**SUMMARY**—Makes appropriations to the Communication and Computing Unit of the Division of Enterprise Information Technology Services of the Department of Administration for the replacement of computer hardware and associated software, the replacement of components of a security firewall and security upgrades to mountaintop microwave sites. (BDR S-1128)

AN ACT making appropriations to the Communication and Computing Unit of the Division of Enterprise Information Technology Services of the Department of Administration for the replacement of computer hardware and associated software, the replacement of components of a security firewall and security upgrades to mountaintop microwave sites; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1     **Section 1.** There is hereby appropriated from the State General  
2 Fund to the Communication and Computing Unit of the Division of  
3 Enterprise Information Technology Services of the Department of  
4 Administration the sum of \$101,678 for the Computer Facility



1 budget account for the replacement of computer hardware and  
2 associated software.

3 **Sec. 2.** There is hereby appropriated from the State General  
4 Fund to the Communication and Computing Unit of the Division of  
5 Enterprise Information Technology Services of the Department of  
6 Administration the sum of \$33,042 for the Data Communications  
7 and Network Engineering budget account for the replacement of  
8 computer hardware and associated software.

9 **Sec. 3.** There is hereby appropriated from the State General  
10 Fund to the Communication and Computing Unit of the Division of  
11 Enterprise Information Technology Services of the Department of  
12 Administration the sum of \$1,280,928 for the Data Communications  
13 and Network Engineering budget account for the replacement of  
14 components of a security firewall.

15 **Sec. 4.** There is hereby appropriated from the State General  
16 Fund to the Communication and Computing Unit of the Division of  
17 Enterprise Information Technology Services of the Department of  
18 Administration the sum of \$26,082 for the Telecommunications  
19 budget account for the replacement of computer hardware and  
20 associated software.

21 **Sec. 5.** There is hereby appropriated from the State General  
22 Fund to the Communication and Computing Unit of the Division of  
23 Enterprise Information Technology Services of the Department of  
24 Administration the sum of \$27,945 for the Network Transport  
25 Services budget account for the replacement of computer hardware  
26 and associated software.

27 **Sec. 6.** There is hereby appropriated from the State General  
28 Fund to the Communication and Computing Unit of the Division of  
29 Enterprise Information Technology Services of the Department of  
30 Administration the sum of \$141,949 for the Network Transport  
31 Services budget account for security upgrades to mountaintop  
32 microwave sites.

33 **Sec. 7.** Any remaining balance of the appropriations made by  
34 sections 1 to 6, inclusive, of this act must not be committed for  
35 expenditure after June 30, 2025, by the entity to which the  
36 appropriation is made or any entity to which money from the  
37 appropriation is granted or otherwise transferred in any manner, and  
38 any portion of the appropriated money remaining must not be spent  
39 for any purpose after September 19, 2025, by either the entity to  
40 which the money was appropriated or the entity to which the money  
41 was subsequently granted or transferred, and must be reverted to the  
42 State General Fund on or before September 19, 2025.



1     **Sec. 8.** This act becomes effective upon passage and approval.
