# ASSEMBLY BILL NO. 511–COMMITTEE ON TRANSPORTATION

# MARCH 28, 2011

### Referred to Committee on Transportation

SUMMARY—Revises certain provisions governing transportation. (BDR 43-1109)

FISCAL NOTE: Effect on Local Government: No. Effect on the State: Yes.

EXPLANATION - Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to transportation; providing certain privileges to the owner or long-term lessee of a qualified plug-in electric drive vehicle; authorizing in this State the operation of, and a driver's license endorsement for operators of, autonomous vehicles; providing a penalty; and providing other matters properly relating thereto.

#### Legislative Counsel's Digest:

Existing law authorizes the Department of Transportation to adopt regulations 1 2 3 to allow certified low emission and energy-efficient vehicles to be operated in a lane on a highway under its jurisdiction designated for the preferential use or 45678 exclusive use of high-occupancy vehicles. (NRS 484A.463) Section 6 of this bill defines the term "qualified plug-in electric drive vehicle" in a manner substantially similar to the definition used by the Internal Revenue Service for the purpose of the tax credit made available for the initial acquisition of such vehicles. Section 7 of this bill requires that, with limited exceptions, each local authority shall establish a 9 parking program for qualified plug-in electric drive vehicles. Section 7 provides 10 that the owner or long-term lessee of such a vehicle may: (1) apply to the local 11 authority for a distinctive decal, label or other identifier that distinguishes the 12 vehicle from other vehicles; and (2) while displaying the distinctive identifier, park 13 the vehicle without the payment of a parking fee at certain times in certain public 14 parking lots, parking areas and metered parking zones. Section 10 of this bill 15 authorizes the use of a qualified plug-in electric drive vehicle in high-occupancy 16 vehicle lanes irrespective of the occupancy of the vehicle, if the Department of 17 Transportation has adopted the necessary regulations. Section 13 of this bill causes the provisions of this bill that pertain to qualified plug-in electric drive vehicles to 18 expire by limitation ("sunset") as of January 1, 2018. 19

Section 8 of this bill requires the Department of Motor Vehicles to adopt
 regulations authorizing the operation of autonomous vehicles on highways within
 the State of Nevada. Section 8 defines an "autonomous vehicle" to mean a motor
 vehicle that uses artificial intelligence, sensors and global positioning system





24 25 coordinates to drive itself without the active intervention of a human operator.

Section 2 of this bill requires the Department, by regulation, to establish a driver's

26 27 license endorsement for the operation of an autonomous vehicle on the highways of this State.

# THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY. DO ENACT AS FOLLOWS:

**Section 1.** (Deleted by amendment.) 1

Sec. 2. Chapter 483 of NRS is hereby amended by adding 2 3 thereto a new section to read as follows:

4 The Department shall by regulation establish a driver's 1. license endorsement for the operation of an autonomous vehicle 5 on the highways of this State. The driver's license endorsement 6 described in this subsection must, in its restrictions or lack thereof, 7 recognize the fact that a person is not required to actively drive an 8 9 autonomous vehicle.

2. As used in this section, "autonomous vehicle" has the 10 meaning ascribed to it in section 8 of this act. 11

Sec. 3. NRS 483.230 is hereby amended to read as follows:

483.230 1. Except persons expressly exempted in NRS 13 483.010 to 483.630, inclusive, and section 2 of this act, a person 14 shall not drive any motor vehicle upon a highway in this State 15 unless such person has a valid license as a driver under the 16 provisions of NRS 483.010 to 483.630, inclusive, and section 2 of 17 *this act* for the type or class of vehicle being driven. 18

2. Any person licensed as a driver under the provisions of NRS 19 483.010 to 483.630, inclusive, and section 2 of this act may 20 exercise the privilege thereby granted upon all streets and highways 21 of this State and shall not be required to obtain any other license to 22 exercise such privilege by any county, municipal or local board or 23 body having authority to adopt local police regulations. 24

3. Except persons expressly exempted in NRS 483.010 to 25 483.630, inclusive, and section 2 of this act, a person shall not steer 26 or exercise any degree of physical control of a vehicle being towed 27 by a motor vehicle upon a highway unless such person has a license 28 29 to drive the type or class of vehicle being towed.

30 4. A person shall not receive a driver's license until the person surrenders to the Department all valid licenses in his or her 31 32 possession issued to the person by this or any other jurisdiction. 33 Surrendered licenses issued by another jurisdiction shall be returned by the Department to such jurisdiction. A person shall not have 34 35 more than one valid driver's license.

1 Sec. 4. NRS 483.620 is hereby amended to read as follows:

483.620 It is a misdemeanor for any person to violate any of
the provisions of NRS 483.010 to 483.630, inclusive, *and section 2 of this act* unless such violation is, by NRS 483.010 to 483.630,
inclusive, *and section 2 of this act* or other law of this State,
declared to be a felony.

7 **Sec. 5.** Chapter 484A of NRS is hereby amended by adding 8 thereto the provisions set forth as sections 6, 7 and 8 of this act.

9 Sec. 6. "Qualified plug-in electric drive vehicle" means a 10 motor vehicle that:

1. Is equipped with four wheels;

2. Is made by a manufacturer;

13 3. Is manufactured primarily for use on public streets, roads 14 and highways;

15 4. Has a manufacturer's gross vehicle weight rating of less 16 than 8,500 pounds;

17 5. Can maintain a maximum rate of speed of at least 70 miles 18 per hour; and

19 6. Is propelled to a significant extent by an electric motor 20 which draws electricity from a battery that:

(a) Has a capacity of not less than 4 kilowatt hours; and

22 (b) Can be recharged from a source of electricity that is 23 external to the vehicle.

24 Sec. 7. 1. Except as otherwise provided in subsection 6, a 25 local authority that has within its jurisdiction a public metered 26 parking zone, parking lot or parking area for the use of which a 27 fee is charged, shall by ordinance establish a parking program for 28 qualified plug-in electric drive vehicles pursuant to this section.

29 2. Upon the application of the owner or long-term lessee of a 30 qualified plug-in electric drive vehicle, the local authority or its 31 designee shall issue to the owner or long-term lessee a distinctive 32 decal, label or other identifier that clearly distinguishes the 33 qualified plug-in electric drive vehicle from other vehicles.

34 3. The board of county commissioners or the governing body 35 of the city may charge a fee for the distinctive decal, label or other 36 identifier issued pursuant to subsection 2 in an amount not to 37 exceed \$10 annually.

4. Except as otherwise provided in subsection 5, the driver of
a qualified plug-in electric drive vehicle displaying the distinctive
decal, label or other identifier issued pursuant to subsection 2
may:

42 (a) Stop, stand or park the qualified plug-in electric drive 43 vehicle in any public metered parking zone within the jurisdiction 44 of the local authority without depositing a coin of United States 45 currency of the designated denomination, or making payment





using another acceptable method of payment, in the applicable 1 2 parking meter; and

(b) Stop, stand or park the qualified plug-in electric drive 3 vehicle in any public parking lot or parking area within the 4 jurisdiction of the local authority without paying a parking fee. 5

In addition to the requirements set forth in this section, the 6 5. 7 authority may by ordinance establish such other local requirements as it determines necessary for the parking program 8 for qualified plug-in electric drive vehicles, including, without 9 10 *limitation:* 

(a) Requiring that the driver of a qualified plug-in electric 11 drive vehicle comply with any limits on the amount of time for 12 13 stopping, standing or parking imposed on other drivers; and

14 (b) Requiring that the driver of a qualified plug-in electric 15 drive vehicle pay applicable parking fees during certain special events or activities designated by the local authority, regardless of 16 whether the vehicle displays a distinctive decal, label or other 17 18 identifier issued pursuant to subsection 2.

6. The provisions of this section do not apply to any public 19 metered parking zone, parking lot or parking area of an airport. 20

21 Sec. 8. 1. The Department shall adopt regulations 22 authorizing the operation of autonomous vehicles on highways 23 within the State of Nevada.

24 2. The regulations required to be adopted by subsection 1 25 must:

(a) Set forth requirements that an autonomous vehicle must 26 27 meet before it may be operated on a highway within this State;

(b) Set forth requirements for the insurance that is required to 28 29 test or operate an autonomous vehicle on a highway within this 30 State:

31 (c) Establish minimum safety standards for autonomous 32 vehicles and their operation;

(d) Provide for the testing of autonomous vehicles;

(e) Restrict the testing of autonomous vehicles to specified 34 35 geographic areas; and

36 (f) Set forth such other requirements as the Department 37 determines to be necessary. 38

As used in this section: *3*.

39 (a) "Artificial intelligence" means the use of computers and 40 related equipment to enable a machine to duplicate or mimic the 41 behavior of human beings.

42 (b) "Autonomous vehicle" means a motor vehicle that uses artificial intelligence, sensors and global positioning system 43 44 coordinates to drive itself without the active intervention of a 45 human operator.

(c) "Sensors" includes, without limitation, cameras, lasers and 1 2 radar. 3

**Sec. 9.** NRS 484A.010 is hereby amended to read as follows:

4 484A.010 As used in chapters 484A to 484E, inclusive, of 5 NRS, unless the context otherwise requires, the words and terms 6 defined in NRS 484A.015 to 484A.320, inclusive, and section 6 of 7 *this act* have the meanings ascribed to them in those sections.

Sec. 10. NRS 484A.463 is hereby amended to read as follows:

9 484A.463 1. To the extent not inconsistent with federal law, the Department of Transportation may, in consultation with the 10 Highway Administration 11 Federal and the United States 12 Environmental Protection Agency, adopt regulations establishing a 13 program to allow a vehicle that is certified by the Administrator of 14 the United States Environmental Protection Agency as a low 15 emission and energy-efficient vehicle to be operated in a lane that is 16 designated for the use of high-occupancy vehicles pursuant to 17 NRS 484A.460.

18 2. As used in this section, "low emission and energy-efficient vehicle" has the meaning ascribed to it in 23 U.S.C. § 166(f)(3). The 19 20 term includes, without limitation, a qualified plug-in electric drive 21 vehicle.

Sec. 11. NRS 484B.523 is hereby amended to read as follows:

23 484B.523 1. [When] Except as otherwise provided in section 7 of this act, when parking meters are erected by any local authority 24 25 pursuant to an adopted ordinance giving notice thereof, it is unlawful for any person to stop, stand or park a vehicle in any 26 27 metered parking zone for a period of time longer than designated by 28 such parking meters upon a deposit of a coin of United States 29 currency of the designated denomination.

30 2. Every vehicle shall be parked wholly within the metered 31 parking space for which the meter shows parking privilege has been 32 granted.

33 3. It is unlawful for any unauthorized person to remove, deface, 34 tamper with, open, willfully break, destroy or damage any parking meter, or willfully to manipulate any parking meter in such a 35 manner that the indicator will fail to show the correct amount of 36 37 unexpired time before a violation occurs.

The Department of Motor Vehicles shall adopt 38 Sec. 12. 1. 39 the regulations necessary to implement the provisions of sections 2 40 and 8 of this act on or before March 1, 2012.

41 Each local authority to which the provisions of section 7 of 2. 42 this act apply shall adopt the ordinances necessary to implement the provisions of sections 6, 7, 9, 10 and 11 of this act on or before 43 44 January 1, 2012.





3. As used in this section, "local authority" has the meaning 1 ascribed to it in NRS 484A.115. 2

Sec. 13. 1. This section and section 12 of this act become 3 effective upon passage and approval. 2. Sections 5, 6, 7, 9, 10 and 11 of this act become effective on 4

5 January 1, 2012. 6

3. Sections 2, 3, 4 and 8 of this act become effective on 7 March 1, 2012. 8

The following provisions expire by limitation on January 1, 4. 9 10 2018:

(a) Sections 5, 6 and 7 of this act; 11

(b) The amendatory provisions of sections 9, 10 and 11 of this 12 13 act; and

(c) Subsections 2 and 3 of section 12 of this act. 14
