---

ASSEMBLY JOINT RESOLUTION—Proposing to amend the Nevada Constitution to provide a citizens’ commission to establish the compensation of certain elected officers.

**Legislative Counsel’s Digest:**

1 Existing law establishes the salaries of the various constitutional officers of this  
2 State, members of the Senate and Assembly, justices of the Supreme Court, judges  
3 of the Court of Appeals and district judges. (NRS 2.050, 2A.080, 3.030, 218A.630,  
4 218A.635, 223.050, 224.050, 225.050, 226.090, 227.060, 228.070) Existing law also  
5 creates an advisory Commission to Review the Compensation of Constitutional  
6 Officers, Legislators, Supreme Court Justices, Judges of the Court of Appeals,  
7 District Judges and Elected County Officers which is empowered to review and  
8 make recommendations to the Legislature concerning the salary of the various  
9 offices within its purview. (NRS 281.157-281.1575) This resolution proposes to  
10 revise the Nevada Constitution to reserve to a Citizens’ Commission on  
11 Compensation for Certain Elected Officers the power to establish salaries and  
12 benefits for various offices within this State, including members of the Senate and  
13 Assembly, the Governor, Lieutenant Governor, Secretary of State, State Treasurer,  
14 State Controller, Attorney General, justices of the Supreme Court, judges of the  
15 Court of Appeals and judges of the District Court, and to establish salaries for  
16 various other offices within this State, including county commissioners, district  
17 attorneys, sheriffs, county clerks, county assessors, county recorders, county  
18 treasurers and public administrators. This resolution also authorizes the Commission  
19 to: (1) fix the compensation of the members of the Legislature for each calendar day  
20 of service during any regular or special session of the Legislature; and (2) provide  
21 compensation to members of the Legislature for the performance of duties as a  
22 member of the Legislature outside of a regular or special session.

1 WHEREAS, The Nevada Legislature established the Commission  
2 to Review the Compensation of Constitutional Officers, Legislators,  
3 Supreme Court Justices, Judges of the Court of Appeals, District  
4 Judges and Elected County Officers in 1993; and

5 WHEREAS, While the Commission is empowered by law to  
6 review compensation, hold public hearings and make  
7 recommendations for revisions to compensation for the various  
8 offices within its purview, it serves a purely advisory function and  
9 its recommendations have no effect unless enacted by the  
10 Legislature; and

11 WHEREAS, A constitutional amendment is required to fully  
12 empower such a commission to engage in a comprehensive review  
13 of the compensation given to various officers within this State and  
14 put into effect its findings; now, therefore, be it

15 RESOLVED BY THE ASSEMBLY AND SENATE OF THE STATE OF  
16 NEVADA, JOINTLY, That a new section, designated Section 33A, be  
17 added to Article 4 of the Nevada Constitution to read as follows:

18 *Sec. 33A. 1. The Legislature shall provide by law for*  
19 *a Citizens' Commission on Compensation for Certain*  
20 *Elected Officers.*

21 *2. The Commission must consist of seven members*  
22 *appointed by the Governor who have diverse personal and*  
23 *professional interests and reside in various geographical*  
24 *areas of this State of which:*

25 *(a) One member has expertise in public compensation*  
26 *and is recommended by the Public Employees' Retirement*  
27 *Board or its successor organization;*

28 *(b) One member represents a nonprofit public interest*  
29 *organization;*

30 *(c) One member represents the general public;*

31 *(d) One member has experience with the operation of*  
32 *independent businesses in this State and is recommended by*  
33 *an organization which represents the interests of*  
34 *independent businesses in this State;*

35 *(e) One member has experience with the operation of a*  
36 *retailer in this State and is recommended by an organization*  
37 *which represents the interests of retailers in this State; and*

38 *(f) Two members have experience as officers or*  
39 *members of a labor organization in this State and are*  
40 *recommended by a labor organization in this State.*

41 *3. Each member of the Commission must be a resident*  
42 *of this State and must not be a state officer, public employee*  
43 *or lobbyist, or a parent, spouse, sibling, child or dependent*  
44 *relative of a state officer, public employee or lobbyist.*



1           4. *Except as otherwise provided in this subsection, the*  
2 *term of office of each member of the Commission is 4 years.*  
3 *The Governor shall appoint three of the members first*  
4 *appointed by him or her for initial terms of 2 years. If a*  
5 *vacancy occurs, the Governor shall fill the vacancy for the*  
6 *unexpired term in the same manner as the original*  
7 *appointment, within 30 days after the vacancy occurs. A*  
8 *member of the Commission may not serve more than two*  
9 *terms.*

10           5. *The Governor may remove a member of the*  
11 *Commission only for cause of incapacity, incompetence,*  
12 *neglect of duty, malfeasance in office or failure to meet a*  
13 *qualification set forth in subsection 3.*

14           6. *The Commission shall elect a Chair from among its*  
15 *members. Except as otherwise provided in this section, the*  
16 *Commission shall adopt rules of procedure for the conduct*  
17 *of its hearings and any other procedural rules it deems*  
18 *necessary to carry out its duties. The affirmative vote of a*  
19 *majority of all the members appointed to the Commission is*  
20 *required to take action.*

21           7. *Members of the Commission are entitled to:*

22           (a) *The compensation provided by law for members of*  
23 *the Commission on Judicial Discipline who are not judicial*  
24 *officers; and*

25           (b) *The per diem allowance and travel expenses*  
26 *provided by law for state officers and employees generally.*

27           8. *The Commission shall:*

28           (a) *Study the relationship of salaries and benefits to the*  
29 *duties of the members of the Legislature, the Governor,*  
30 *Lieutenant Governor, Secretary of State, State Treasurer,*  
31 *State Controller, Attorney General, justices of the Supreme*  
32 *Court, judges of the Court of Appeals and judges of the*  
33 *District Courts;*

34           (b) *Study the relationship of salaries to the duties of*  
35 *county commissioners, district attorneys, sheriffs, county*  
36 *clerks, county assessors, county recorders, county treasurers*  
37 *and public administrators;*

38           (c) *Compare the salaries and benefits of the elected*  
39 *officers set forth in paragraph (a) to the salaries and*  
40 *benefits of persons who are employed by a public or private*  
41 *employer and who have similar qualifications as those*  
42 *elected officers and compare the salaries of the elected*  
43 *officers set forth in paragraph (b) to the salaries of persons*  
44 *who are employed by a public or private employer and who*  
45 *have similar qualifications as those elected officers;*



1           (d) Fix the salaries and benefits of the elected officers  
2 set forth in paragraph (a) and fix the salaries of the elected  
3 officers set forth in paragraph (b); and

4           (e) Carry out any duties provided by the Legislature.

5           9. The Commission may increase, but not diminish, the  
6 salary and benefits of an elected officer set forth in  
7 paragraph (a) of subsection 8 during his or her term of  
8 office. Except for the initial schedule of salaries and  
9 benefits for elected officers filed pursuant to subsection 10,  
10 the Commission may not increase or decrease the salary of  
11 any elected officer by more than 15 percent of the salary of  
12 that elected officer provided in the immediately preceding  
13 schedule of salaries for elected officers. The Commission  
14 may exercise any powers conferred by the Legislature.

15           10. The Commission shall file its initial schedule of  
16 salaries and benefits for elected officers with the Secretary  
17 of State not later than January 1, 2019, and shall file a  
18 schedule of salaries and benefits not later than January 1 of  
19 each odd-numbered year thereafter. Each schedule of  
20 salaries and benefits is effective:

21           (a) For members of the Legislature, for the period from  
22 the first Monday of February immediately following the  
23 January 1 that the schedule is due through the day before  
24 the first Monday of February of the next odd-numbered  
25 year; and

26           (b) For all other elected officers set forth in paragraph  
27 (a) or (b) of subsection 8, for the period from July 1  
28 immediately following the January 1 that the schedule is  
29 due through June 30 of the next odd-numbered year.

30           The Legislature shall provide by law for setting apart from  
31 each year's revenues a sufficient amount of money to pay  
32 such salaries and benefits.

33           11. Before the Commission may file a schedule of  
34 salaries and benefits with the Secretary of State, the  
35 Commission shall hold at least four meetings to receive  
36 public testimony on the schedule. At the last public hearing  
37 before the schedule is filed with the Secretary of State, the  
38 Commission shall adopt the schedule as originally proposed  
39 or as amended. All meetings of the Commission are subject  
40 to the provisions of any open meeting laws made applicable  
41 generally to other public bodies.

42           12. The Legislative Counsel Bureau shall include in  
43 the Nevada Revised Statutes a copy of the most recent  
44 schedule of salaries and benefits established by the  
45 Commission and filed with the Secretary of State.



1 And be it further

2 RESOLVED, That Section 32 of Article 4 of the Nevada  
3 Constitution be amended to read as follows:

4 Sec. 32. The Legislature shall have power to increase,  
5 diminish, consolidate or abolish the following county  
6 officers: County Clerks, County Recorders, Auditors,  
7 Sheriffs, District Attorneys and Public Administrators. The  
8 Legislature shall provide for their election by the people, and  
9 fix by law their duties and , *unless fixed by the Citizens'  
10 Commission on Compensation for Certain Elected Officers  
11 pursuant to Section 33A of this Article, fix their*  
12 compensation. County Clerks shall be ex-officio Clerks of the  
13 Courts of Record and of the Boards of County  
14 Commissioners in and for their respective counties.

15 And be it further

16 RESOLVED, That Section 33 of Article 4 of the Nevada  
17 Constitution be amended to read as follows:

18 Sec. 33. The members of the Legislature shall receive  
19 for their services a compensation to be fixed by ~~law~~ *the*  
20 *Citizens' Commission on Compensation for Certain Elected*  
21 *Officers pursuant to Section 33A of this Article* and paid out  
22 of the public treasury, for ~~not to exceed 60 days~~ *each*  
23 *calendar day of service* during any regular session of the  
24 Legislature and ~~not to exceed 20 days~~ during any special  
25 session . ~~but no increase of such compensation shall take~~  
26 ~~effect during the term for which the members of either house~~  
27 ~~shall have been elected; Provided, that an~~ *The Citizens'*  
28 *Commission on Compensation for Certain Elected Officers*  
29 *may provide for the compensation of members of the*  
30 *Legislature for the performance of duties as a member of*  
31 *the Legislature outside of a regular or special session. An*  
32 appropriation may be made for the payment of such actual  
33 expenses as members of the Legislature may incur for  
34 postage, express charges, newspapers and stationery not  
35 exceeding the sum of Sixty dollars for any general or special  
36 session to each member; and Furthermore Provided, that the  
37 Speaker of the Assembly, and Lieutenant Governor, as  
38 President of the Senate, shall each, during the time of their  
39 actual attendance as such presiding officers receive an  
40 additional allowance of two dollars per diem.

41 And be it further

42 RESOLVED, That Section 15 of Article 6 of the Nevada  
43 Constitution be amended to read as follows:

44 Sec. 15. The justices of the Supreme Court, the judges  
45 of the court of appeals and the district judges are each entitled



1 to receive for their services a compensation to be fixed by  
2 ~~law~~ *the Citizens' Commission on Compensation for*  
3 *Certain Elected Officers pursuant to Section 33A of Article*  
4 *4* and paid in the manner provided by law . ~~[which must not~~  
5 ~~be increased or diminished during the term for which they~~  
6 ~~have been elected, unless]~~ *If* a vacancy occurs, ~~[in which~~  
7 ~~ease]~~ the successor of the former incumbent is entitled to  
8 receive ~~[only such salary as may be]~~ *the salary and benefits*  
9 *provided for that office* by ~~law~~ *the Citizens' Commission*  
10 *on Compensation for Certain Elected Officers pursuant to*  
11 *Section 33A of Article 4* at the time of his *or her* election or  
12 appointment. ~~[A provision must be made by law for setting~~  
13 ~~apart from each year's revenue a sufficient amount of money~~  
14 ~~to pay such compensation.]~~

15 And be it further

16 RESOLVED, That Section 9 of Article 15 of the Nevada  
17 Constitution be repealed.

TEXT OF REPEALED SECTION

---

**Sec: 9. Increase or decrease of compensation of officers whose compensation fixed by constitution.** The Legislature may, at any time, provide by law for increasing or diminishing the salaries or compensation of any of the Officers, whose salaries or compensation is fixed in this Constitution; Provided, no such change of Salary or compensation shall apply to any Officer during the term for which he may have been elected.
