
SENATE BILL NO. 137—COMMITTEE ON GOVERNMENT AFFAIRS

SUMMARY—Revises provisions relating to the construction of bus turnouts at certain locations. (BDR 22-917)

AN ACT relating to local governmental planning; providing for the construction of additional bus turnouts at certain locations in certain counties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, the regional transportation commission in a county whose
2 population is 400,000 or more (currently Clark County) was required to designate,
3 on or before December 31, 2009, 10 bus stops at which a bus turnout—an area for
4 loading and unloading passengers outside of the lanes of traffic—must be
5 constructed by December 31, 2012. Such a bus turnout must be constructed on land
6 owned by the State or a local government. The commission must fund the
7 construction of the bus turnout. (NRS 278.02587)
8 **Section 1** of this bill requires the regional transportation commission in a
9 county whose population is 400,000 or more to designate, on or before
10 December 31, 2011, 15 additional bus stops at which a bus turnout must be
11 constructed by December 31, 2014. Such a bus turnout must be constructed on land
12 owned by the State or a local government. The commission must fund the
13 construction of the bus turnout. **Section 2** of this bill requires the regional
14 transportation commission in a county whose population is 400,000 or more to
15 report to the Legislature on the designation and construction of bus turnouts before
16 the 77th Session of the Legislature convenes.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 278.02587 is hereby amended to read as
2 follows:

3 278.02587 1. Not later than December 31, 2009:

4 (a) Except as otherwise provided in subsection ~~5~~ 7, the
5 commission shall designate 10 locations in the county that are
6 owned by the State or by local governments and at which a bus
7 turnout must be constructed pursuant to this section; and

8 (b) For each location designated pursuant to paragraph (a), the
9 commission and the State or the local government that owns the
10 location shall execute an interlocal or cooperative agreement that
11 authorizes the construction of a bus turnout at the location.

12 2. For each location designated pursuant to subsection 1, the
13 commission and the State or the local government that owns the
14 location shall ensure that a bus turnout is constructed not later than
15 December 31, 2012.

16 3. *Not later than December 31, 2011:*

17 (a) *Except as otherwise provided in subsection 7, the*
18 *commission shall designate 15 locations in the county that are*
19 *owned by the State or by local governments and at which a bus*
20 *turnout must be constructed pursuant to this section; and*

21 (b) *For each location designated pursuant to paragraph (a),*
22 *the commission and the State or the local government that owns*
23 *the location shall execute an interlocal or cooperative agreement*
24 *that authorizes the construction of a bus turnout at the location.*

25 4. *For each location designated pursuant to subsection 3, the*
26 *commission and the State or the local government that owns the*
27 *location shall ensure that a bus turnout is constructed not later*
28 *than December 31, 2014.*

29 5. The commission shall fund the construction of a bus turnout
30 built pursuant to this section.

31 ~~4~~ 6. When determining the locations to be designated
32 pursuant to subsection 1 ~~5~~ or 3, the commission shall consider,
33 without limitation:

34 (a) The amount of traffic congestion at the location during hours
35 of peak traffic;

36 (b) The extent of improvements to the location that would need
37 to be completed before the bus turnout could be constructed;

38 (c) The proximity of the location to an intersection;

39 (d) The frequency with which buses receive and discharge
40 passengers at the location;

41 (e) The number of bus passengers regularly using the bus stop at
42 the location;



1 (f) The general need for a bus turnout at the location; and

2 (g) Any obstacle that may prevent the completion of the
3 construction of a bus turnout by the date set forth in subsection 2 ~~§~~
4 *or 4, as applicable.*

5 ~~§~~ 7. The commission shall not designate more than three
6 locations pursuant to subsection 1 *or 3* that are owned by the State
7 or by the same local government.

8 ~~§~~ 8. As used in this section:

9 (a) "Bus" has the meaning ascribed to it in NRS 484A.030.

10 (b) "Bus turnout" means a fixed area that is:

11 (1) Adjacent or appurtenant to, or within reasonable
12 proximity of, a public highway; and

13 (2) To be occupied exclusively by buses in receiving or
14 discharging passengers.

15 (c) "Commission" means the regional transportation
16 commission created and organized pursuant to chapter 277A of NRS
17 in a county whose population is 400,000 or more.

18 (d) "Local government" means any political subdivision of the
19 State, including, without limitation, any county, city, town, board,
20 airport authority, fire protection district, irrigation district, school
21 district, hospital district or other special district which performs a
22 governmental function and which is located within the jurisdiction
23 of the commission.

24 (e) "Location" means a parcel of real property which:

25 (1) Is owned by the State or by a local government;

26 (2) Is adjacent to a public highway; and

27 (3) Contains a bench, shelter or transit stop for passengers of
28 public transportation.

29 (f) "Public highway" means any street, road, alley, thoroughfare,
30 way or place of any kind used by the public or open to the use of the
31 public as a matter of right for the purpose of vehicular traffic.

32 **Sec. 2.** 1. On or before February 1, 2013, the commission
33 shall submit a report on the designation and construction by the
34 commission of bus turnouts pursuant to NRS 278.02587, as
35 amended by section 1 of this act, and any recommendations for
36 legislation to the Director of the Legislative Counsel Bureau for
37 transmission to the 77th Session of the Nevada Legislature.

38 2. As used in this section:

39 (a) "Bus" has the meaning ascribed to it in NRS 484A.030.

40 (b) "Bus turnout" means a fixed area that is:

41 (1) Adjacent or appurtenant to, or within reasonable
42 proximity of, a public highway; and

43 (2) To be occupied exclusively by buses in receiving or
44 discharging passengers.



1 (c) "Commission" means the regional transportation
2 commission created and organized pursuant to chapter 277A of NRS
3 in a county whose population is 400,000 or more.

4 (d) "Public highway" means any street, road, alley,
5 thoroughfare, way or place of any kind used by the public or open to
6 the use of the public as a matter of right for the purpose of vehicular
7 traffic.

8 **Sec. 3.** The provisions of NRS 354.599 do not apply to any
9 additional expenses of a local government that are related to the
10 provisions of this act.

11 **Sec. 4.** This act becomes effective upon passage and approval.
