AN ACT relating to education; requiring a public school with more than 500 pupils to list on its Internet website certain information relating to the learning materials and activities that were used for pupil instruction during the immediately preceding school year; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 This bill requires a public school with more than 500 pupils to list on its  
2 Internet website certain information relating to the learning materials and activities  
3 that were used for pupil instruction at the public school during the immediately  
4 preceding school year. This bill clarifies that this requirement must not be  
5 construed to require the digital reproduction of such materials, nor the separate  
6 reporting of individual components of materials produced as a single volume.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 389 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       1. *Each public school with more than 500 pupils shall*  
4 *prominently list on a publicly accessible portion of its Internet*  
5 *website:*

6       (a) *The learning materials and activities that were used for*  
7 *pupil instruction at the public school during the immediately*  
8 *preceding school year, organized at a minimum by subject area*  
9 *and grade; and*

10       (b) *Any procedures for the documentation, review or approval*  
11 *of the learning materials used for pupil instruction at the public*  
12 *school.*

13       2. *A public school is required to list only the information*  
14 *necessary to identify the learning materials and activities used for*  
15 *instruction, including, without limitation, the title and the author,*  
16 *organization or Internet website associated with each material and*  
17 *activity. Nothing in this section shall be construed to require the*  
18 *digital reproduction of such materials, nor the separate reporting*  
19 *of individual components of materials produced as a single*  
20 *volume.*

21       3. *As used in this section:*

22       (a) *“Activities” includes, without limitation, presentations,*  
23 *assemblies, lectures or other activities or events facilitated by*  
24 *the staff of the public school, but does not include pupil*  
25 *presentations.*

26       (b) *“Learning materials” includes, without limitation, all*  
27 *textbooks, reading materials, videos, digital materials, Internet*  
28 *websites and other online applications.*

29       (c) *“Used for pupil instruction” means the use of learning*  
30 *materials and activities that:*

31       (1) *Are assigned, distributed or otherwise presented to*  
32 *pupils in any course for which pupils receive academic credit or in*  
33 *any capacity in which attendance of a pupil is required by the*  
34 *public school; and*

35       (2) *Require pupils to select one or more options, if the*  
36 *available selection is restricted to specific options.*

37       **Sec. 2.** Each public school which is required to list  
38 information on its Internet website pursuant to section 1 of this act  
39 shall initially list such information relating to the 2021-2022 school  
40 year not later than July 1, 2022.



1     **Sec. 3.** The provisions of NRS 354.599 do not apply to any  
2 additional expenses of a local government that are related to the  
3 provisions of this act.

4     **Sec. 4.** This act becomes effective on July 1, 2021.
