SUMMARY—Revises provisions relating to employment practices.

AN ACT relating to employment; requiring the Nevada Equal Rights Commission to notify certain persons that the Commission shall, upon request, provide a right-to-sue notice; requiring the Commission to issue a right-to-sue notice in certain circumstances; revising the statute of limitations for bringing a civil action in district court for an unlawful employment practice; authorizing a court to award certain relief to an employee injured by certain unlawful employment practices under certain circumstances; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides that a person may file a complaint which alleges
2 unlawful discriminatory practices in employment with the Nevada Equal Rights
3 Commission not later than 300 days after the date of the occurrence of the alleged
4 unlawful discriminatory practice in employment. (NRS 233.160) **Section 9** of this
5 bill requires the Commission to notify in writing the person who filed the complaint
6 that the person may request the Commission to issue a right-to-sue notice. **Section**
7 **2** of this bill requires the Commission to issue, upon request, a right-to-sue notice if
8 at least 180 days have passed after the complaint was filed. In addition, **section 7** of
9 this bill requires the Commission to issue a right-to-sue notice if, after a complaint
10 is filed with the Commission, the Commission does not conclude that an unfair
11 employment practice has occurred. The right-to-sue notice must inform the person
12 that the person may bring a civil action in district court not later than 90 days after



13 the date of receipt of the right-to-sue notice against the person named in the
14 complaint.

15 Under existing law, if, after a complaint alleging an unfair employment practice
16 is filed with the Commission, the Commission does not conclude that an unfair
17 employment practice has occurred, the person alleging such a practice has occurred
18 is authorized to bring a civil action in the district court for an order granting or
19 restoring to that person the rights to which the person is entitled. (NRS 613.420)
20 Existing law prohibits a person from bringing such a civil action unless it is brought
21 not more than 180 days after the act constituting the unfair employment practice
22 occurred and provides that the 180-day period is tolled during the pendency of the
23 complaint before the Commission. (NRS 613.430) **Sections 7 and 8** of this bill
24 prohibit a person from bringing a civil action in district court unless the civil action
25 is brought not later than 180 days after the act constituting the unfair employment
26 practice occurred, including, the period for which this 180-day period is tolled
27 during the pendency of the complaint before the Commission, or not later than 90
28 days after a right-to-sue notice is received, whichever is later.

29 Title VII of the Civil Rights Act of 1964 sets forth various employment
30 practices that are unlawful if such practices are based on an individual's: (1) race;
31 (2) color; (3) religion; (4) sex; or (5) national origin. (42 U.S.C. §§ 2000e-2, 2000e-
32 3) Title VII of the Civil Rights Act of 1964 provides various forms of legal and
33 equitable relief to individuals against whom such unlawful employment practices
34 were committed. (42 U.S.C. § 2000e-5) Existing Nevada law provides that a person
35 who has suffered an injury as a result of certain unlawful employment practices
36 may file a complaint with the Nevada Equal Rights Commission if the complaint is
37 based on discrimination because of: (1) race; (2) color; (3) sex; (4) sexual
38 orientation; (5) gender identity or expression; (6) age; (7) disability; (8) religion; or
39 (9) national origin. (NRS 613.405) Existing Nevada law also provides that if the
40 Commission does not conclude that an unfair employment practice has occurred,
41 any person alleging such a practice may bring an action in district court.
42 (NRS 613.420)

43 **Section 3** of this bill provides that if a court finds that an employee has been
44 injured as the result of certain unlawful employment practices, the court may award
45 to the employee the same legal or equitable relief that may be awarded to a person
46 pursuant to Title VII of the Civil Rights Act of 1964 if the employee is protected by
47 Title VII of the Civil Rights Act of 1964 or certain provisions of existing law.
48 **Sections 4-6** of this bill make conforming changes.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 613 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *If a person files a complaint pursuant to paragraph*
4 *(b) of subsection 1 of NRS 233.160 which alleges an unlawful*
5 *discriminatory practice in employment, the Commission shall*
6 *issue, upon request from the person, a right-to-sue notice if at*
7 *least 180 days have passed after the complaint was filed pursuant*
8 *to NRS 233.160. The right-to-sue notice must indicate that the*
9 *person may, not later than 90 days after the date of receipt of*
10 *the right-to-sue notice, bring a civil action in district court against*
11 *the person named in the complaint.*



1 **Sec. 3.** *If a court finds that an employee has been injured by*
2 *an unlawful employment practice within the scope of this section*
3 *and NRS 613.310 to 613.4383, inclusive, and section 2 of this act,*
4 *the court may award the employee the same legal or equitable*
5 *relief that may be awarded to a person pursuant to Title VII of the*
6 *Civil Rights Act of 1964, 42 U.S.C. §§ 2000e et seq., if the*
7 *employee is protected by Title VII of the Civil Rights Act of 1964,*
8 *42 U.S.C. §§ 2000e et seq., or NRS 613.330.*

9 **Sec. 4.** NRS 613.310 is hereby amended to read as follows:

10 613.310 As used in NRS 613.310 to 613.4383, inclusive, *and*
11 *sections 2 and 3 of this act*, unless the context otherwise requires:

12 1. “Disability” means, with respect to a person:

13 (a) A physical or mental impairment that substantially limits one
14 or more of the major life activities of the person, including, without
15 limitation, the human immunodeficiency virus;

16 (b) A record of such an impairment; or

17 (c) Being regarded as having such an impairment.

18 2. “Employer” means any person who has 15 or more
19 employees for each working day in each of 20 or more calendar
20 weeks in the current or preceding calendar year, but does not
21 include:

22 (a) The United States or any corporation wholly owned by the
23 United States.

24 (b) Any Indian tribe.

25 (c) Any private membership club exempt from taxation pursuant
26 to 26 U.S.C. § 501(c).

27 3. “Employment agency” means any person regularly
28 undertaking with or without compensation to procure employees for
29 an employer or to procure for employees opportunities to work for
30 an employer, but does not include any agency of the United States.

31 4. “Gender identity or expression” means a gender-related
32 identity, appearance, expression or behavior of a person, regardless
33 of the person’s assigned sex at birth.

34 5. “Labor organization” means any organization of any kind, or
35 any agency or employee representation committee or plan, in which
36 employees participate and which exists for the purpose, in whole or
37 in part, of dealing with employers concerning grievances, labor
38 disputes, wages, rates of pay, hours of employment or other
39 conditions of employment.

40 6. “Person” includes the State of Nevada and any of its
41 political subdivisions.

42 7. “Sexual orientation” means having or being perceived as
43 having an orientation for heterosexuality, homosexuality or
44 bisexuality.



1 **Sec. 5.** NRS 613.320 is hereby amended to read as follows:
2 613.320 1. The provisions of NRS 613.310 to 613.4383,
3 inclusive, *and sections 2 and 3 of this act* do not apply to:

4 (a) Any employer with respect to employment outside this state.
5 (b) Any religious corporation, association or society with
6 respect to the employment of individuals of a particular religion to
7 perform work connected with the carrying on of its religious
8 activities.

9 2. The provisions of NRS 613.310 to 613.4383, inclusive, *and*
10 *sections 2 and 3 of this act* concerning unlawful employment
11 practices related to sexual orientation and gender identity or
12 expression do not apply to an organization that is exempt from
13 taxation pursuant to 26 U.S.C. § 501(c)(3).

14 **Sec. 6.** NRS 613.390 is hereby amended to read as follows:
15 613.390 Nothing contained in NRS 613.310 to 613.4383,
16 inclusive, *and sections 2 and 3 of this act* applies to any business or
17 enterprise on or near an Indian reservation with respect to any
18 publicly announced employment practice of such business or
19 enterprise under which a preferential treatment is given to any
20 individual because the individual is an Indian living on or near a
21 reservation.

22 **Sec. 7.** NRS 613.420 is hereby amended to read as follows:
23 613.420 1. If the Nevada Equal Rights Commission does not
24 conclude that an unfair employment practice within the scope of
25 NRS 613.310 to 613.4383, inclusive, *and sections 2 and 3 of this*
26 *act* has occurred, ~~any~~ *the Commission shall issue a right-to-sue*
27 *notice. The right-to-sue notice must indicate that the person may,*
28 *not later than 90 days after the date of receipt of the right-to-sue*
29 *notice, bring a civil action in district court against the person*
30 *named in the complaint.*

31 2. *If the Nevada Equal Rights Commission has issued a*
32 *right-to-sue notice pursuant to this section or section 2 of this act,*
33 *the person alleging such a practice has occurred may ~~apply to~~*
34 *bring a civil action in the district court not later than 90 days after*
35 *the date of receipt of the right-to-sue notice for any appropriate*
36 *relief, including, without limitation, an order granting or restoring*
37 *to that person the rights to which the person is entitled under those*
38 *sections.*

39 **Sec. 8.** NRS 613.430 is hereby amended to read as follows:
40 613.430 No action authorized by NRS 613.420 may be brought
41 more than 180 days after the date of the act complained of ~~or~~ *or*
42 *more than 90 days after the date of the receipt of the right-to-sue*
43 *notice pursuant to section 2 of this act, whichever is later.* When a
44 complaint is filed with the Nevada Equal Rights Commission, the
45 limitation provided by this section is tolled as to any action



1 authorized by NRS 613.420 during the pendency of the complaint
2 before the Commission.

3 **Sec. 9.** NRS 233.160 is hereby amended to read as follows:

4 233.160 1. A complaint which alleges unlawful
5 discriminatory practices in:

6 (a) Housing must be filed with the Commission not later than 1
7 year after the date of the occurrence of the alleged practice or the
8 date on which the practice terminated.

9 (b) Employment or public accommodations must be filed with
10 the Commission not later than 300 days after the date of the
11 occurrence of the alleged practice.

12 ➤ A complaint is timely if it is filed with an appropriate federal
13 agency within that period. A complainant shall not file a complaint
14 with the Commission if any other state or federal administrative
15 body or officer which has comparable jurisdiction to adjudicate
16 complaints of discriminatory practices has made a decision upon a
17 complaint based upon the same facts and legal theory.

18 2. The complainant shall specify in the complaint the alleged
19 unlawful practice and sign it under oath.

20 3. The Commission shall send to the party against whom an
21 unlawful discriminatory practice is alleged:

22 (a) A copy of the complaint;

23 (b) An explanation of the rights which are available to that
24 party; and

25 (c) A copy of the Commission's procedures.

26 ***4. If a person files a complaint pursuant to paragraph (b) of***
27 ***subsection 1 which alleges an unlawful discriminatory practice in***
28 ***employment, the Commission shall, as soon as practicable after***
29 ***receiving the complaint, notify in writing the person who filed the***
30 ***complaint that the person may request the Commission to issue a***
31 ***right-to-sue notice pursuant to section 2 of this act.***
