AN ACT relating to occupational safety; expanding the period of expiration and renewal for certain completion cards obtained by construction workers and supervisory employees; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law requires each construction worker and supervisory employee to  
2 obtain, within 15 days after the date he or she is hired, a completion card for taking  
3 a course in construction industry safety and health hazard recognition which is: (1)  
4 developed by the Occupational Safety and Health Administration of the United  
5 States Department of Labor; and (2) approved by the Division of Industrial  
6 Relations of the Department of Business and Industry. Each completion card  
7 obtained by a construction worker or supervisory employee expires 5 years after the  
8 date it is issued and may be renewed by: (1) completing another such course in  
9 construction industry safety and health hazard recognition within the previous 5  
10 years; or (2) completing certain requirements for continuing education within that  
11 period. (NRS 618.983) This bill provides that each completion card obtained by a  
12 construction worker or supervisory employee expires 10 years after the date it is  
13 issued and may be renewed by completing another such course or completing those  
14 requirements for continuing education within the previous 10 years.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 618.983 is hereby amended to read as follows:  
2 618.983 1. Not later than 15 days after the date a construction  
3 worker other than a supervisory employee is hired, the construction

1 worker must obtain a completion card for an OSHA-10 course  
2 which is issued upon completion of a course approved by the  
3 Division pursuant to NRS 618.977.

4 2. Not later than 15 days after the date a supervisory employee  
5 is hired, the supervisory employee must obtain a completion card for  
6 an OSHA-30 course which is issued upon completion of a course  
7 approved by the Division pursuant to NRS 618.977.

8 3. Any completion card used to satisfy the requirements of this  
9 section expires ~~5~~ 10 years after the date it is issued and may be  
10 renewed by:

11 (a) Completing an OSHA-10 course or OSHA-30 course, as  
12 applicable, within the previous ~~5~~ 10 years; or

13 (b) Providing proof satisfactory to the Division that the  
14 construction worker has completed continuing education within the  
15 previous ~~5~~ 10 years consisting of job-specific training that meets  
16 the guidelines established by the Division pursuant to NRS 618.977  
17 in an amount of:

18 (1) For a completion card issued for an OSHA-10 course, not  
19 less than 5 hours; or

20 (2) For a completion card issued for an OSHA-30 course, not  
21 less than 15 hours.

22 **Sec. 2.** This act becomes effective on July 1, 2015.
