

SENATE BILL NO. 276—SENATORS SEGERBLOM AND FARLEY

MARCH 13, 2015

Referred to Committee on Health and Human Services

SUMMARY—Revises provisions governing medical marijuana establishments. (BDR 40-996)

AN ACT relating to medical marijuana; revising provisions relating to the allocation of medical marijuana establishment registration certificates; authorizing the transfer of a medical marijuana establishment registration certificate in certain circumstances; authorizing a medical marijuana establishment to move to a new location under certain circumstances; revising provisions governing the registration of certain medical marijuana establishments; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law limits, by the size of the population of each county, the number of
- 2 certain medical marijuana establishments that may be certified in each county, and
- 3 also limits the Division of Public and Behavioral Health of the Department of
- 4 Health and Human Services to accepting applications for the certification of such
- 5 establishments to not more than 10 days in any calendar year. (NRS 453A.324)
- 6 **Section 1** of this bill requires the Division to reallocate the certificates provided for
- 7 a county which has no qualified applicants to the other counties of this State.
- 8 **Section 5** of this bill provides for the reallocation and issuance of such currently
- 9 unused certificates.
- 10 Existing law prohibits the transfer of a medical marijuana establishment agent
- 11 registration card or a medical marijuana establishment registration certificate. (NRS
- 12 453A.334) **Section 2** of this bill allows the transfer of ownership in a medical
- 13 marijuana establishment and the transfer of a medical marijuana establishment
- 14 registration certificate if the new owner: (1) meets the requirements of existing law
- 15 relating to liquid assets; (2) submits certain information to allow the Division to
- 16 perform certain background checks; and (3) proves that its acquisition of the
- 17 establishment will not violate certain restrictions on holding multiple
- 18 establishments.



19 Existing law establishes certain requirements for the location of a medical
20 marijuana establishment. (NRS 453A.350) **Section 3** of this bill allows an
21 establishment to move to a new location under the jurisdiction of the same local
22 government if, after a public hearing, the local government approves the new
23 location. **Section 4** of this bill requires the Division to revise its regulations to
24 conform with the provisions of **section 3**.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 453A.324 is hereby amended to read as
2 follows:

3 453A.324 1. Except as otherwise provided in this section and
4 NRS 453A.326, the Division shall issue medical marijuana
5 establishment registration certificates for medical marijuana
6 dispensaries in the following quantities for applicants who qualify
7 pursuant to NRS 453A.322:

8 (a) In a county whose population is 700,000 or more, 40
9 certificates;

10 (b) In a county whose population is 100,000 or more but less
11 than 700,000, ten certificates;

12 (c) In a county whose population is 55,000 or more but less than
13 100,000, two certificates; and

14 (d) In each other county, one certificate.

15 2. Notwithstanding the provisions of subsection 1, the Division

16 ~~shall not~~ :

17 (a) *Shall not* issue medical marijuana establishment registration
18 certificates for medical marijuana dispensaries in such a quantity as
19 to cause the existence within the applicable county of more than one
20 medical marijuana dispensary for every ten pharmacies that have
21 been licensed in the county pursuant to chapter 639 of NRS. The
22 Division may issue medical marijuana establishment registration
23 certificates for medical marijuana dispensaries in excess of the ratio
24 otherwise allowed pursuant to this subsection if to do so is
25 necessary to ensure that the Division issues at least one medical
26 marijuana establishment registration certificate in each county of
27 this State in which the Division has approved an application for such
28 an establishment to operate.

29 (b) *Shall, for any county for which no applicants qualify*
30 *pursuant to NRS 453A.322, within 2 months after the end of the*
31 *period during which the Division accepts applications pursuant to*
32 *subsection 4, reallocate the certificates provided for that county*
33 *pursuant to subsection 1 to the other counties specified in*
34 *subsection 1 in the same proportion as provided in subsection 1.*



1 3. With respect to medical marijuana establishments that are
2 not medical marijuana dispensaries, the Division shall determine the
3 appropriate number of such establishments as are necessary to serve
4 and supply the medical marijuana dispensaries to which the Division
5 has granted medical marijuana establishment registration
6 certificates.

7 4. The Division shall not, for more than a total of 10 business
8 days in any 1 calendar year, accept applications to operate medical
9 marijuana establishments.

10 **Sec. 2.** NRS 453A.334 is hereby amended to read as follows:
11 453A.334 ~~¶¶~~

12 *1. Except as otherwise provided in subsection 2, the following*
13 *are nontransferable:*

14 ~~¶~~ (a) A medical marijuana establishment agent registration
15 card.

16 ~~¶~~ (b) A medical marijuana establishment registration
17 certificate.

18 *2. A medical marijuana establishment may transfer all or any*
19 *portion of its ownership to another party, and the Division shall*
20 *transfer the medical marijuana establishment registration*
21 *certificate issued to the establishment to the party acquiring*
22 *ownership, if the party who will acquire the ownership of the*
23 *medical marijuana establishment submits:*

24 (a) *Evidence satisfactory to the Division that the party has*
25 *complied with the provisions of sub-subparagraph (III) of*
26 *subparagraph (2) of paragraph (a) of subsection 3 of NRS*
27 *453A.322 for the purpose of operating the medical marijuana*
28 *establishment.*

29 (b) *For the party and each person who is proposed to be an*
30 *owner, officer or board member of the proposed medical*
31 *marijuana establishment, the name, address and date of birth of*
32 *the person, a complete set of the person's fingerprints and written*
33 *permission of the person authorizing the Division to forward the*
34 *fingerprints to the Central Repository for Nevada Records of*
35 *Criminal History for submission to the Federal Bureau of*
36 *Investigation for its report.*

37 (c) *Proof satisfactory to the Division that, as a result of the*
38 *transfer of ownership, no person, group of persons or entity will,*
39 *in a county whose population is 100,000 or more, hold more than*
40 *one medical marijuana establishment registration certificate or*
41 *more than 10 percent of the medical marijuana establishment*
42 *registration certificates allocated to the county, whichever is*
43 *greater.*

44 **Sec. 3.** NRS 453A.350 is hereby amended to read as follows:
45 453A.350 *1.* Each medical marijuana establishment must:



1 ~~11~~ (a) Be located in a separate building or facility that is
2 located in a commercial or industrial zone or overlay;

3 ~~12~~ (b) Comply with all local ordinances and rules pertaining to
4 zoning, land use and signage;

5 ~~13~~ (c) Have an appearance, both as to the interior and exterior,
6 that is professional, orderly, dignified and consistent with the
7 traditional style of pharmacies and medical offices; and

8 ~~14~~ (d) Have discreet and professional signage that is consistent
9 with the traditional style of signage for pharmacies and medical
10 offices.

11 *2. A medical marijuana establishment may move to a new*
12 *location under the jurisdiction of the same local government as its*
13 *original location and regardless of the distance from its original*
14 *location if the operation of the medical marijuana establishment*
15 *at the new location as been approved by the local government. A*
16 *local government may approve a new location pursuant to this*
17 *subsection only in a public hearing for which written notice is*
18 *given at least 7 working days before the hearing.*

19 **Sec. 4.** 1. The provisions of any regulation adopted by the
20 Division of Public and Behavioral Health of the Department of
21 Health and Human Services which conflict with the provisions of
22 NRS 453A.350, as amended by section 3 of this act, are void and
23 must not be given effect to the extent of the conflict.

24 2. The Division of Public and Behavioral Health shall amend
25 or repeal any of its existing regulations that conflict or are
26 inconsistent with the provisions of NRS 453A.350, as amended by
27 section 3 of this act, as soon as practicable after the effective date of
28 this section.

29 **Sec. 5.** 1. Notwithstanding any other provision of law, the
30 Division shall reallocate, on or before July 1, 2015, medical
31 marijuana establishment registration certificates for medical
32 marijuana dispensaries pursuant to NRS 453A.324, as amended by
33 section 1 of this act, in the following quantities for applicants who
34 qualify pursuant to NRS 453A.322:

35 (a) In a county whose population is 700,000 or more, eight
36 certificates for the unincorporated area of such a county;

37 (b) In a county whose population is 100,000 or more but less
38 than 700,000, one certificate for the unincorporated area of such a
39 county; and

40 (c) In addition to the certificate described in paragraph (b), in a
41 county whose population is 100,000 or more but less than 700,000:

42 (1) One certificate for each city whose population is 220,000
43 or more; and

44 (2) One certificate for each city whose population is 60,000
45 or more but less than 220,000.



1 2. The provisions of NRS 453A.326 do not apply to any
2 medical marijuana establishment registration certificate issued
3 pursuant to subsection 1.

4 3. Notwithstanding any other provision of law, the Division:

5 (a) Shall, on or before July 1, 2015, issue a medical marijuana
6 establishment registration certificate pursuant to subsection 1 if:

7 (1) The medical marijuana establishment is in compliance
8 with paragraph (a) of subsection 4; and

9 (2) The issuance of such certificate does not exceed the total
10 number of certificates allocated.

11 (b) May, at any time, after receiving an application to operate a
12 medical marijuana establishment:

13 (1) Register the medical marijuana establishment; and

14 (2) Issue a medical marijuana establishment registration
15 certificate to the applicant.

16 (c) Shall, on or after the effective date of this act and before
17 September 1, 2015, regardless of the Division's ranking of the
18 applications to operate a medical marijuana establishment, issue a
19 medical marijuana establishment registration certificate for the total
20 number of certificates allocated unless the Division determines that
21 the applicant is not qualified.

22 (d) Shall provide the rationale for determining that an applicant
23 to operate a medical marijuana establishment is not qualified, within
24 30 days after such determination, to:

25 (1) An applicant who is denied a medical marijuana
26 establishment registration certificate; and

27 (2) The local governmental jurisdiction where the proposed
28 medical marijuana establishment is to be located.

29 4. A local governmental jurisdiction may:

30 (a) Issue a business license or deem a medical marijuana
31 establishment in compliance with all local governmental ordinances
32 or rules, regardless of any ranking of the establishment established
33 by the Division.

34 (b) Consider diversity, location and community ties in
35 determining whether the medical marijuana establishment is in
36 compliance with all applicable local governmental ordinances or
37 rules.

38 (c) Provide by ordinance a limitation on the total number of
39 medical marijuana establishments which is less than the number
40 allocated pursuant to subsection 1, if the local governmental
41 jurisdiction determines that the community is adequately served by
42 the number of current establishments.

43 5. Any application period established by the Division pursuant
44 to this section:



- 1 (a) Is a one-time extension of the application period opened by
2 the Division in calendar year 2014;
- 3 (b) Must not require a new application if an application has
4 previously been submitted;
- 5 (c) Must not require the payment of any additional application
6 fees if such fees have previously been paid; and
- 7 (d) Is separate and apart from and must not be included within
8 the 10-day period for the acceptance of applications pursuant to
9 subsection 4 of NRS 453A.324, as amended by section 1 of this act.
- 10 6. As used in this section:
- 11 (a) "Division" means the Division of Public and Behavioral
12 Health of the Department of Health and Human Services.
- 13 (b) "Local governmental jurisdiction" means a city, town,
14 township or unincorporated area within a county.
- 15 **Sec. 6.** 1. This section and sections 1 and 5 of this act
16 become effective upon passage and approval.
- 17 2. Section 5 of this act expires by limitation on December 31,
18 2015.
- 19 3. Sections 2, 3 and 4 of this act become effective upon
20 passage and approval for the purpose of adopting regulations and
21 performing any other preparatory administrative tasks that are
22 necessary to carry out the provisions of this act, and on October 1,
23 2015, for all other purposes.
