SUMMARY—Revises provisions related to public safety.

AN ACT relating to governmental administration; requiring a fire department established by a county, city or town to operate in compliance with certain standards; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

- 1 Existing law authorizes a board of county commissioners to create a district for
- 2 a fire department and authorizes a city council of a city incorporated pursuant to
- 3 general law to organize, regulate and maintain a fire department. (NRS 244.2961,
- 4 266.310) **Sections 1 and 2** of this bill provide that any such fire department must
- 5 operate in compliance with the current: (1) standards of the National Fire Protection
- 6 Association; and (2) regulations of the Occupational Safety and Health
- 7 Administration of the United States Department of Labor.
- 8 Existing law requires the town board or board of county commissioners in any
- 9 unincorporated town to organize, regulate and establish fire companies or fire
- 10 departments. (NRS 269.250) **Section 3** of this bill requires that such a fire company
- 11 or fire department operate in compliance with the current: (1) standards of the
- 12 National Fire Protection Association; and (2) regulations of the Occupational
- 13 Safety and Health Administration of the United States Department of Labor.
- 14 The City Charters of the cities of Caliente, Carlin, Carson City, Elko,
- 15 Henderson, Las Vegas, Mesquite, North Las Vegas, Wells and Yerington authorize
- 16 their respective City Councils to organize, regulate and maintain a fire department.
- 17 (Caliente City Charter § 2.160, Carlin City Charter § 2.170, Carson City Charter §
- 18 2.160, Elko City Charter § 2.200, Henderson City Charter § 2.160, Las Vegas City
- 19 Charter § 2.170, Mesquite City Charter § 2.150, North Las Vegas City Charter §
- 20 2.160, Wells City Charter § 2.170, Yerington City Charter § 2.160) **Sections 5-12,**
- 21 **15 and 16** of this bill require that any such fire department operate in compliance



22 with the current: (1) standards of the National Fire Protection Association; and (2)
23 regulations of the Occupational Safety and Health Administration of the United
24 States Department of Labor.

25 **Sections 4, 13 and 14** of this bill authorize the City Council of Boulder City
26 and the Cities of Reno and Sparks to organize, regulate and maintain a fire
27 department. Any such fire department must operate in compliance with the current:
28 (1) standards of the National Fire Protection Association; and (2) regulations of the
29 Occupational Safety and Health Administration of the United States Department of
30 Labor.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 244.2961 is hereby amended to read as
2 follows:

3 244.2961 1. The board of county commissioners may by
4 ordinance create a district for a fire department. The board of county
5 commissioners is ex officio the governing body of any district
6 created pursuant to this section and may:

7 (a) Organize, regulate and maintain the fire department. *Any*
8 *such fire department must operate in compliance with the current:*

9 (1) *Standards of the National Fire Protection Association;*
10 *and*

11 (2) *Regulations of the Occupational Safety and Health*
12 *Administration of the United States Department of Labor,*
13 *including, without limitation, 29 C.F.R. § 1910.134.*

14 (b) Appoint and prescribe the duties of the fire chief.

15 (c) Designate arson investigators as peace officers.

16 (d) Regulate or prohibit the storage of any explosive,
17 combustible or inflammable material in or transported through the
18 county, and prescribe the distance from any residential or
19 commercial area where it may be kept. Any ordinance adopted
20 pursuant to this paragraph that regulates places of employment
21 where explosives are stored must be at least as stringent as the
22 standards and procedures adopted by the Division of Industrial
23 Relations of the Department of Business and Industry pursuant to
24 NRS 618.890.

25 (e) Establish, by ordinance, a fire code and other regulations
26 necessary to carry out the purposes of this section.

27 (f) Include the budget of the district in the budget of the county.

28 (g) Hold meetings of the governing body of the district in
29 conjunction with the meetings of the board of county commissioners
30 without posting additional notices of the meetings within the
31 district.



1 2. Except as otherwise provided in subsection 6, if the fire
2 department transports sick or injured persons to a medical facility,
3 the board of county commissioners shall adopt an ordinance:

- 4 (a) Requiring the fire department to defray the expenses of
5 furnishing such transportation by imposing and collecting fees; and
6 (b) Establishing a schedule of such fees.

7 3. The board of county commissioners of a county whose
8 population is 700,000 or more shall, when adopting an ordinance
9 pursuant to subsection 2:

10 (a) Limit the number of transports of sick or injured persons to a
11 medical facility that may be made by the fire department to not
12 more than 1,000 such transports per year, except that the fire
13 department may, exclusive of the limit, make any such emergency
14 transport that is necessary for the health or life of a sick or injured
15 person when other ambulance services are not available; and

16 (b) Require the fire department and all other ambulance services
17 operating in the county to report to the board:

18 (1) The total number of transports of sick or injured persons
19 to a medical facility that are made each month; and

20 (2) For each transport reported pursuant to subparagraph (1):

21 (I) The fees charged to transport the person to a medical
22 facility;

23 (II) Whether the person had health insurance at the time
24 of the transport; and

25 (III) The name of the medical facility where the fire
26 department or ambulance service transported the person to or from.

27 4. The other officers and employees of the county shall
28 perform duties for the district that correspond to the duties they
29 perform for the county.

30 5. All persons employed to perform the functions of the fire
31 department are employees of the county for all purposes.

32 6. The provisions of subsection 2 do not apply to any county
33 for which a nonprofit corporation has been granted an exclusive
34 franchise for ambulance service in that county.

35 **Sec. 2.** NRS 266.310 is hereby amended to read as follows:

36 266.310 The city council may:

37 1. Organize, regulate and maintain a fire department. *Any such*
38 *fire department must operate in compliance with the current:*

39 (a) *Standards of the National Fire Protection Association; and*

40 (b) *Regulations of the Occupational Safety and Health*
41 *Administration of the United States Department of Labor,*
42 *including, without limitation, 29 C.F.R. § 1910.134.*

43 2. Prescribe the duties of the fire chief.

44 3. Designate arson investigators as peace officers.



1 4. Regulate or prohibit the storage of any explosive,
2 combustible or inflammable material in or transported through the
3 city, and prescribe the distance from any residential or commercial
4 area where it may be kept. Any ordinance adopted pursuant to this
5 subsection that regulates places of employment where explosives
6 are stored must be at least as stringent as the standards and
7 procedures adopted by the Division of Industrial Relations of the
8 Department of Business and Industry pursuant to NRS 618.890.

9 5. Establish, by ordinance, a fire code and other regulations
10 necessary to carry out the purposes of this section.

11 **Sec. 3.** NRS 269.250 is hereby amended to read as follows:

12 269.250 1. The town board or board of county
13 commissioners shall in any unincorporated town in their respective
14 counties:

15 (a) Provide for the prevention and extinguishment of fires.

16 (b) Organize, regulate, establish and disband fire companies or
17 fire departments. *Any such fire company or fire department must*
18 *operate in compliance with the current:*

19 (1) *Standards of the National Fire Protection Association;*
20 *and*

21 (2) *Regulations of the Occupational Safety and Health*
22 *Administration of the United States Department of Labor,*
23 *including, without limitation, 29 C.F.R. § 1910.134.*

24 (c) Provide for the payment of fire companies or fire
25 departments, and the appointment and payment of officers thereof.

26 2. All payments authorized under the provisions of subsection
27 1 must be made from the separate fund of the town where service is
28 performed or required when the fire company or department
29 operates in the town alone, and if used outside of the town the board
30 of county commissioners may provide for contribution from general
31 county funds if provided for in the county budget.

32 3. A majority of the town board or board of county
33 commissioners shall name and appoint two-thirds of all such
34 officers and employees, and the minority thereof shall name and
35 appoint one-third.

36 4. The fire chief and the personnel of the fire department are
37 entitled to receive such compensation as the town board or board of
38 county commissioners prescribes.

39 5. The town board or board of county commissioners may
40 designate arson investigators as peace officers.

41 **Sec. 4.** The Charter of Boulder City is hereby amended by
