

SENATE BILL NO. 309—SENATOR SETTELMAYER

MARCH 21, 2011

Referred to Committee on Natural Resources

SUMMARY—Authorizes a person to remove from his or her property livestock for which he or she has, by contract, provided care and shelter under certain circumstances. (BDR 50-703)

AN ACT relating to livestock; authorizing a person to remove from his or her property livestock for which he or she has, by contract, provided care and shelter under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law provides for the care of and prevention of cruelty to animals.  
2 (NRS 574.050-574.510) This bill provides that: (1) if a person enters into a contract  
3 to provide care and shelter for livestock; (2) the person gives 30 days’ notice of the  
4 termination of the contract and requests the removal of the livestock from his or her  
5 property at the end of the contract; and (3) the owner fails to remove the livestock  
6 from the person’s property at the end of that contract, the person providing care and  
7 shelter may remove the livestock from his or her property in several ways.  
8 However, before the person may remove the livestock, he or she must provide  
9 written notification to the owner by certified mail of his or her intention to remove  
10 the livestock if the owner fails to remove the livestock from the person’s property.  
11 If the owner fails to remove the livestock by the time provided for in the notice, the  
12 livestock will be deemed abandoned, and the person may: (1) sell the livestock; (2)  
13 give the livestock to a society for the prevention of cruelty to animals; (3) return the  
14 livestock to the owner; (4) transfer the livestock to another facility that is willing to  
15 provide care and shelter for the livestock; or (5) bring an action in court to require  
16 the owner to remove the livestock from the person’s property. The owner of the  
17 livestock is liable for any reasonable and actual costs incurred by the person in  
18 removing the livestock from his or her property.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1       **Section 1.** Chapter 575 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3       1. *A person who enters into a contract with an owner of*  
4 *livestock to provide care or shelter for the livestock on the person's*  
5 *property shall give the owner of the livestock at least 30 days'*  
6 *notice before terminating the contract.*

7       2. *After receiving the notice, if the owner of the livestock fails*  
8 *to remove the livestock from the property before the termination of*  
9 *the contract, the livestock shall be deemed abandoned and the*  
10 *person providing care or shelter for the livestock may remove the*  
11 *livestock from his or her property as provided in subsection 3 if:*

12       (a) *The person notifies the owner of the livestock in writing of*  
13 *the person's intention to remove the livestock from the property if*  
14 *the owner fails to remove the livestock before the date the contract*  
15 *is terminated; and*

16       (b) *Fourteen days have elapsed since the notice was mailed to*  
17 *the owner of the livestock. The notice must be mailed, by certified*  
18 *mail, return receipt requested, to the owner of the livestock at the*  
19 *owner's present address, and if that address is unknown, then at*  
20 *the owner's last known address.*

21       3. *If any livestock is deemed abandoned pursuant to*  
22 *subsection 2, a person providing care or shelter for that livestock*  
23 *may:*

24       (a) *Sell the livestock;*

25       (b) *Give the livestock to a society for the prevention of cruelty*  
26 *to animals;*

27       (c) *Return the livestock to the owner at the owner's present*  
28 *address;*

29       (d) *Transfer the livestock to another facility which is able to*  
30 *provide care and shelter for the livestock; or*

31       (e) *Bring a civil action in a court of competent jurisdiction to*  
32 *require the owner to remove the livestock from the person's*  
33 *property.*

34       4. *If the owner of the livestock fails to remove the livestock*  
35 *pursuant to subsection 2, the person providing care and shelter for*  
36 *the livestock may charge and collect any reasonable and actual*  
37 *costs he or she incurs in removing the livestock pursuant to*  
38 *subsection 3.*

39       5. *Except as otherwise provided in subsection 6, the*  
40 *provisions of this section may be varied by agreement, and the*  
41 *rights conferred by this section may be waived.*



- 1        ***6. The remedies provided for in this section are the exclusive***  
2 ***remedies for an action brought pursuant to this section. If a***  
3 ***person pursues a remedy not provided for in this section***  
4 ***including, without limitation, a civil action for breach of contract***  
5 ***or trespass, the provisions of this section do not apply, and the***  
6 ***remedies provided for in this section are not available.***
- 7        ***7. As used in this section, "livestock" means:***  
8        ***(a) All cattle or animals of the bovine species;***  
9        ***(b) All horses, mules, burros and asses or animals of the***  
10 ***equine species;***  
11        ***(c) All swine or animals of the porcine species;***  
12        ***(d) All goats or animals of the caprine species; and***  
13        ***(e) All sheep or animals of the ovine species.***
