AN ACT relating to public health; creating the Rare Disease Advisory Council within the Department of Health and Human Services; requiring information concerning the importance of annual physical examinations for children to be provided in certain programs, activities, notifications and courses; providing for the issuance of special license plates to increase awareness of childhood cancer; exempting the special license plates from certain provisions otherwise applicable to special license plates; requiring certain licensing boards to encourage continuing education in the diagnosis of rare diseases and disseminate information concerning childhood cancers; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

- 1 Existing law establishes certain programs to improve public health in this State.
2 (NRS 439.495-439.5297) **Section 2** of this bill creates the Rare Disease Advisory
3 Council within the Department of Health and Human Services to study issues
4 relating to the prevalence and treatment of rare diseases in this State. **Section 3** of
5 this bill prescribes the duties of the Council, which include annually compiling a
6 public report. **Section 3** requires the report to contain a summary of the activities of
7 the Council and any recommendations of the Council for legislation and other
8 policies.
9 Existing law requires the Division of Public and Behavioral Health of the
10 Department of Health and Human Services to take necessary measures to prevent
11 the spread of sickness and disease and enforce all health laws and regulations.
12 (NRS 439.170) **Section 4** of this bill requires the Division to include information

13 concerning the importance of annual physical examinations by a provider of health
14 care for children in appropriate public health programs and activities. **Section 5** of
15 this bill requires the board of trustees of a school district or the governing body of a
16 charter school to include such information in any written communication with the
17 parents or guardians of pupils related to the health of pupils.

18 Existing law requires health and physical education to be taught in all public
19 schools in this State. (NRS 389.018) **Section 6** of this bill requires those courses to
20 include instruction concerning the importance of annual physical examinations by a
21 provider of health care and the appropriate response to unusual aches and pains.

22 **Section 7** of this bill requires the Department of Motor Vehicles to design,
23 prepare and issue special license plates to increase awareness of childhood cancer.
24 A person wishing to obtain the special license plates must pay to the Department
25 fees for initial issuance of \$60 and fees for renewal of \$30, along with all
26 applicable registration and license fees and governmental services taxes. **Section 7**
27 requires a portion of those fees to be credited to the Department and used to pay
28 any expenses of the Rare Disease Advisory Council and other programs and
29 services related to childhood cancer. A person wishing to obtain the special license
30 plates may also request that the plates be combined with personalized prestige
31 plates if the person pays the additional fees for the personalized prestige plates.

32 Under existing law, certain special license plates: (1) must be approved by the
33 Department, based on a recommendation from the Commission on Special License
34 Plates; (2) are subject to a limitation on the number of separate designs of special
35 license plates which the Department may issue at any one time; and (3) may not be
36 designed, prepared or issued by the Department unless a certain number of
37 applications for the plates are received. (NRS 482.367004, 482.367008, 482.36705)
38 **Sections 11-13** of this bill exempt the special license plates to increase awareness
39 of childhood cancer from each of the preceding requirements. **Sections 7.5-10 and**
40 **14-16** of this bill make conforming changes.

41 Existing law requires physicians, physician assistants and registered nurses to
42 receive certain continuing education. (NRS 630.253, 632.343, 633.471) **Sections**
43 **18, 20 and 22** of this bill require the Board of Medical Examiners, the State Board
44 of Nursing and the State Board of Osteopathic Medicine to encourage physicians,
45 physician assistants and advanced practice registered nurses to receive, as a portion
46 of that continuing education, training and education in the diagnosis of rare
47 diseases. **Sections 17, 19 and 21** of this bill require those licensing boards to
48 annually disseminate to physicians, physician assistants and registered nurses who
49 care for children information concerning the signs of pediatric cancer.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 439 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1. *The Rare Disease Advisory Council is hereby***
4 ***created within the Department of Health and Human Services.***
5 ***The Council consists of:***

6 ***(a) The Chair of the State of Nevada Advisory Council on***
7 ***Palliative Care and Quality of Life created by NRS 232.4855 or his***
8 ***or her designee; and***

9 ***(b) The following members appointed by the Director:***



1 (1) *Not more than three physicians who practice in the area*
2 *of cardiology, emergency care, neurology, oncology, orthopedics,*
3 *pediatrics or primary care and provide care to patients with rare*
4 *diseases;*

5 (2) *Two registered nurses who provide care to patients with*
6 *rare diseases;*

7 (3) *Not more than two administrators of hospitals that provide*
8 *care to patients with rare diseases or their designees;*

9 (4) *One representative of the Division who provides education*
10 *concerning rare diseases or the management of chronic*
11 *conditions;*

12 (5) *The employee of the Division who is responsible for*
13 *epidemiology services;*

14 (6) *Two persons over 18 years of age who have suffered from*
15 *or currently suffer from a rare disease;*

16 (7) *Two parents or guardians who each have experience*
17 *caring for a child with a rare disease;*

18 (8) *One representative of an organization dedicated to*
19 *providing services to patients suffering from rare diseases in*
20 *northern Nevada; and*

21 (9) *One representative of an organization dedicated to*
22 *providing services to patients suffering from rare diseases in*
23 *southern Nevada.*

24 2. *The Council may, by affirmative vote of a majority of its*
25 *members, request the Director to appoint to the Council additional*
26 *members who have expertise on issues studied by the Council.*
27 *Such members serve for a period determined by the Council.*

28 3. *A vacancy in the membership of the Council must be filled*
29 *in the same manner as the initial appointment.*

30 4. *The members of the Council serve without compensation*
31 *and are not entitled to the per diem and travel expenses provided*
32 *for state officers and employees generally.*

33 5. *Each member of the Council who is an officer or employee*
34 *of this State or a political subdivision of this State must be relieved*
35 *from his or her duties without loss of regular compensation so that*
36 *the officer or employee may prepare for and attend meetings of the*
37 *Council and perform any work necessary to carry out the duties of*
38 *the Council in the most timely manner practicable. A state agency*
39 *or political subdivision of this State shall not require an officer or*
40 *employee who is a member of the Council to make up the time the*
41 *officer or employee is absent from work to carry out duties as a*
42 *member of the Council or use annual leave or compensatory time*
43 *for the absence.*



1 6. *The Department shall provide such administrative support*
2 *to the Council as is necessary to carry out the duties of the*
3 *Council.*

4 7. *The Council shall:*

5 (a) *Elect a Chair from among its members; and*

6 (b) *Meet at least once every 3 months at the times and places*
7 *specified by a call of the Chair and may meet at such further times*
8 *as deemed necessary by the Chair.*

9 **Sec. 3. 1. *The Rare Disease Advisory Council created by***
10 ***section 2 of this act shall:***

11 (a) *Perform a statistical and qualitative examination of the*
12 *incidence, causes and economic burden of rare diseases in this*
13 *State;*

14 (b) *Receive and consider reports and testimony concerning*
15 *rare diseases from persons, the Division, community-based*
16 *organizations, providers of health care and other local and*
17 *national organizations whose work relates to rare diseases;*

18 (c) *Increase awareness of the burden caused by rare diseases*
19 *in this State;*

20 (d) *Identify evidence-based strategies to prevent and control*
21 *rare diseases;*

22 (e) *Determine the effect of delayed or inappropriate treatment*
23 *on the quality of life for patients suffering from rare diseases and*
24 *the economy of this State;*

25 (f) *Study the effect of early treatment for rare diseases on the*
26 *quality of life for patients suffering from rare diseases, the*
27 *provision of services to such patients and reimbursement for such*
28 *services;*

29 (g) *Increase awareness among providers of health care of the*
30 *symptoms of and care for patients with rare diseases;*

31 (h) *Evaluate the systems for delivery of treatment for rare*
32 *diseases in place in this State and develop recommendations to*
33 *increase the survival rates and quality of life of patients with rare*
34 *diseases;*

35 (i) *Determine effective methods of collecting data concerning*
36 *cases of rare diseases in this State for the purpose of conducting*
37 *epidemiological studies of rare diseases in this State;*

38 (j) *Establish a comprehensive plan for the management of rare*
39 *diseases in this State, which must include, without limitation,*
40 *recommendations for the Department, the Division, local health*
41 *districts, public and private organizations, businesses and*
42 *potential sources of funding, and update the comprehensive plan*
43 *as necessary; and*



1 (k) *Develop a registry of rare diseases diagnosed in this State*
2 *to determine the genetic and environmental factors that contribute*
3 *to such rare diseases.*

4 2. *The Council shall compile an annual report which must*
5 *include, without limitation, a summary of the activities of the*
6 *Council and any recommendations of the Council for legislation*
7 *or other policies. The Council shall:*

8 (a) *Post the report on an Internet website maintained by the*
9 *Department; and*

10 (b) *Submit the report to the Department, the Governor and the*
11 *Director of the Legislative Counsel Bureau for transmittal to:*

12 (1) *In even-numbered years, the next regular session of the*
13 *Legislature; and*

14 (2) *In odd-numbered years, the Legislative Committee on*
15 *Health Care.*

16 3. *As used in this section, "provider of health care" has the*
17 *meaning ascribed to it in NRS 629.031.*

18 **Sec. 4.** NRS 439.170 is hereby amended to read as follows:

19 439.170 **1.** *The Division shall take such measures as may be*
20 *necessary to prevent the spread of sickness and disease, and shall*
21 *possess all powers necessary to fulfill the duties and exercise the*
22 *authority prescribed by law and to bring actions in the courts for the*
23 *enforcement of all health laws and lawful rules and regulations.*

24 **2.** *The Division shall include in appropriate public health*
25 *programs and activities information concerning the importance of*
26 *an annual physical examination by a provider of health care for*
27 *children.*

28 **Sec. 5.** Chapter 388 of NRS is hereby amended by adding
29 thereto a new section to read as follows:

30 *The board of trustees of a school district or the governing body*
31 *of a charter school shall include in any written communication*
32 *with the parent or guardian of a pupil related to the health of*
33 *pupils information concerning the importance of an annual*
34 *physical examination by a provider of health care for children.*

35 **Sec. 6.** NRS 389.018 is hereby amended to read as follows:

36 389.018 **1.** *The following subjects are designated as the core*
37 *academic subjects that must be taught, as applicable for grade*
38 *levels, in all public schools, the Caliente Youth Center, the Nevada*
39 *Youth Training Center and any other state facility for the detention*
40 *of children that is operated pursuant to title 5 of NRS:*

41 (a) *English language arts;*

42 (b) *Mathematics;*

43 (c) *Science; and*

44 (d) *Social studies, which includes only the subjects of history,*
45 *geography, economics and government.*



1 2. Except as otherwise provided in this subsection, a pupil
2 enrolled in a public high school must enroll in a minimum of:

3 (a) Four units of credit in English language arts;

4 (b) Four units of credit in mathematics, including, without
5 limitation, Algebra I and geometry, or an equivalent course of study
6 that integrates Algebra I and geometry;

7 (c) Three units of credit in science, including two laboratory
8 courses; and

9 (d) Three units of credit in social studies, including, without
10 limitation:

11 (1) American government;

12 (2) American history; and

13 (3) World history or geography.

14 ↪ A pupil is not required to enroll in the courses of study and
15 credits required by this subsection if the pupil, the parent or legal
16 guardian of the pupil and an administrator or a counselor at the
17 school in which the pupil is enrolled mutually agree to a modified
18 course of study for the pupil and that modified course of study
19 satisfies at least the requirements for a standard high school
20 diploma, an adjusted diploma or an alternative diploma, as
21 applicable.

22 3. Except as otherwise provided in this subsection, in addition
23 to the core academic subjects, the following subjects must be taught
24 as applicable for grade levels and to the extent practicable in all
25 public schools, the Caliente Youth Center, the Nevada Youth
26 Training Center and any other state facility for the detention of
27 children that is operated pursuant to title 5 of NRS:

28 (a) The arts;

29 (b) Computer education and technology;

30 (c) Health; and

31 (d) Physical education.

32 ↪ If the State Board requires the completion of course work in a
33 subject area set forth in this subsection for graduation from high
34 school or promotion to the next grade, a public school shall offer the
35 required course work. Except as otherwise provided for a course of
36 study in health prescribed by subsection 1 of NRS 389.021, unless a
37 subject is required for graduation from high school or promotion to
38 the next grade, a charter school is not required to comply with this
39 subsection.

40 *4. Instruction in health and physical education provided*
41 *pursuant to subsection 3 must include, without limitation,*
42 *instruction concerning the importance of annual physical*
43 *examinations by a provider of health care and the appropriate*
44 *response to unusual aches and pains.*



1 **Sec. 7.** Chapter 482 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 1. *The Department, in cooperation with organizations*
4 *selected by the Department whose work relates to childhood*
5 *cancer, shall design, prepare and issue license plates to increase*
6 *awareness of childhood cancer using any colors and designs*
7 *which the Department deems appropriate. The design of the*
8 *license plates must include the phrase "Cure Childhood Cancer."*

9 2. *The Department shall issue license plates to increase*
10 *awareness of childhood cancer for a passenger car or light*
11 *commercial vehicle upon application by a person who is entitled to*
12 *license plates pursuant to NRS 482.265 and who otherwise*
13 *complies with the requirements for registration and licensing*
14 *pursuant to this chapter. A person may request that personalized*
15 *prestige license plates issued pursuant to NRS 482.3667 be*
16 *combined with license plates to increase awareness of childhood*
17 *cancer if that person pays the fees for the personalized prestige*
18 *license plates in addition to the fees for the license plates to*
19 *increase awareness of childhood cancer pursuant to subsections 3*
20 *and 4.*

21 3. *The fee for license plates to increase awareness of*
22 *childhood cancer is \$35, in addition to all other applicable*
23 *registration and license fees and governmental services taxes. The*
24 *license plates are renewable upon the payment of \$10.*

25 4. *In addition to all other applicable registration and license*
26 *fees and governmental services taxes and the fee prescribed*
27 *pursuant to subsection 3, a person who requests a set of license*
28 *plates to increase awareness of childhood cancer must pay for the*
29 *issuance of the plates an additional fee of \$25 and for each*
30 *renewal of the plates an additional fee of \$20, to be deposited in*
31 *accordance with subsection 8.*

32 5. *The provisions of NRS 482.36705 do not apply to license*
33 *plates described in this section.*

34 6. *If, during a registration period, the holder of license plates*
35 *issued pursuant to the provisions of this section disposes of the*
36 *vehicle to which the plates are affixed, the holder shall:*

37 (a) *Retain the plates and affix them to another vehicle that*
38 *meets the requirements of this section if the holder pays the fee for*
39 *the transfer of the registration and any registration fee or*
40 *governmental services taxes due pursuant to NRS 482.399; or*

41 (b) *Within 30 days after removing the plates from the vehicle,*
42 *return them to the Department.*

43 7. *The Department may accept any gifts, grants and*
44 *donations or other sources of money for the production and*
45 *issuance of the special license plates pursuant to this section.*



1 **8. The Department shall deposit the additional fees collected**
2 **pursuant to subsection 4 with the State Treasurer for credit to the**
3 **Department of Health and Human Services. The money may be**
4 **used by the Department of Health and Human Services only:**

- 5 (a) **To pay any expenses of the Rare Disease Advisory Council**
6 **created by section 2 of this act; and**
7 (b) **For other programs and services related to childhood**
8 **cancer.**

9 **Sec. 7.5.** NRS 482.2065 is hereby amended to read as follows:

10 482.2065 1. A trailer may be registered for a 3-year period as
11 provided in this section.

12 2. A person who registers a trailer for a 3-year period must pay
13 upon registration all fees and taxes that would be due during the 3-
14 year period if he or she registered the trailer for 1 year and renewed
15 that registration for 2 consecutive years immediately thereafter,
16 including, without limitation:

17 (a) Registration fees pursuant to NRS 482.480 and 482.483.

18 (b) A fee for each license plate issued pursuant to NRS 482.268.

19 (c) Fees for the initial issuance, reissuance and renewal of a
20 special license plate pursuant to NRS 482.265, if applicable.

21 (d) Fees for the initial issuance and renewal of a personalized
22 prestige license plate pursuant to NRS 482.367, if applicable.

23 (e) Additional fees for the initial issuance and renewal of a
24 special license plate issued pursuant to NRS 482.3667 to 482.3823,
25 inclusive, **and section 7 of this act** which are imposed to generate
26 financial support for a particular cause or charitable organization, if
27 applicable.

28 (f) Governmental services taxes imposed pursuant to chapter
29 371 of NRS, as provided in NRS 482.260.

30 (g) The applicable taxes imposed pursuant to chapters 372, 374,
31 377 and 377A of NRS.

32 3. A license plate issued pursuant to this section will be
33 reissued as provided in NRS 482.265 except that such reissuance
34 will be done at the first renewal after the license plate has been
35 issued for not less than 8 years.

36 4. As used in this section, the term "trailer" does not include a
37 full trailer or semitrailer that is registered pursuant to subsection 3 of
38 NRS 482.483.

39 **Sec. 8.** NRS 482.216 is hereby amended to read as follows:

40 482.216 1. Except as otherwise provided in NRS 482.2155,
41 upon the request of a new vehicle dealer, the Department may
42 authorize the new vehicle dealer to:

43 (a) Accept applications for the registration of the new motor
44 vehicles he or she sells and the related fees and taxes;



1 (b) Issue certificates of registration to applicants who satisfy the
2 requirements of this chapter; and

3 (c) Accept applications for the transfer of registration pursuant
4 to NRS 482.399 if the applicant purchased from the new vehicle
5 dealer a new vehicle to which the registration is to be transferred.

6 2. A new vehicle dealer who is authorized to issue certificates
7 of registration pursuant to subsection 1 shall:

8 (a) Transmit the applications received to the Department within
9 the period prescribed by the Department;

10 (b) Transmit the fees collected from the applicants and properly
11 account for them within the period prescribed by the Department;

12 (c) Comply with the regulations adopted pursuant to subsection
13 5; and

14 (d) Bear any cost of equipment which is necessary to issue
15 certificates of registration, including any computer hardware or
16 software.

17 3. A new vehicle dealer who is authorized to issue certificates
18 of registration pursuant to subsection 1 shall not:

19 (a) Charge any additional fee for the performance of those
20 services;

21 (b) Receive compensation from the Department for the
22 performance of those services;

23 (c) Accept applications for the renewal of registration of a motor
24 vehicle; or

25 (d) Accept an application for the registration of a motor vehicle
26 if the applicant wishes to:

27 (1) Obtain special license plates pursuant to NRS 482.3667
28 to 482.3823, inclusive ~~§~~, *and section 7 of this act*; or

29 (2) Claim the exemption from the governmental services tax
30 provided pursuant to NRS 361.1565 to veterans and their relations.

31 4. The provisions of this section do not apply to the registration
32 of a moped pursuant to NRS 482.2155.

33 5. The Director shall adopt such regulations as are necessary to
34 carry out the provisions of this section. The regulations adopted
35 pursuant to this subsection must provide for:

36 (a) The expedient and secure issuance of license plates and
37 decals by the Department; and

38 (b) The withdrawal of the authority granted to a new vehicle
39 dealer pursuant to subsection 1 if that dealer fails to comply with the
40 regulations adopted by the Department.

41 **Sec. 9.** NRS 482.2703 is hereby amended to read as follows:

42 482.2703 1. The Director may order the preparation of
43 sample license plates which must be of the same design and size as
44 regular license plates or license plates issued pursuant to NRS
45 482.384. The Director shall ensure that:



1 (a) Each license plate issued pursuant to this subsection,
2 regardless of its design, is inscribed with the word SAMPLE and an
3 identical designation which consists of the same group of three
4 numerals followed by the same group of three letters; and

5 (b) The designation of numerals and letters assigned pursuant to
6 paragraph (a) is not assigned to a vehicle registered pursuant to this
7 chapter or chapter 706 of NRS.

8 2. The Director may order the preparation of sample license
9 plates which must be of the same design and size as any of the
10 special license plates issued pursuant to NRS 482.3667 to 482.3823,
11 inclusive ~~[]~~, *and section 7 of this act*. The Director shall ensure
12 that:

13 (a) Each license plate issued pursuant to this subsection,
14 regardless of its design, is inscribed with the word SAMPLE and the
15 number zero in the location where any other numerals would
16 normally be displayed on a license plate of that design; and

17 (b) The number assigned pursuant to paragraph (a) is not
18 assigned to a vehicle registered pursuant to this chapter or chapter
19 706 of NRS.

20 3. The Director may establish a fee for the issuance of sample
21 license plates of not more than \$15 for each license plate.

22 4. A decal issued pursuant to NRS 482.271 may be displayed
23 on a sample license plate issued pursuant to this section.

24 5. All money collected from the issuance of sample license
25 plates must be deposited in the State Treasury for credit to the
26 Motor Vehicle Fund.

27 6. A person shall not affix a sample license plate issued
28 pursuant to this section to a vehicle. A person who violates the
29 provisions of this subsection is guilty of a misdemeanor.

30 **Sec. 10.** NRS 482.274 is hereby amended to read as follows:

31 482.274 1. The Director shall order the preparation of vehicle
32 license plates for trailers in the same manner provided for motor
33 vehicles in NRS 482.270, except that a vehicle license plate
34 prepared for a full trailer or semitrailer that is registered pursuant to
35 subsection 3 of NRS 482.483 is not required to have displayed upon
36 it the month and year the registration expires.

37 2. The Director shall order preparation of two sizes of vehicle
38 license plates for trailers. The smaller plates may be used for trailers
39 with a gross vehicle weight of less than 1,000 pounds.

40 3. The Director shall determine the registration numbers
41 assigned to trailers.

42 4. Any license plates issued for a trailer before July 1, 1975,
43 bearing a different designation from that provided for in this section,
44 are valid during the period for which such plates were issued.



1 5. Any license plates issued for a trailer before
2 January 1, 1982, are not subject to reissue pursuant to subsection 2
3 of NRS 482.265.

4 6. The Department shall not issue for a full trailer or semitrailer
5 that is registered pursuant to subsection 3 of NRS 482.483 a special
6 license plate available pursuant to NRS 482.3667 to 482.3823,
7 inclusive **H**, *and section 7 of this act.*

8 **Sec. 11.** NRS 482.367004 is hereby amended to read as
9 follows:

10 482.367004 1. There is hereby created the Commission on
11 Special License Plates. The Commission is advisory to the
12 Department and consists of five Legislators and three nonvoting
13 members as follows:

14 (a) Five Legislators appointed by the Legislative Commission:

15 (1) One of whom is the Legislator who served as the Chair of
16 the Assembly Standing Committee on Transportation during the
17 most recent legislative session. That Legislator may designate an
18 alternate to serve in place of the Legislator when absent. The
19 alternate must be another Legislator who also served on the
20 Assembly Standing Committee on Transportation during the most
21 recent legislative session.

22 (2) One of whom is the Legislator who served as the Chair of
23 the Senate Standing Committee on Transportation during the most
24 recent legislative session. That Legislator may designate an alternate
25 to serve in place of the Legislator when absent. The alternate must
26 be another Legislator who also served on the Senate Standing
27 Committee on Transportation during the most recent legislative
28 session.

29 (b) Three nonvoting members consisting of:

30 (1) The Director of the Department of Motor Vehicles, or a
31 designee of the Director.

32 (2) The Director of the Department of Public Safety, or a
33 designee of the Director.

34 (3) The Director of the Department of Tourism and Cultural
35 Affairs, or a designee of the Director.

36 2. Each member of the Commission appointed pursuant to
37 paragraph (a) of subsection 1 serves a term of 2 years, commencing
38 on July 1 of each odd-numbered year. A vacancy on the
39 Commission must be filled in the same manner as the original
40 appointment.

41 3. Members of the Commission serve without salary or
42 compensation for their travel or per diem expenses.

43 4. The Director of the Legislative Counsel Bureau shall

16 involves the use of a weapon of mass destruction. The course must
17 provide at least 4 hours of instruction that includes instruction in the
18 following subjects:

19 (1) An overview of acts of terrorism and weapons of mass
20 destruction;

21 (2) Personal protective equipment required for acts of
22 terrorism;

23 (3) Common symptoms and methods of treatment associated
24 with exposure to, or injuries caused by, chemical, biological,
25 radioactive and nuclear agents;

26 (4) Syndromic surveillance and reporting procedures for acts
27 of terrorism that involve biological agents; and

28 (5) An overview of the information available on, and the use
29 of, the Health Alert Network.

30 ↪ The Board may thereafter determine whether to include in a
31 program of continuing education additional courses of instruction
32 relating to the medical consequences of an act of terrorism that
33 involves the use of a weapon of mass destruction.

34 4. The Board shall encourage each licensee who treats or cares
35 for persons who are more than 60 years of age to receive, as a
36 portion of their continuing education, education in geriatrics and
37 gerontology, including such topics as:

38 (a) The skills and knowledge that the licensee needs to address
39 aging issues;

40 (b) Approaches to providing health care to older persons,
41 including both didactic and clinical approaches;

42 (c) The biological, behavioral, social and emotional aspects of
43 the aging process; and

44 (d) The importance of maintenance of function and
45 independence for older persons.

17 (a) "Act of terrorism" has the meaning ascribed to it in
18 NRS 202.4415.

19 (b) "Biological agent" has the meaning ascribed to it in
20 NRS 202.442.

21 (c) "Chemical agent" has the meaning ascribed to it in
22 NRS 202.4425.

23 (d) "Radioactive agent" has the meaning ascribed to it in
24 NRS 202.4437.

25 (e) "Weapon of mass destruction" has the meaning ascribed to it
26 in NRS 202.4445.

27 **Sec. 21.** Chapter 633 of NRS is hereby amended by adding
28 thereto a new section to read as follows:

29 *The Board shall develop and disseminate annually to each
30 licensed osteopathic physician and physician assistant who cares
31 for children information concerning the signs and symptoms of
32 pediatric cancer.*

33 **Sec. 22.** NRS 633.471 is hereby amended to read as follows:

34 633.471 1. Except as otherwise provided in subsection 9 and
35 NRS 633.491, every holder of a license issued under this chapter,
36 except a temporary or a special license, may renew the license on or
37 before January 1 of each calendar year after its issuance by:

38 (a) Applying for renewal on forms provided by the Board;

39 (b) Paying the annual license renewal fee specified in this
40 chapter;

41 (c) Submitting a list of all actions filed or claims submitted to
42 arbitration or mediation for malpractice or negligence against the
43 holder during the previous year;

44 (d) Submitting evidence to the Board that in the year preceding
45 the application for renewal the holder has attended courses or



1 programs of continuing education approved by the Board in
2 accordance with regulations adopted by the Board totaling a number
3 of hours established by the Board which must not be less than 35

13 for renewal of a license to practice osteopathic medicine or a license
14 to practice as a physician assistant. Upon a request from the Board,
15 an applicant for renewal of a license to practice osteopathic
16 medicine or a license to practice as a physician assistant shall submit
17 verified evidence satisfactory to the Board that in the year preceding
18 the application for renewal the applicant attended courses or
19 programs of continuing medical education approved by the Board
20 totaling the number of hours established by the Board.

21 4. The Board shall require each holder of a license to practice
22 osteopathic medicine to complete a course of instruction within 2
23 years after initial licensure that provides at least 2 hours of
24 instruction on evidence-based suicide prevention and awareness as
25 described in subsection ~~7-1~~ 8.

26 5. The Board shall encourage each holder of a license to
27 practice osteopathic medicine to receive, as a portion of his or her
28 continuing education, training concerning methods for educating
29 patients about how to effectively manage medications, including,
30 without limitation, the ability of the patient to request to have the
31 symptom or purpose for which a drug is prescribed included on the
32 label attached to the container of the drug.

33 6. *The Board shall encourage each holder of a license to*
34 *practice osteopathic medicine or as a physician assistant to*

4 practice osteopathic medicine to receive as a portion of his or her

8 (a) The skills and knowledge that the licensee needs to detect
9 behaviors that may lead to suicide, including, without limitation,
10 post-traumatic stress disorder;

13 (c) The detection of suicidal thoughts and ideations and the
14 prevention of suicide.

15 ~~8~~ 9. A holder of a license to practice osteopathic medicine
16 may not substitute the continuing education credits relating to
17 suicide prevention and awareness required by this section for the
18 purposes of satisfying an equivalent requirement for continuing
19 education in ethics.

20 ~~9~~ 10. Members of the Armed Forces of the United States
21 and the United States Public Health Service are exempt from
22 payment of the annual license renewal fee during their active duty
23 status.

24 **Sec. 23.** The Rare Disease Advisory Council created by
25 section 2 of this act shall meet not later than 90 days after the
26 effective date of this section.

27 **Sec. 24.** The provisions of subsection 1 of NRS 218D.380 do
28 not apply to any provision of this act which adds or revises a
29 requirement to submit a report to the Legislature.

30 **Sec. 25.** 1. This section and sections 1, 2, 3, 23 and 24 of this
31 act become effective upon passage and approval.

32 2. Sections 4 to 22, inclusive, of this act become effective:

33 (a) Upon passage and approval for the purpose of adopting any
34 regulations and performing any other preparatory administrative
35 tasks that are necessary to carry out the provisions of this act; and

36 (b) On January 1, 2020, for all other purposes.
