AN ACT relating to motor vehicles; revising provisions relating to enforcement of weight limits on vehicles; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Existing law provides for the enforcement of weight limits on vehicles by
2 specially trained members of the Nevada Highway Patrol, inspectors of the
3 Department of Motor Vehicles and the Department of Public Safety, and to certain
4 law enforcement personnel in counties whose population is 100,000 or more
5 (currently Clark and Washoe Counties). The authorized law enforcement personnel,
6 if they have reason to believe that the weight of a vehicle and load is unlawful, may
7 require the driver to stop and submit to a weighing of the vehicle. (NRS 484D.675)
8 This bill authorizes such a stop only if the officer has a reasonable suspicion that
9 the vehicle is being operated unlawfully by reason of its weight. This bill eliminates
10 the restriction on enforcement of these provisions by local law enforcement officers
11 in less populated counties but specifies that the authority of the law enforcement
12 officers and inspectors is limited to enforcement within their own jurisdiction. This
13 bill also revises the training requirements for such officers.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 484D.675 is hereby amended to read as
2 follows:
3 484D.675 1. Authority for the enforcement of the provisions
4 of NRS 484D.630 to 484D.680, inclusive, is vested in certain law
5 enforcement agencies in this State.



1 2. Any category I peace officer, officer of the Nevada Highway
2 Patrol or inspector ~~[having reason to believe]~~, ***acting within his or***
3 ***her jurisdiction, who has reasonable suspicion*** that the weight of a
4 vehicle and load is unlawful may require the driver to stop and
5 submit to a weighing of the vehicle either by means of portable or
6 stationary scales and may require that the vehicle be driven to the
7 nearest public scales, if they are within 5 miles.

8 3. An officer of the Nevada Highway Patrol, a category I peace
9 officer or an inspector upon weighing a vehicle and load as provided
10 in subsection 2 who determines that the weight is unlawful may
11 require the driver to stop in a suitable place and remove such portion
12 of the load as may be necessary to reduce the gross weight of the
13 vehicle to those limits permitted under NRS 484D.630 to 484D.680,
14 inclusive. All materials so unloaded must be cared for by the carrier
15 of the material and at the carrier's expense. The officer of the
16 Nevada Highway Patrol, category I peace officer or inspector may
17 allow the driver of the inspected vehicle to continue on his or her
18 journey if any overload does not exceed by more than 5 percent the
19 limitations prescribed by NRS 484D.630 to 484D.680, inclusive, but
20 the penalties provided in NRS 484D.680 must be imposed for the
21 overload violation.

22 4. Any driver of a vehicle who fails or refuses to stop and
23 submit the vehicle and load to a weighing, or who fails or refuses
24 when directed by an officer of the Nevada Highway Patrol, a
25 category I peace officer or an inspector upon a weighing of the
26 vehicle to stop and otherwise comply with the provisions of NRS
27 484D.630 to 484D.680, inclusive, is guilty of a misdemeanor.

28 5. As used in this section:

29 (a) "Category I peace officer" means a peace officer, as defined
30 in NRS 289.460, ~~[in a county whose population is 100,000 or more]~~
31 who ~~[has]~~:

32 ***(1) Has received specialized training concerning vehicle***
33 ***weight enforcement;***

34 ***(2) Is certified by the Commercial Vehicle Safety Alliance***
35 ***to perform a North American Standard Inspection; and***

36 ***(3) Has completed a vehicle weight enforcement training***
37 ***program [that is specific to this State and] conducted by the***
38 ***Commercial Vehicle Safety Alliance or an equivalent program***
39 ***approved by the Nevada Highway Patrol [] for this purpose.***

40 (b) "Inspector" means an inspector of the Department of Motor
41 Vehicles or the Department of Public Safety who has completed a
42 vehicle weight enforcement training program that is specific to this
43 State and conducted by the Nevada Highway Patrol.

44 (c) "Law enforcement agency" has the meaning ascribed to it in
45 NRS 202.873.
