

SENATE BILL NO. 323—SENATOR PARKS

SUMMARY—Revises provisions relating to motor vehicle liability insurance and registration. (BDR 43-421)

FISCAL NOTE: Effect on Local Government: Increases or Newly Provides for Term of Imprisonment in County or City Jail or Detention Facility.

EXPLANATION – Matter in *bolded italics* is new; matter between brackets [omitted material] is material to be omitted.

AN ACT relating to vehicles; revising provisions governing the reinstatement of the registration of a motor vehicle whose registered owner has allowed his or her policy of liability insurance to lapse; revising provisions governing registration of vehicles in this State by residents of this State; requiring certain nonresidents to register vehicles in this State; prohibiting the Department of Motor Vehicles from registering a motor vehicle under certain circumstances; providing penalties; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

1 Under existing law, a registered owner who failed to have liability insurance on
2 a date specified by the Department of Motor Vehicles is required, with respect to a
3 vehicle that is not dormant, to pay to the Department a fee of \$250 to reinstate the
4 registration of the vehicle. (NRS 482.480) **Section 2** of this bill replaces the flat
5 \$250 reinstatement fee with a tiered system of penalties that includes, depending
6 upon how many times the registered owner has allowed his or her insurance to
7 lapse and depending upon the length of time during which the insurance has lapsed,
8 escalating reinstatement fees, escalating fines, requirements to file and maintain a
9 certificate of financial responsibility and possible suspension of the registered
10 owner’s driver’s license.

11 Existing law requires a person, within 60 days after becoming a resident of this
12 State, to apply for the registration of each vehicle he or she owns which is operated
13 in this State. A nonresident owner of a noncommercial vehicle is not required to
14 apply for registration of the vehicle unless the vehicle is furnished to a resident for
15 his or her continuous use within this State. (NRS 482.385) **Section 4** of this bill
16 changes the 60-day period within which a new resident must apply for registration



17 of his or her vehicle to a 30-day period. **Section 4** also requires certain persons to
18 register their vehicles: (1) if the person is a nonresident and the vehicle is operated
19 in this State for a period of more than 30 days in the aggregate in any 1 calendar
20 year; (2) within 30 days if the person is a resident or nonresident and engages in a
21 trade, profession or occupation or accepts gainful employment in this State; (3)
22 within 30 days if the person is a resident or nonresident and enrolls his or her
23 children in a public school in this State; or (4) within 30 days if the person is a
24 resident and operates a vehicle owned by a nonresident. **Section 4** provides
25 exceptions to the preceding requirements for persons who are on active duty in the
26 military service of the United States, out-of-state students, certain students of
27 institutions of higher education who are present in this State to participate in a
28 work-study program, and migrant or seasonal farm workers.

29 Under existing law, a constable may issue a citation to an owner or driver, as
30 appropriate, of a vehicle that is required to be registered in this State if the
31 constable determines that the vehicle is not properly registered. Such a constable
32 must, upon the issuance of the citation, charge and collect a fee of \$100 from the
33 person to whom the citation was issued. (NRS 258.070) **Section 3** of this bill
34 prohibits the Department of Motor Vehicles from registering a motor vehicle if the
35 Department has received from a local authority notice that the owner of the vehicle
36 has failed to pay a fee imposed by a constable for noncompliance with the
37 provisions of NRS 482.385, unless the owner provides to the Department a receipt
38 indicating that the owner has paid the fee to the local authority or the local authority
39 transmits to the Department a notice stating that the owner has paid the fee.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 482 of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2. 1. *Except as otherwise provided in subsection 7 of***
4 ***NRS 485.317, if a registered owner failed to have insurance on the***
5 ***date specified by the Department pursuant to NRS 485.317:***

6 ***(a) For a first offense, the registered owner shall pay to the***
7 ***Department a registration reinstatement fee of \$250, and if the***
8 ***period during which insurance coverage lapsed was:***

9 ***(1) At least 31 days but not more than 90 days, pay to the***
10 ***Department a fine of \$250.***

11 ***(2) At least 91 days but not more than 180 days:***

12 ***(I) Pay to the Department a fine of \$500; and***

13 ***(II) File and maintain with the Department a certificate***
14 ***of financial responsibility for a period of not less than 3 years***
15 ***following the date on which the registration of the applicable***
16 ***vehicle is reinstated.***

17 ***(3) More than 180 days:***

18 ***(I) Pay to the Department a fine of \$1,000; and***

19 ***(II) File and maintain with the Department a certificate***
20 ***of financial responsibility for a period of not less than 3 years***



1 following the date on which the registration of the applicable
2 vehicle is reinstated.

3 (b) For a second offense, the registered owner shall pay to the
4 Department a registration reinstatement fee of \$500, and if the
5 period during which insurance coverage lapsed was:

6 (1) At least 31 days but not more than 90 days, pay to the
7 Department a fine of \$500.

8 (2) At least 91 days but not more than 180 days:

9 (I) Pay to the Department a fine of \$500; and

10 (II) File and maintain with the Department a certificate
11 of financial responsibility for a period of not less than 3 years
12 following the date on which the registration of the applicable
13 vehicle is reinstated.

14 (3) More than 180 days:

15 (I) Pay to the Department a fine of \$1,000; and

16 (II) File and maintain with the Department a certificate
17 of financial responsibility for a period of not less than 3 years
18 following the date on which the registration of the applicable
19 vehicle is reinstated.

20 (c) For a third or subsequent offense:

21 (1) The driver's license of the registered owner must be
22 suspended for a period to be determined by regulation of the
23 Department but not less than 30 days;

24 (2) The registered owner shall file and maintain with the
25 Department a certificate of financial responsibility for a period of
26 not less than 3 years following the date on which the registration
27 of the applicable vehicle is reinstated; and

28 (3) The registered owner shall pay to the Department a
29 registration reinstatement fee of \$750, and if the period during
30 which insurance coverage lapsed was:

31 (I) At least 31 days but not more than 90 days, pay to the
32 Department a fine of \$500.

33 (II) At least 91 days but not more than 180 days, pay to
34 the Department a fine of \$750.

35 (III) More than 180 days, pay to the Department a fine
36 of \$1,000.

37 2. As used in this section, "certificate of financial
38 responsibility" has the meaning ascribed to it in NRS 485.028.

39 **Sec. 3. 1.** Except as otherwise provided in subsection 3, the
40 Department shall not register a motor vehicle if a local authority
41 has filed with the Department a notice stating that the owner of
42 the motor vehicle:

43 (a) Was cited by a constable pursuant to subsection 2 of NRS
44 258.070 for failure to comply with the provisions of NRS 482.385;
45 and



1 ***(b) Has failed to pay the fee charged by the constable pursuant***
2 ***to subsection 2 of NRS 258.070.***

3 ***2. The Department shall, upon request, furnish to the owner***
4 ***of the motor vehicle a copy of the notice of nonpayment described***
5 ***in subsection 1.***

6 ***3. The Department may register a motor vehicle for which the***
7 ***Department has received a notice of nonpayment described in***
8 ***subsection 1 if:***

9 ***(a) The Department receives:***

10 ***(1) A receipt from the owner of the motor vehicle which***
11 ***indicates that the owner has paid the fee charged by the constable;***
12 ***or***

13 ***(2) Notification from the applicable local authority that the***
14 ***owner of the motor vehicle has paid the fee charged by the***
15 ***constable; and***

16 ***(b) The owner of the motor vehicle otherwise complies with the***
17 ***requirements of this chapter for the registration of the motor***
18 ***vehicle.***

19 **Sec. 4.** NRS 482.385 is hereby amended to read as follows:

20 482.385 1. Except as otherwise provided in **[subsection]**
21 ***subsections 5 and 7*** and NRS 482.390, a nonresident owner of a
22 vehicle of a type subject to registration pursuant to the provisions of
23 this chapter, owning any vehicle which has been registered for the
24 current year in the state, country or other place of which the owner
25 is a resident and which at all times when operated in this State has
26 displayed upon it the registration license plate issued for the vehicle
27 in the place of residence of the owner, may operate or permit the
28 operation of the vehicle within this State without its registration in
29 this State pursuant to the provisions of this chapter and without the
30 payment of any registration fees to this State **[+]**:

31 ***(a) For a period of not more than 30 days in the aggregate in***
32 ***any 1 calendar year; and***

33 ***(b) Notwithstanding the provisions of paragraph (a), during***
34 ***any period in which the owner is:***

35 ***(1) On active duty in the military service of the United***
36 ***States;***

37 ***(2) An out-of-state student;***

38 ***(3) Registered as a student at a college or university located***
39 ***outside this State and who is in the State for a period of not more***
40 ***than 6 months to participate in a work-study program for which***
41 ***the student earns academic credits from the college or university;***
42 ***or***

43 ***(4) A migrant or seasonal farm worker.***



- 1 2. This section does not:
- 2 (a) Prohibit the use of manufacturers', distributors' or dealers'
- 3 license plates issued by any state or country by any nonresident in
- 4 the operation of any vehicle on the public highways of this State.
- 5 (b) Require registration of vehicles of a type subject to
- 6 registration pursuant to the provisions of this chapter operated by
- 7 nonresident common motor carriers of persons or property, contract
- 8 motor carriers of persons or property, or private motor carriers of
- 9 property as stated in NRS 482.390.

6 subsection, shall be punished by a fine of \$1,000. The fine imposed
7 pursuant to this subsection is in addition to any fine or penalty
8 imposed for the other alleged violation or offense for which the
9 vehicle was halted or its driver arrested pursuant to subsection ~~3-1~~

10 **4.** The fine imposed pursuant to this subsection may be reduced to
11 not less than \$200 if the person presents evidence at the time of the
12 hearing that the person has registered the vehicle pursuant to this
13 chapter.

14 ~~5-1~~ **7.** Any resident operating upon a highway of this State a
15 motor vehicle which is owned by a nonresident and which is
16 furnished to the resident operator for his or her continuous use
17 within this State, shall cause that vehicle to be registered within ~~60~~
18 **30** days after beginning its operation within this State.

19 ~~6-1~~ **8.** A person registering a vehicle pursuant to the
20 provisions of subsection *1, 3, 5 ,* ~~or~~ *7 or 9* or pursuant to
21 NRS 482.390:

22 (a) Must be assessed the registration fees and governmental
23 services tax, as required by the provisions of this chapter and
24 chapter 371 of NRS; and

25 (b) Must not be allowed credit on those taxes and fees for the
26 unused months of the previous registration.

27 ~~7-1~~ **9.** If a vehicle is used in this State for a gainful purpose,
28 the owner shall immediately apply to the Department for
29 registration, except as otherwise provided in NRS 482.390, 482.395
30 and 706.801 to 706.861, inclusive.

31 ~~8-1~~ **10.** An owner registering a vehicle pursuant to the
32 provisions of this section shall surrender the existing nonresident
33 license plates and registration certificates to the Department for
34 cancellation.

35 ~~9-1~~ **11.** A vehicle may be cited for a violation of this section
36 regardless of whether it is in operation or is parked on a highway, in
37 a public parking lot or on private property which is open to the
38 public if, after communicating with the owner or operator of the
39 vehicle, the peace officer issuing the citation determines that:

40 (a) The owner of the vehicle is a resident of this State; ~~or~~

41 (b) The vehicle is used in this State for a gainful purpose ~~or~~;

42 *(c) Except as otherwise provided in paragraph (b) of*
43 *subsection 1, the owner of the vehicle is a nonresident and has*
44 *operated the vehicle in this State for more than 30 days in the*
45 *aggregate in any 1 calendar year; or*



1 *(d) The owner of the vehicle is a nonresident required to*
2 *register the vehicle pursuant to subsection 5.*

3 ➔ As used in this subsection, "peace officer" includes a constable.

4 **Sec. 5.** NRS 482.480 is hereby amended to read as follows:

5 482.480 There must be paid to the Department for the
6 registration or the transfer or reinstatement of the registration of
7 motor vehicles, trailers and semitrailers, fees according to the
8 following schedule:

9 1. Except as otherwise provided in this section, for each stock
10 passenger car and each reconstructed or specially constructed
11 passenger car registered to a person, regardless of weight or number
12 of passenger capacity, a fee for registration of \$33.

13 2. Except as otherwise provided in subsection 3:

14 (a) For each of the fifth and sixth such cars registered to a
15 person, a fee for registration of \$16.50.

16 (b) For each of the seventh and eighth such cars registered to a
17 person, a fee for registration of \$12.

18 (c) For each of the ninth or more such cars registered to a
19 person, a fee for registration of \$8.

20 3. The fees specified in subsection 2 do not apply:

21 (a) Unless the person registering the cars presents to the
22 Department at the time of registration the registrations of all the cars
23 registered to the person.

24 (b) To cars that are part of a fleet.

25 4. For every motorcycle, a fee for registration of \$33 and for
26 each motorcycle other than a trimobile, an additional fee of \$6 for
27 motorcycle safety. The additional fee must be deposited in the State
28 Highway Fund for credit to the Account for the Program for the
29 Education of Motorcycle Riders.

30 5. For each transfer of registration, a fee of \$6 in addition to
31 any other fees.

32 6. Except as otherwise provided in subsection 7 of NRS
33 485.317, to reinstate the registration of a motor vehicle that is
34 suspended pursuant to that section:

35 (a) A fee ~~[of \$250]~~ *as specified in section 2 of this act* for a
36 registered owner who failed to have insurance on the date specified
37 by the Department ~~[]~~, *which fee is in addition to any fine or*
38 *penalty imposed pursuant to section 2 of this act;* or

39 (b) A fee of \$50 for a registered owner of a dormant vehicle who
40 cancelled the insurance coverage for that vehicle or allowed the
41 insurance coverage for that vehicle to expire without first cancelling
42 the registration for the vehicle in accordance with subsection 3 of
43 NRS 485.320,

44 ➔ both of which must be deposited in the Account for Verification
45 of Insurance which is hereby created in the State Highway Fund.



1 The money in the Account must be used to carry out the provisions
2 of NRS 485.313 to 485.318, inclusive.

3 7. For every travel trailer, a fee for registration of \$27.

4 8. For every permit for the operation of a golf cart, an annual
5 fee of \$10.

6 9. For every low-speed vehicle, as that term is defined in NRS
7 484B.637, a fee for registration of \$33.

8 10. To reinstate the registration of a motor vehicle that is
9 suspended pursuant to NRS 482.451, a fee of \$33.

10 **Sec. 6.** NRS 485.317 is hereby amended to read as follows:

11 485.317 1. The Department shall verify that each motor
12 vehicle which is registered in this State is covered by a policy of
13 liability insurance as required by NRS 485.185.

14 2. Except as otherwise provided in this subsection, the
15 Department may use any information to verify whether a motor
16 vehicle is covered by a policy of liability insurance as required by
17 NRS 485.185. The Department may not use the name of the owner
18 of a motor vehicle as the primary means of verifying that a motor
19 vehicle is covered by a policy of liability insurance.

20 3. If the Department is unable to verify that a motor vehicle is
21 covered by a policy of liability insurance as required by NRS
22 485.185, the Department shall send a request for information by
23 first-class mail to the registered owner of the motor vehicle. The
24 owner shall submit all the information which is requested to the
25 Department within 15 days after the date on which the request for
26 information was mailed by the Department. If the Department does
27 not receive the requested information within 15 days after it mailed
28 the request to the owner, the Department shall send to the owner a
29 notice of suspension of registration by certified mail. The notice
30 must inform the owner that unless the Department is able to verify
31 that the motor vehicle is covered by a policy of liability insurance as
32 required by NRS 485.185 within 10 days after the date on which the
33 notice was sent by the Department, the owner's registration will be
34 suspended pursuant to subsection 4.

35 4. The Department shall suspend the registration and require
36 the return to the Department of the license plates of any vehicle for
37 which the Department cannot verify the coverage of liability
38 insurance required by NRS 485.185.

39 5. Except as otherwise provided in subsection 6, the
40 Department shall reinstate the registration of the vehicle and reissue
41 the license plates only upon verification of current insurance and
42 ~~payment of the fee~~ *compliance with the requirements* for
43 reinstatement of registration prescribed in paragraph (a) of
44 subsection 6 of NRS 482.480.



1 6. If a registered owner proves to the satisfaction of the
2 Department that the vehicle was a dormant vehicle during the period
3 in which the information provided pursuant to NRS 485.314
4 indicated that there was no insurance for the vehicle, the Department
5 shall reinstate the registration and, if applicable, reissue the license
6 plates. If such an owner of a dormant vehicle failed to cancel the
7 registration for the vehicle in accordance with subsection 3 of NRS
8 485.320, the Department shall not reinstate the registration or
9 reissue the license plates unless the owner pays the fee set forth in
10 paragraph (b) of subsection 6 of NRS 482.480.

11 7. If the Department suspends the registration of a motor
12 vehicle pursuant to subsection 4 because the registered owner of the
13 motor vehicle failed to have insurance on the date specified in the
14 form for verification, and if the registered owner, in accordance with
15 regulations adopted by the Department, proves to the satisfaction of
16 the Department that the owner was unable to comply with the
17 provisions of NRS 485.185 on that date because of extenuating
18 circumstances, the Department may:

19 (a) Reinstate the registration of the motor vehicle and reissue the
20 license plates upon payment by the registered owner of a fee of \$50,
21 which must be deposited in the Account for Verification of
22 Insurance created by subsection 6 of NRS 482.480; or

23 (b) Rescind the suspension of the registration without the
24 payment of a fee.

25 ↪ The Department shall adopt regulations to carry out the
26 provisions of this subsection.

27 **Sec. 7.** Notwithstanding the amendatory provisions of this act:

28 1. The provisions of subsection 3 of NRS 482.385, as amended
29 by section 4 of this act, do not require a person specified in that
30 subsection to register a vehicle owned by that person and operated
31 in this State until August 1, 2011.

32 2. The provisions of subsection 5 of NRS 482.385, as added to
33 that section by section 4 of this act, do not require a resident of this
34 State specified in that subsection to register a vehicle owned by that
35 person and operated in this State until September 1, 2011.

36 3. The provisions of subsection 7 of NRS 482.385, as amended
37 by section 4 of this act, do not require a resident of this State who
38 operates a motor vehicle specified in that subsection to cause that
39 motor vehicle to be registered until August 1, 2011.

40 **Sec. 8.** This act becomes effective upon passage and approval
41 for the purpose of adopting regulations and on July 1, 2011, for all
42 other purposes.
