AN ACT relating to public welfare; requiring the Director of the
Department of Health and Human Services to authorize
certain children to enroll in Medicaid and the Children’s
Health Insurance Program; and providing other matters
properly relating thereto.

Legislative Counsel’s Digest:

1 Existing federal law provides generally that an alien is not eligible for any
2 Federal means-tested public benefit for a period of 5 years beginning on the date of
3 the alien’s entry into the United States. (8 U.S.C. § 1613) Federal law contains an
4 exemption that authorizes a state to elect to allow children under 21 years of age
5 who are lawfully residing in the United States and have resided in the United States
6 for less than 5 years to enroll in Medicaid and the Children’s Health Insurance
7 Program. (42 U.S.C. § 1396b(v)(4)(A)(ii)) This bill requires the Director of the
8 Department of Health and Human Services to include in the State Plan for
9 Medicaid and the Children’s Health Insurance Program authorization for such
10 children to enroll in Medicaid and the Children’s Health Insurance Program.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 422 of NRS is hereby amended by adding
2 thereto a new section to read as follows:

3 *The Director shall:*

4 *1. To the extent authorized by federal law, include in the*
5 *State Plan for Medicaid and in the Children’s Health Insurance*



1 *Program authorization for a child described in 42 U.S.C. §*
2 *1396b(v)(4)(A)(ii) to enroll in Medicaid and the Children's Health*
3 *Insurance Program; and*

4 *2. Take any action necessary to comply with the requirements*
5 *of the Centers for Medicare and Medicaid Services and any other*
6 *applicable federal law to carry out the requirements of*
7 *subsection 1.*

8 **Sec. 2.** NRS 232.320 is hereby amended to read as follows:

9 232.320 1. The Director:

10 (a) Shall appoint, with the consent of the Governor,
11 administrators of the divisions of the Department, who are
12 respectively designated as follows:

13 (1) The Administrator of the Aging and Disability Services
14 Division;

15 (2) The Administrator of the Division of Welfare and
16 Supportive Services;

17 (3) The Administrator of the Division of Child and Family
18 Services;

19 (4) The Administrator of the Division of Health Care
20 Financing and Policy; and

21 (5) The Administrator of the Division of Public and
22 Behavioral Health.

23 (b) Shall administer, through the divisions of the Department,
24 the provisions of chapters 63, 424, 425, 427A, 432A to 442,
25 inclusive, 446 to 450, inclusive, 458A and 656A of NRS, NRS
26 127.220 to 127.310, inclusive, 422.001 to 422.410, inclusive, *and*
27 *section 1 of this act*, 422.580, 432.010 to 432.133, inclusive,
28 432B.621 to 432B.626, inclusive, 444.002 to 444.430, inclusive,
29 and 445A.010 to 445A.055, inclusive, and all other provisions of
30 law relating to the functions of the divisions of the Department, but
31 is not responsible for the clinical activities of the Division of Public
32 and Behavioral Health or the professional line activities of the other
33 divisions.

34 (c) Shall administer any state program for persons with
35 developmental disabilities established pursuant to the
36 Developmental Disabilities Assistance and Bill of Rights Act of
37 2000, 42 U.S.C. §§ 15001 et seq.

38 (d) Shall, after considering advice from agencies of local
39 governments and nonprofit organizations which provide social
40 services, adopt a master plan for the provision of human services in
41 this State. The Director shall revise the plan biennially and deliver a
42 copy of the plan to the Governor and the Legislature at the
43 beginning of each regular session. The plan must:



- 1 (1) Identify and assess the plans and programs of the
2 Department for the provision of human services, and any
3 duplication of those services by federal, state and local agencies;
4 (2) Set forth priorities for the provision of those services;
5 (3) Provide for communication and the coordination of those
6 services among nonprofit organizations, agencies of local
7 government, the State and the Federal Government;
8 (4) Identify the sources of funding for services provided by
9 the Department and the allocation of that funding;
10 (5) Set forth sufficient information to assist the Department
11 in providing those services and in the planning and budgeting for the
12 future provision of those services; and
13 (6) Contain any other information necessary for the
14 Department to communicate effectively with the Federal
15 Government concerning demographic trends, formulas for the
16 distribution of federal money and any need for the modification of
17 programs administered by the Department.
18 (e) May, by regulation, require nonprofit organizations and state
19 and local governmental agencies to provide information regarding
20 the programs of those organizations and agencies, excluding
21 detailed information relating to their budgets and payrolls, which the
22 Director deems necessary for the performance of the duties imposed
23 upon him or her pursuant to this section.
24 (f) Has such other powers and duties as are provided by law.
25 2. Notwithstanding any other provision of law, the Director, or
26 the Director's designee, is responsible for appointing and removing
27 subordinate officers and employees of the Department, other than
28 the State Public Defender of the Office of State Public Defender
29 who is appointed pursuant to NRS 180.010.
30 **Sec. 3.** This act becomes effective on July 1, 2017.
