
SENATE BILL NO. 340—SENATORS BREEDEN AND WIENER**MARCH 21, 2011**

SUMMARY—Revises provisions relating to programs to increase public awareness of health care information.
(BDR 40-663)

EXPLANATION – Matter in ***bolded italics*** is new; matter between brackets [~~omitted material~~] is material to be omitted.

AN ACT relating to public health; requiring the Department of Health and Human Services to collect information from hospitals and surgical centers for ambulatory patients relating to physicians who perform surgical procedures to the extent that money is available; requiring the Department to post such information on an Internet website if available; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 **Sections 1 and 2** of this bill require the Department of Health and Human
2 Services to collect and maintain information, to the extent that money is available
3 for that purpose, from hospitals and surgical centers for ambulatory patients
4 concerning the names of physicians who perform surgical procedures and other
5 data relating to those surgical procedures as part of the programs established by the
6 Department to increase public awareness of health care information. **Section 3** of
7 this bill requires the Department to post that information on an Internet website if
8 that information is available.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 439A.220 is hereby amended to read as
2 follows:
3 439A.220 1. The Department shall establish and maintain a
4 program to increase public awareness of health care information

1 concerning the hospitals in this State. The program must be
2 designed to assist consumers with comparing the quality of care
3 provided by the hospitals in this State and the charges for that care.

4 2. The program must include, without limitation, the collection,
5 maintenance and provision of information concerning:

6 (a) Inpatients and outpatients of each hospital in this State as
7 reported in the forms submitted pursuant to NRS 449.485;

8 (b) The quality of care provided by each hospital in this State as
9 determined by applying uniform measures of quality prescribed by
10 the Department pursuant to NRS 439A.230;

11 (c) How consistently each hospital follows recognized practices
12 to prevent the infection of patients, to speed the recovery of patients
13 and to avoid medical complications of patients;

14 (d) For each hospital, the total number of patients discharged,
15 the average length of stay and the average billed charges, reported
16 for the 50 most frequent diagnosis-related groups for inpatients and
17 50 medical treatments for outpatients that the Department
18 determines are most useful for consumers; ~~and~~

19 (e) *To the extent that money is available for that purpose, for
20 each hospital, the name of each physician who performed a
21 surgical procedure in the hospital and the total number of surgical
22 procedures performed by the physician, reported by diagnosis-
23 related group if the information is available and by principal
24 diagnosis, principal surgical procedure and secondary surgical
25 procedure; and*

26 (f) Any other information relating to the charges imposed and
27 the quality of the services provided by the hospitals in this State
28 which the Department determines is:

29 (1) Useful to consumers;
30 (2) Nationally recognized; and
31 (3) Reported in a standard and reliable manner.

32 3. As used in this section, "diagnosis-related group" means
33 groupings of medical diagnostic categories used as a basis for
34 hospital payment schedules by Medicare and other third-party health

36 **Sec. 2.** NRS 439A.240 is hereby amended to read as follows:

37 439A.240 1. The Department shall establish and maintain a

39 concerning the surgical centers for ambulatory patients in this State.
40 The program must be designed to assist consumers with comparing
41 the quality of care provided by the surgical centers for ambulatory
42 patients in this State and the charges for that care.

43 2. The program must include, without limitation, the collection,
44 maintenance and provision of information concerning:

1 (a) The charges imposed on outpatients by each surgical center
2 for ambulatory patients in this State as reported in the forms
3 submitted pursuant to NRS 439A.250;

4 (b) The quality of care provided by each surgical center for
5 ambulatory patients in this State as determined by applying uniform
6 measures of quality prescribed by the Department pursuant to
7 NRS 439A.250;

8 (c) How consistently each surgical center for ambulatory
9 patients follows recognized practices to prevent the infection of
10 patients, to speed the recovery of patients and to avoid medical
11 complications of patients;

12 (d) For each surgical center for ambulatory patients, the total
13 number of patients discharged and the average billed charges,
14 reported for 50 medical treatments for outpatients that the
15 Department determines are most useful for consumers; ~~and~~

16 (e) *To the extent that money is available for that purpose, for
17 each surgical center for ambulatory patients, the name of each
18 physician who performed a surgical procedure in the surgical

- 29 (2) Nationally recognized; and
- 30 (3) Reported in a standard and reliable manner.

31 **Sec. 3.** NRS 439A.270 is hereby amended to read as follows:

32 439A.270 1. The Department shall establish and maintain an
33 Internet website that includes the information concerning the
34 charges imposed and the quality of the services provided by the
35 hospitals and surgical centers for ambulatory patients in this State as
36 required by the programs established pursuant to NRS 439A.220
37 and 439A.240. The information must:

38 (a) Include, for each hospital in this State, the ~~Total~~ :

39 (1) *Total* number of patients discharged, the average length
40 of stay and the average billed charges, reported for the 50 most
41 frequent diagnosis-related groups for inpatients and 50 medical
42 treatments for outpatients that the Department determines are most
43 useful for consumers; *and*

44 (2) *Name of each physician who performed a surgical
45 procedure in the hospital and the total number of surgical*

1 ***procedures performed by each physician in the hospital, reported
2 for the most frequent surgical procedures that the Department
3 determines are most useful for consumers if the information is
4 available;***

5 (b) Include, for each surgical center for ambulatory patients in
6 this State, the [total]:

7 (1) **Total** number of patients discharged and the average
8 billed charges, reported for 50 medical treatments for outpatients
9 that the Department determines are most useful for consumers; **and**

10 (2) **Name of each physician who performed a surgical
11 procedure in the surgical center for ambulatory patients and the
12 total number of surgical procedures performed by each physician
13 in the surgical center for ambulatory patients, reported for the
14 most frequent surgical procedures that the Department determines
15 are most useful for consumers;**

16 (c) Be presented in a manner that allows a person to view and
17 compare the information for the hospitals by:

- 18 (1) Geographic location of each hospital;
19 (2) Type of medical diagnosis; and
20 (3) Type of medical treatment;

21 (d) Be presented in a manner that allows a person to view and
22 compare the information for the surgical centers for ambulatory
23 patients by:

- 24 (1) Geographic location of each surgical center for
25 ambulatory patients;
26 (2) Type of medical diagnosis; and
27 (3) Type of medical treatment;

28 (e) Be presented in a manner that allows a person to view and
29 compare the information separately for:

- 30 (1) The inpatients and outpatients of each hospital; and
31 (2) The outpatients of each surgical center for ambulatory
32 patients;

33 (f) Be readily accessible and understandable by a member of the
34 general public;

35 (g) Include the annual summary of reports of sentinel events
36 prepared pursuant to paragraph (d) of subsection 1 of NRS 439.840;
37 and

38 (h) Provide any other information relating to the charges
39 imposed and the quality of the services provided by the hospitals
40 and surgical centers for ambulatory patients in this State which the
41 Department determines is:

- 42 (1) Useful to consumers;
43 (2) Nationally recognized; and
44 (3) Reported in a standard and reliable manner.

45 2. The Department shall:

- 1 (a) Publicize the availability of the Internet website;
- 2 (b) Update the information contained on the Internet website at
- 3 least quarterly;
- 4 (c) Ensure that the information contained on the Internet website
- 5 is accurate and reliable;
- 6 (d) Ensure that the information contained on the Internet website
- 7 is aggregated so as not to reveal the identity of a specific inpatient or
- 8 outpatient of a hospital;
- 9 (e) Post a disclaimer on the Internet website indicating that the
- 10 information contained on the website is provided to assist with the
- 11 comparison of hospitals and is not a guarantee by the Department or
- 12 its employees as to the charges imposed by the hospitals in this State
- 13 or the quality of the services provided by the hospitals in this State,
- 14 including, without limitation, an explanation that the actual amount
- 15 charged to a person by a particular hospital may not be the same
- 16 charge as posted on the website for that hospital;
- 17 (f) Provide on the Internet website established pursuant to this
- 18 section a link to the Internet website of the Centers for Medicare and
- 19 Medicaid Services of the United States Department of Health and
- 20 Human Services; and
- 21 (g) Upon request, make the information that is contained on the
- 22 Internet website available in printed form.
- 23 3. As used in this section, "diagnosis-related group" means
- 24 groupings of medical diagnostic categories used as a basis for
- 25 hospital payment schedules by Medicare and other third-party health
- 26 care plans.
