## SENATE BILL NO. 421–COMMITTEE ON LEGISLATIVE OPERATIONS AND ELECTIONS

## MARCH 23, 2015

Referred to Committee on Legislative Operations and Elections

SUMMARY—Makes various changes relating to political parties and presidential preference primary elections. (BDR 24-1148)

FISCAL NOTE: Effect on Local Government: May have Fiscal Impact. Effect on the State: Yes.

EXPLANATION - Matter in *bolded italics* is new; matter between brackets {omitted material} is material to be omitted.

AN ACT relating to elections; making various changes relating to political parties and presidential preference primary elections; revising provisions governing the organization and operation of major political parties; providing in certain circumstances for a presidential preference primary election to be held for each major political party; establishing certain requirements and procedures for conducting a presidential preference primary election; requiring delegates to a national party convention to vote according to the results of the state party's presidential preference process in certain circumstances; providing penalties; and providing other matters properly relating thereto.

## Legislative Counsel's Digest:

Under existing law, a major political party must: (1) hold precinct meetings in
 each county; (2) select delegates to the county, state and national party conventions;
 (3) provide certain types of notice regarding its meetings and conventions; and (4)
 follow certain procedural requirements when conducting its affairs. (NRS 293.130 293.163) Sections 3.5-6 of this bill revise various aspects of the organization and
 operation of major political parties.
 Sections 3.5 and 4 authorize major political parties to adopt rules for providing
 notice of meetings and conventions through an Internet website or other social

7 Sections 3.5 and 4 authorize major political parties to adopt rules for providing 8 notice of meetings and conventions through an Internet website or other social 9 media. Section 4 also provides that precinct meetings may be consolidated or held 10 for the county at large. Section 5 allows delegates to be selected through a 11 nomination process instead of being selected at precinct meetings and permits the 12 county central committee to provide for forms to be prepared and delivered





13 electronically. Section 6 provides that until the end of the first ballot at the national 14 party convention, the state party's delegates are bound to vote at each stage of the 15 presidential nomination process according to the results of the state party's 16 presidential preference process.

17 Sections 1-2.5, 31.1-38 and 42 of this bill provide, with certain exceptions, for a statewide presidential preference primary election to be held for each major 18 19 political party on the last Tuesday in February of a presidential election year. 20 21 22 23 24 25 26 27 28 30 31 32 33 4 35 36 37 38 Section 32 provides that a presidential preference primary election is generally governed by the same statutory provisions applicable to the existing statewide primary, except that the specific provisions of sections 31.1-38 and any regulations adopted by the Secretary of State to carry out those provisions take precedence and control if there is any conflict. Pursuant to section 33, a major political party may opt out of a presidential preference primary election. Such an election must be held for a major political party if: (1) the chair of the national committee of that party does not timely notify the Secretary of State that the party wants to opt out of the election; and (2) two or more qualified candidates of that party timely file declarations of candidacy for the election with the Secretary of State.

Sections 35-38 establish certain requirements and procedures for conducting a presidential preference primary election. In particular, section 35 specifies which registered voters are entitled to cast a ballot at the election, and section 36 states that local election officials: (1) shall not distribute sample ballots or conduct early voting for the election; (2) shall permit voting by absent ballot and militaryoverseas ballot for the election; and (3) shall establish polling places for the election that must be open from 7 a.m. until 7 p.m. on the day of the election. Section 36 also provides that a registered voter in the county who is entitled to cast a ballot at the election may do so at any polling place in the county on the day of 39 the election. Finally, sections 37 and 42 provide that the cost of any presidential 40 preference primary election is a charge against the State and must be paid from the 41 Reserve for Statutory Contingency Account in the State General Fund.

## THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 293 of NRS is hereby amended by adding 2 thereto a new section to read as follows:

"Presidential preference primary election" means an election 3 held in a presidential election year pursuant to sections 31.1 to 38, inclusive, of this act to determine the preferences of the registered 4 5 voters of a major political party regarding the party's nominee for 6 7 President of the United States. 8

NRS 293.130 is hereby amended to read as follows: 5 293.130 1. All 39 40 persons registered in the party and residing in [the] your 41 precinct are entitled to attend the *precinct meeting. meeting* 42 regarding your precinct. Delegates to your party's county 43 convention will be elected at the meeting *regarding your* 44 *precinct* by those in attendance. (a) The date, time and place of the meeting; [and]

8 (b) The number of delegates to the county convention to be 9 chosen at the meeting [-]; and

10 (c) Any fees which may be charged to attend the county or 11 state convention.

Sec. 5. NRS 293.137 is hereby amended to read as follows:

13 293.137 1. [Promptly] Except as otherwise provided in 14 subsection 3, promptly at the time and place appointed therefor, the 15 [mass] meeting *regarding one or more precincts* must be convened and organized. [for each precinct.] If access to the premises 16 17 appointed for any such meeting is not available, the meeting may be 18 convened at an accessible place immediately adjacent thereto. The 19 meeting must be conducted openly and publicly and in such a 20 manner that it is freely accessible to any registered voter of the party calling the meeting who resides in one of the [precinct] precincts 21 22 and is desirous of attending the meeting, until the meeting is 23 adjourned. At the meeting, the delegates to which the members of 24 the party residing in *one of* the *precinct precincts* are entitled in 25 the party's county convention must be elected pursuant to the rules of the state central committee of **[that]** the party. In presidential 26 27 election years  $\square$  in which a presidential preference primary election is not held for the party, the election of delegates may be a 28 29 part of expressing preferences for candidates for the party's 30 nomination for President of the United States if the rules of the party 31 permit such conduct. The result of the election must be certified to 32 the county convention of the party by the chair and the secretary of 33 the meeting upon the forms specified in subsection  $\frac{13.1}{5}$ .

[At] Except as otherwise provided in subsection 3, at the 34 2. 35 precinct meetings, the delegates and alternates to the party's convention must be elected. If a meeting is not held for a particular 36 37 precinct at the location specified, that precinct must be without representation at the county convention unless the meeting was 38 scheduled, with proper notice, and no registered voter of the party 39 40 appeared. In that case, the meeting shall be deemed to have been 41 held and the position of delegate is vacant. If a position of delegate is vacant, it must be filled by the designated alternate, if any. If there 42 is no designated alternate, the vacancy must be filled pursuant to the 43 44 rules of the party, if the rules of the party so provide, or, if the rules 45 of the party do not so provide, the county central committee shall





1 appoint a delegate from among the qualified members of the party 2 residing in the precinct in which the vacancy occurred, and the secretary of the county central committee shall certify the appointed 3 4 delegate to the county convention.

5 3. If consistent with the rules of the party, the delegates and 6 alternates to the party's convention may be elected through a nomination process and may be chosen by precinct or at large. 7 The number of delegates elected may not exceed the number 8 9 authorized pursuant to NRS 293.133. In presidential election years in which a presidential preference primary election is held for 10 the party, the rules must reasonably reflect the results of the 11 presidential preference primary election. The results of the 12 13 nomination process must be certified to the county convention of 14 the party by the chair and the secretary overseeing the process 15 upon the forms specified in subsection 5.

16 4. If the county central committee elects to nominate 17 delegates and alternates to the party's convention pursuant to 18 subsection 3, the county central committee shall give notice of the 19 *nomination process. The notice:* 20

(a) May be given, without limitation, by:

(1) Publishing in one or more newspapers of general 21 22 circulation published in the precinct or county, if any; or

23 (2) If consistent with the rules of the party, posting on an 24 Internet website or other social media. 25

(b) Must include, without limitation: (1) The name of the party;

26 27

(2) The purpose of the nomination process;

28 (3) The process that will be used to elect delegates and 29 alternates:

30

(4) Any relevant dates, times or locations for the process;

31 (5) The number of delegates to be chosen; and

32 (6) Any fees which may be charged to attend the county or 33 state convention.

The county central committee shall prepare and number 34 5. 35 serially a number of certificate forms equal to the total number of delegates to be elected throughout the county, and deliver the 36 37 appropriate number to *leach precinct meeting. the precinct meetings.* Each certificate must be in duplicate. The original must 38 be given to the elected delegate, and the duplicate transmitted to the 39 40 county central committee. The county central committee may 41 provide for such forms to be prepared and delivered electronically 42 pursuant to the rules of the party.

43 All duplicates must be delivered to the chair of the <del>[4.]</del> 6. 44 preliminary credentials committee of the county convention. Every





1 delegate who presents a certificate matching one of the duplicates 2 must be seated without dispute.

[5.] 7. Each state central committee shall adopt written rules 3 governing, but not limited to, the following procedures: 4

5 (a) The selection, rights and duties of committees of a 6 convention: 7

(b) Challenges to credentials of delegates; and

8 9 (c) Majority and minority reports of committees. **Sec. 5.5.** NRS 293.143 is hereby amended to read as follows:

10 293.143 1. The county central committee of a major political 11 party to be elected by the county convention of the party must 12 consist of such number of members as may be determined by the 13 convention, but each voting precinct, entitled to one or more 14 delegates in the convention, is entitled to have at least one 15 committeeman or committeewoman and no precinct may have more 16 committeemen or committeewomen than its authorized number of 17 delegates to the county convention.

18 2. After the county convention of the party, the composition of the county central committee may be changed, and during a 19 presidential election year, must be changed, by the county central 20 21 committee to reflect changes in the organization of precincts and in 22 the number of registered voters of the party, using the same 23 standards adopted by the party to elect delegates to the county 24 convention.

25

**Sec. 6.** NRS 293.163 is hereby amended to read as follows:

26 293.163 1. In presidential election years, on the call of a 27 national party convention, but one set of party conventions and but 28 one state convention shall be held on such respective dates and at 29 such places as the state central committee of the party shall 30 designate. If no earlier dates are fixed, the state convention shall be 31 held 30 days before the date set for the national convention and the 32 county conventions shall be held 60 days before the date set for the 33 national convention.

34 2. Delegates to such conventions shall be selected in the same manner as prescribed in NRS 293.130 to 293.160, inclusive, and 35 36 each convention shall have and exercise all of the power granted it 37 under NRS 293.130 to 293.160, inclusive. In addition to such powers granted it, the state convention shall select the necessary 38 39 delegates and alternates to the national convention of the party and, 40 if consistent with the rules **[and regulations]** of the party, shall select 41 the national committeeman and committeewoman of the party from the State of Nevada. Any rules of the party governing the 42 election of delegates and alternates to the national convention of 43 44 the party, or directing the votes of delegates at the national





1 convention, must reasonably reflect the results of any presidential 2 preference primary election held for the party.

3 Until the end of the first ballot at the national convention 3. 4 of the party, a delegate or alternate to the national convention of the party is bound to vote at each stage of the presidential 5 6 nomination process at the national convention in accordance 7 with:

8 (a) The preference expressed by the members of the state party through any presidential preference process prescribed by NRS 9 293.130 to 293.160, inclusive, or any presidential preference 10 11 primary election held for the party; and 12

(b) Any rules of the party adopted pursuant to subsection 4.

13 The state central committee of the party shall adopt rules 4. 14 of the party to govern whether the delegates or alternates to the 15 national convention of the party are bound to vote:

(a) For the presidential candidate receiving the highest 16 17 percentage of votes during the presidential candidate selection 18 process; or

(b) In a proportional manner in relation to the presidential 19 20 preferences expressed during the presidential candidate selection 21 process.

22 5. If a delegate violates the provisions of subsection 3, the 23 delegate and the state party:

(a) Shall each pay to the candidate for whom the vote of the 24 25 delegate was bound, an amount equal to the fee paid by the 26 candidate to file with the state party; or

27 (b) If the candidate did not pay a fee to file with the state party, shall each pay a civil penalty in an amount not to exceed \$1,000 28 29 for each violation. This penalty must be recovered in a civil action 30 brought in the name of the State of Nevada by the Attorney General in a court of competent jurisdiction. Any civil penalty 31 collected pursuant to this section must be deposited by the 32 Attorney General for credit to the State General Fund in the bank 33 34 designated by the State Treasurer.

Except as otherwise provided in this section, a 5 presidential preference primary election for each party must be 6 held on the last Tuesday in February of a presidential election 7 year to determine the preferences of the registered voters of the 8 party regarding the party's nominee for President of the United 9 States.

2. If a party wants to opt out of a presidential preference 10 primary election, the chair of the national committee of the party 11 must so notify the Secretary of State in writing. Except as 12 13 otherwise provided in this subsection, the notice must be given by 14 certified mail and must be received by the Secretary of State not 15 later than 5 p.m. on October 25 of the year immediately preceding 16 the presidential election year. If October 25 is not a business day, the notice must be received by the Secretary of State not later than 17 5 p.m. of the last business day immediately preceding October 25. 18 Any such notice may be rescinded by a contrary notice given in the 19 manner required by this subsection and more than one notice may 20 be given, but the notice last received by the Secretary of State 21 22 before the deadline established by this subsection shall be deemed to be the operative notice for the purposes of this section. 23

24 3. If a party does not opt out of a presidential preference 25 primary election in the manner required by subsection 2 and:

26 (a) More than one qualified candidate of the party files a 27 declaration of candidacy pursuant to section 34 of this act, a 28 presidential preference primary election for the party must be held 29 pursuant to the provisions of sections 31.1 to 38, inclusive, of this 30 act.

(b) Only one qualified candidate or no qualified candidate of the party files a declaration of candidacy pursuant to section 34 of this act, a presidential preference primary election for the party must not be held. If only one qualified candidate of the party files a declaration of candidacy, the Secretary of State shall certify the name of the qualified candidate to:

(1) The state central committee; and

(2) The national committee if necessary to comply with the
 rules of the party.

40 Sec. 34. 1. If a person who is a qualified candidate to be a 41 party's nominee for President of the United States wants to appear 42 on the ballot for a presidential preference primary election that is 43 held for the party, the person must, not earlier than November 1 44 and not later than 5 p.m. on November 15 of the year immediately 45 preceding the presidential election year, file with the Secretary of





1 State a declaration of candidacy in the form prescribed by the 2 Secretary of State.

3 2. A person who files a declaration of candidacy pursuant to 4 this section is not required to file a declaration of candidacy or an 5 acceptance of candidacy pursuant to NRS 293.177.

6 Sec. 35. 1. If a presidential preference primary election is 7 held for a party, the Secretary of State shall forward to each 8 county clerk the name and mailing address of each qualified 9 candidate of the party whose name must appear on the ballot for 10 the presidential preference primary election for the party pursuant 11 to sections 33 and 34 of this act.

12 2. A registered voter may cast a ballot at a presidential 13 preference primary election for a party only if the registered voter 14 designated on his or her application to register to vote an 15 affiliation with the party. Such a registered voter may vote for only 16 one qualified candidate on the ballot for the party as the voter's 17 preference to be the nominee for President of the United States for 18 the party.

19 3. If a person who is not such a registered voter wants to 20 become a registered voter who may cast a ballot at a presidential 21 preference primary election for a party, the person must register to 22 vote and designate on his or her application to register to vote an 23 affiliation with the party in the manner and within the time 24 required by chapters 293 and 293D of NRS for a primary election.

25 Sec. 36. 1. In conducting a presidential preference primary 26 election that is held for a party, the county clerk:

27 (a) Shall not distribute sample ballots for the presidential 28 preference primary election.

(b) Shall not establish any polling places for early voting by
personal appearance for the presidential preference primary
election, and no registered voter of the party may request to vote
early for the presidential preference primary election.

(c) Shall permit voting by registered voters of the party by
absent ballot and military-overseas ballot for the presidential
preference primary election in the manner and within the time
required by chapters 293 and 293D of NRS for voting by absent
ballot and military-overseas ballot for a primary election.

(d) Shall establish polling places for voting by registered voters
of the party on the day of the presidential preference primary
election. The polling places must open at 7 a.m. and close at 7 p.m.
on the day of the presidential preference primary election.

42 2. A registered voter of the party who is a registered voter in 43 the county and who is entitled to cast a ballot at the presidential 44 preference primary election for the party may do so at any polling





place in the county on the day of the presidential preference 1 2 primary election. Sec. 37. The money in the Account must 27 be expended only for: (a) The payment of claims which are obligations of the State 28 29 pursuant to NRS 41.03435, 41.0347, 62I.025, 176.485, 179.310, 212.040, 212.050, 212.070, 281.174, 282.290, 282.315, 288.203, 30 293.253, 293.405, 353.120, 353.262, 412.154 and 475.235 H and 31 32 section 37 of this act; 33 (b) The payment of claims which are obligations of the State 34 pursuant to: 35 (1) Chapter 472 of NRS arising from operations of the Division of Forestry of the State Department of Conservation and 36 37 Natural Resources directly involving the protection of life and property; and 38 39 (2) NRS 7.155, 34.750, 176A.640, 179.225 and 213.153,  $\rightarrow$  except that claims may be approved for the respective purposes 40 41 listed in this paragraph only when the money otherwise appropriated 42 for those purposes has been exhausted; 43 (c) The payment of claims which are obligations of the State 44 pursuant to NRS 41.0349 and 41.037, but only to the extent that the



1 money in the Fund for Insurance Premiums is insufficient to pay the2 claims; and

3 (d) The payment of claims which are obligations of the State 4 pursuant to NRS 535.030 arising from remedial actions taken by the 5 State Engineer when the condition of a dam becomes dangerous to 6 the safety of life or property.

The State Board of Examiners may authorize its Clerk or a 7 3. person designated by the Clerk, under such circumstances as it 8 9 deems appropriate, to approve, on behalf of the Board, the payment of claims from the Reserve for Statutory Contingency Account. For 10 the purpose of exercising any authority granted to the Clerk of the 11 State Board of Examiners or to the person designated by the Clerk 12 13 pursuant to this subsection, any statutory reference to the State 14 Board of Examiners relating to such a claim shall be deemed to refer 15 to the Clerk of the Board or the person designated by the Clerk.
