AN ACT relating to modification of weather; making an appropriation to the State Department of Conservation and Natural Resources for the awarding of grants to support certain cloud seeding operations; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

- 1 This bill makes an appropriation of \$500,000 to the State Department of  
2 Conservation and Natural Resources to award grants to support cloud seeding  
3 operations which are intended to increase the supply of water in Nevada.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State  
2 General Fund to the State Department of Conservation and Natural  
3 Resources the sum of \$500,000 to be used by the Department to  
4 award grants to support cloud seeding operations which are intended  
5 to increase the supply of water in Nevada.  
6 2. The recipient of any grant awarded pursuant to subsection 1:



1 (a) Must be an agency of this State or any business entity or  
2 other group of persons with the necessary equipment, experience  
3 and ability to conduct successful cloud seeding operations; and

4 (b) May be licensed pursuant to NRS 544.140.

5 3. In awarding a grant pursuant to subsection 1, the Department  
6 shall give preference to an applicant who offers any matching funds.

7 **Sec. 2.** The State Department of Conservation and Natural  
8 Resources shall, on or before January 1, 2017, submit to the  
9 Director of the Legislative Counsel Bureau for transmittal to the  
10 Legislature, a report concerning any grants awarded pursuant to this  
11 section, including, without limitation, the amount of money granted  
12 and the results, if any, of those grants.

13 **Sec. 3.** Any remaining balance of the appropriation made by  
14 section 1 of this act must not be committed for expenditure after  
15 June 30, 2017, by the State Department of Conservation and Natural  
16 Resources or any entity to which money from the appropriation is  
17 granted or otherwise transferred in any manner, and any portion of  
18 the appropriated money remaining must not be spent for any  
19 purpose after September 15, 2017, by either the State Department of  
20 Conservation and Natural Resources or the entity to which the  
21 money was subsequently granted or transferred, and must be  
22 reverted to the State General Fund on or before September 15, 2017.

23 **Sec. 4.** This act becomes effective on July 1, 2015.
