SUMMARY—Revises provisions relating to physical therapy.  
(BDR 54-483)

EXPLANATION – Matter in *bolded italics* is new; matter between brackets ~~omitted material~~ is material to be omitted.

AN ACT relating to physical therapy; changing the name of the State Board of Physical Therapy Examiners to the Nevada Physical Therapy Board; authorizing the Board to appoint nonvoting advisory members to the Board; authorizing the Board to issue citations for certain violations; changing the designation of physical therapists' assistants and physical therapists' technicians; revising the membership and duties of the Board; requiring the Board to elect certain officers annually; amending provisions governing the supervision and authorized activities of physical therapist technicians; revising provisions governing the supervision of physical therapist assistants; exempting certain providers of health care from the provisions governing the practice of physical therapy; revising terminology concerning the education of physical therapists and physical therapist assistants; combining similar provisions governing physical therapists and physical therapist assistants; authorizing the licensure by endorsement of physical therapist assistants; removing the requirement that the Board administer an examination to applicants for a license as a physical therapist; revising provisions prohibiting the use of certain names, titles and initials related to the practice of physical therapy; providing penalties; and providing other matters properly relating thereto.

**Legislative Counsel's Digest:**

1 Existing law establishes the State Board of Physical Therapy Examiners to  
2 regulate physical therapists and physical therapist assistants. (NRS 640.030)  
3 **Section 29** of this bill repeals the requirement of existing law that the Board itself  
4 examine applicants for licensure as physical therapists, but **sections 10 and 23** of  
5 this bill leave in place existing requirements that applicants for licensure as  
6 physical therapists or physical therapist assistants pass an examination designated  
7 by the Board. (NRS 640.080, 640.230) **Section 1.5** of this bill changes the name of  
8 the Board to the Nevada Physical Therapy Board to reflect that the Board no longer  
9 administers, but merely designates, the examinations.

10 **Sections 1.2 and 4** of this bill authorize the Board to appoint nonvoting  
11 advisory members. Additionally, **section 4**: (1) revises the membership of the  
12 Board to include a physical therapist assistant; and (2) clarifies that the Board is  
13 subject to the provisions of law governing meetings of public bodies. **Section 5** of  
14 this bill requires the Board to elect new officers annually and specifies the officers  
15 whom the Board is required to elect. **Section 6** of this bill clarifies that only voting  
16 members of the Board are entitled to compensation. **Section 7** of this bill revises  
17 the duties of the Board. **Section 9** of this bill removes a requirement that the Board  
18 deposit administrative fines with the State Treasurer for credit in the State General  
19 Fund and instead requires the Board to deposit such fines directly in the State  
20 General Fund.

21 Existing law authorizes the Board to impose disciplinary action, after notice  
22 and a hearing, against a licensee who commits certain violations. (NRS 640.160)  
23 **Section 1.3** of this bill authorizes the Board to issue a citation for certain violations  
24 of statute or regulation. **Section 1.4** of this bill allows a person to whom a citation  
25 has been issued to contest the citation in a hearing conducted according to the  
26 provisions of law governing contested cases.

27 Existing law exempts from the law governing the licensure and regulation of  
28 physical therapists an occupational therapist, occupational therapy assistant and  
29 athletic trainer who is licensed to practice his or her profession in this State,  
30 practices within the scope of his or her profession and does not represent that he or  
31 she is a physical therapist or physical therapist assistant or is practicing physical  
32 therapy. (NRS 640.029) **Section 3** of this bill extends this exemption to any  
33 provider of health care who is licensed to practice his or her profession in this State,  
34 who acts within the scope of his or her profession and who does not represent that  
35 he or she is a physical therapist or physical therapist assistant or is practicing  
36 physical therapy.

37 Existing law authorizes the Board to adopt regulations concerning treatments  
38 and other regulated procedures which may be performed by a physical therapist  
39 technician. (NRS 640.050) A physical therapist must provide immediate  
40 supervision of a physical therapist technician while the technician performs  
41 treatments related to physical therapy. (NRS 640.310) **Sections 7 and 26** of this bill  
42 instead require the Board to adopt regulations prescribing the activities that a  
43 physical therapist technician may perform only under the immediate supervision of  
44 a physical therapist. **Section 1.6** of this bill clarifies that a physical therapist who is  
45 supervising a physical therapist technician must be present on-site.

46 **Section 1.7** of this bill clarifies the definition of the term "physical therapist."  
47 **Sections 1.8, 1.9, 2.5-4, 7, 18, 19, 21 and 23-26** of this bill standardize the  
48 terminology used to refer to physical therapist assistants and physical therapist  
49 technicians.

50 Existing law requires an applicant for a license as a physical therapist or  
51 physical therapist assistant to have completed an educational curriculum approved  
52 by the Board. (NRS 640.080, 640.230) **Sections 10 and 23** of this bill instead  
53 require the applicant to have completed a program of professional education for



54 physical therapists or physical therapist assistants, as applicable, that has been  
55 approved by the Board.

56 Existing law provides similar procedures for licensing physical therapists and  
57 physical therapist assistants. (NRS 640.090-640.110, 640.150, 640.250-640.270,  
58 640.280) Existing law also authorizes a person to: (1) obtain a temporary license to  
59 practice as a physical therapist or physical therapist assistant to assist in a medical  
60 emergency without examination; and (2) work without a license under the  
61 supervision of a physical therapist while satisfying clinical education requirements.  
62 (NRS 640.120, 640.275) **Sections 11-14, 17 and 29** of this bill combine and  
63 remove the duplication of those provisions.

64 Existing law prescribes the requirements for licensure by endorsement of a  
65 physical therapist who is licensed in another state. (NRS 640.145, 640.146)  
66 **Sections 15 and 16** of this bill extend those provisions to physical therapist  
67 assistants. **Section 29** repeals duplicative provisions authorizing the Board to  
68 license without examination a physical therapist or physical therapist assistant who  
69 is licensed in another state.

70 Existing law provides that a person who does not hold a license issued by the  
71 Board is guilty of a misdemeanor if he or she practices physical therapy or holds  
72 himself or herself out as a physical therapist or physical therapist assistant. (NRS  
73 640.169, 640.170, 640.175) **Section 20** of this bill provides that a business entity  
74 that holds itself out as providing services constituting the practice of physical  
75 therapy is guilty of a misdemeanor unless those services are provided by or under  
76 the supervision of a licensed physical therapist. **Sections 20 and 21** of this bill  
77 further authorize the Board to impose certain penalties on a person who violates  
78 this provision, including, without limitation, an administrative penalty of not more  
79 than \$5,000. Finally, **sections 20 and 21** require physical therapists and physical  
80 therapist assistants to use a certain designation.

81 Existing law authorizes the Board to seek an injunction in district court against  
82 a person who has engaged or is about to engage in an act that violates or will  
83 violate a provision of existing law governing physical therapists. (NRS 640.210)  
84 **Section 22** of this bill provides that if the Board is seeking an injunction against a  
85 person improperly holding himself or herself out as a licensed physical therapist or  
86 physical therapist assistant or as practicing physical therapy, the Board must only  
87 show that the person violated existing law to establish that immediate and  
88 irreparable injury, loss or damage will result from the person's continued action.

- 42 **Sec. 1.2.** *The Board may, by majority vote, select any person,*
- 43 *including, without limitation, a physical therapist or physical*
- 44 *therapist assistant, to serve as an advisory member of the Board.*
- 45 *The Board shall prescribe the term and duties of any advisory*



1 *member it selects pursuant to this section. An advisory member*  
2 *may not vote on any matter before the Board. Advisory members*  
3 *serve without compensation.*

4 **Sec. 1.3.** *1. After conducting an inspection pursuant to*  
5 *NRS 640.050, a member or agent of the Board may issue a citation*  
6 *to a licensee if the member or agent concludes that, based on a*  
7 *preponderance of the evidence, the licensee has violated:*

8 *(a) Subsection 3 of NRS 640.110;*

9 *(b) Any regulation of the Board that requires a licensee to*  
10 *provide his or her address to the Board, display his or her license*  
11 *or a copy thereof, practice only under the name listed on his or her*  
12 *license or document in the record of a patient any treatment*

14 *(c) Any regulation of the Board establishing requirements for*  
15 *the supervision of an unlicensed person by a physical therapist or*  
16 *limiting the number of persons who may be supervised by a*

18 *2. A citation issued pursuant to this section may include,*  
19 *without limitation, an order to:*

20 *(a) Take action to correct any condition resulting from any act*  
21 *that constitutes a violation of a provision set forth in subsection 1,*  
22 *at the cost of the person who committed the violation. If the*  
23 *citation contains such an order, the citation must:*

24 *(1) State the time permitted for compliance, which must be*  
25 *not less than 5 business days after the date the person receives the*  
26 *citation; and*

27 *(2) Specifically describe the corrective action to be taken.*

28 *(b) Pay an administrative fine not to exceed the amount*  
29 *prescribed pursuant to subsection 3.*

30 *(c) Reimburse the Board for any expenses incurred to*  
31 *investigate the violation, in an amount not to exceed \$150.*

32 *3. Any administrative fine imposed pursuant to this section*  
33 *must be:*

34 *(a) For a first violation, in the amount prescribed by*  
35 *regulation of the Board, which must be not less than \$100 or more*  
36 *than \$500;*

37 *(b) For a second violation, in the amount prescribed by*  
38 *regulation of the Board, which must be not less than \$250 or more*  
39 *than \$1,000; and*

40 *(c) For a third violation and for each additional violation, in*  
41 *the amount determined by the Board after the licensee appears*  
42 *before the Board.*

43 *4. The sanctions authorized by this section are separate from,*  
44 *and in addition to, any other remedy, civil or criminal, authorized*  
45 *by this chapter.*



1       **Sec. 1.4. 1.** *Except as otherwise provided in this subsection,*  
2 *to contest a citation issued pursuant to section 1.3 of this act, the*  
3 *person must submit a written request for a hearing to the Board*  
4 *not later than 30 days after the date of issuance of the citation.*  
5 *The Board may, for good cause shown, extend the time to submit a*  
6 *request for a hearing.*

7       **2.** *If the person to whom a citation is issued files a timely*  
8 *written request for a hearing to contest the citation:*

9       **(a)** *The Board shall provide notice of and conduct the hearing*  
10 *in accordance with this chapter and the provisions of chapters*  
11 *233B and 622A of NRS governing the adjudication of contested*  
12 *cases.*

13       **(b)** *At the hearing, the licensee may contest, without*  
14 *limitation:*

15       **(1)** *The facts forming the basis for the determination that*  
16 *the licensee has committed an act which constitutes a violation of*  
17 *a provision described in section 1.3 of this act;*

18       **(2)** *The time allowed to take any corrective action ordered;*

19       **(3)** *The amount of any administrative fine ordered;*

20       **(4)** *The amount of any payment ordered to reimburse the*  
21 *Board for the expenses incurred to investigate the violation; and*

22       **(5)** *Whether any corrective action described in the citation*  
23 *is reasonable.*

24       **3.** *If a person to whom a citation is issued pursuant to section*  
25 *1.3 of this act does not file timely a written request for a hearing to*  
26 *contest the citation, the citation shall be deemed a final order of*  
27 *the Board and any assessed fine deemed due and payable and any*  
28 *corrective action deemed required.*

29       **4.** *For the purposes of this section, a citation issued pursuant*  
30 *to section 1.3 of this act shall be deemed to have been received by a*  
31 *person:*

32       **(a)** *On the date on which the citation is personally delivered to*  
33 *the person; or*

34       **(b)** *If the citation is mailed, 3 business days after the date on*  
35 *which the citation is mailed by certified mail to the last known*  
36 *business or residential address of the person.*

40 6. Any member or agent of the Board may enter any premises

44 premises* to determine whether a violation of any provision of this  
45 chapter *or any regulation adopted pursuant thereto* has occurred,



1 including, without limitation, an inspection to determine whether  
2 any person at the premises is practicing physical therapy or as a  
3 physical ~~{therapist's}~~ *therapist* assistant without the appropriate  
4 license issued pursuant to the provisions of this chapter.

5 7. Any *voting* member of the Board may administer an oath to  
6 a person testifying in a matter that relates to the duties of the Board.
