SUMMARY—Revises provisions relating to recall elections.
(BDR 24-71)

AN ACT relating to elections; revising the provisions relating to the verification of signatures on a petition for recall of a public officer; establishing a limit on contributions to the campaign of a candidate in a recall election; requiring the disposal of unspent contributions to a candidate at a recall election; revising provisions relating to a request to remove a signature from a petition to recall a public officer; amending the deadline for filing a legal challenge to the sufficiency of a petition to recall a public officer; imposing civil and criminal penalties for violations of provisions governing recall elections; and providing other matters properly relating thereto.

Legislative Counsel’s Digest:

The Nevada Constitution provides for the right of the registered voters of the State of Nevada to recall a public officer and sets forth a procedure for exercising that right, including a requirement to file a petition to demand the recall and a formula for determining the number of signatures of registered voters that is required to appear on the petition to force the recall election. The Constitution also provides that “[s]uch additional legislation as may aid the operation of this section shall be provided by law.” (Nev. Const. Art. 2, § 9) The Legislature has enacted provisions to aid the operation of the registered voters’ right to recall a public officer. (Chapter 306 of NRS) This bill makes various changes to such provisions.

Under existing law, if the Secretary of State finds that the total number of signatures submitted to all county clerks on a petition to recall a public officer is



12 100 percent or more of the number of registered voters needed to declare the
13 petition sufficient, with limited exception, each of the county clerks is required to
14 examine the signatures by sampling them at random for verification. The random
15 sampling must include an examination of at least 500 or 5 percent of the signatures,
16 whichever is greater. Upon completion of the random sampling, each county clerk
17 is required to file a certificate with the Secretary of State that includes the tally of
18 signatures. (NRS 293.1277) If the Secretary of State determines based on the
19 certificates from all of the relevant county clerks that the petition to recall a public
20 officer contains a number of valid signatures equal to 90 percent or more but less
21 than 100 percent of the number of registered voters needed to make the petition
22 sufficient, the Secretary of State is required to order the county clerks to verify all
23 signatures. (NRS 293.1278, 293.1279)

24 **Sections 2, 4 and 22** of this bill: (1) eliminate the random sampling of a
25 petition for the recall of a public officer; (2) require, instead, that each county clerk
26 examine every signature for verification; and (3) give the county clerks 20 days,
27 excluding weekends and holidays, to conduct such verification.

28 **Section 17** of this bill requires a person who submits a petition for the recall of
29 a public officer to pay the costs for the Secretary of State and county clerks to
30 verify signatures on the petition.

31 Existing law sets forth limitations on making, soliciting and accepting a
32 campaign contribution for a primary or general election. (Nev. Const. Art. 2, §10;
33 NRS 294A.100) **Section 6** of this bill: (1) establishes a contribution limitation of
34 \$5,000 for a special election to recall a public officer; and (2) sets forth the period
35 during which such contributions may be made, solicited or accepted. **Section 7** of
36 this bill provides that a contribution for a special election to recall a public officer
37 does not affect the limitations on contributions to candidates for a primary or
38 general election.

39 Existing law requires a candidate who is elected to office to dispose of unspent
40 contributions in various ways, including using the money in the candidate's next
41 election. A candidate who is not elected to office must dispose of unspent
42 contributions but is not allowed to use the money as a candidate in a future election.
43 (NRS 294A.160) **Section 10** of this bill requires every candidate for office at a
44 special election to recall a public officer to dispose of unspent contributions and
45 prohibits any such candidate from using the money in a future election. **Section 11**
46 of this bill requires such a candidate to submit a report to the Secretary of State
47 setting forth how he or she disposed of unspent contributions.

48 Existing law authorizes a person who signs a petition for the recall of a public
49 officer to submit: (1) a request to the county clerk to remove the person's name
50 from the petition before the petition is submitted for verification; and (2) a request
51 to the Secretary of State to remove the person's name from the petition after the
52 completion of signature verification. (NRS 306.015, 306.040) **Section 20** of this
53 bill authorizes a person to submit a request to the county clerk to remove the
54 person's name from the petition at any time before the signature verification is
55 completed. **Section 23** of this bill authorizes a person to submit to the filing officer
56 a request to remove the person's name from the petition after the signature
57 verification is completed.

58 Existing law authorizes a person to file a complaint challenging the legal
59 sufficiency of a petition to recall a public officer not more than 5 days after the
60 Secretary of State notifies the county clerk, filing officer and public officer who is
61 the subject of the petition that the petition contains a sufficient number of
62 signatures. (NRS 306.040) **Section 23** amends the deadline for filing such a
63 complaint to not later than 15 days, Saturdays, Sundays and holidays excluded,
64 after such notification.

65 Existing law provides that a person is guilty of a misdemeanor for
66 misrepresenting the intent or content of a petition for the recall of a public officer.



67 (NRS 306.025) **Section 21** of this bill increases the penalty to a category E felony,
68 punishable by a minimum term of not less than 1 year and a maximum term of not
69 more than 4 years in prison. **Section 18** of this bill provides that it is also a category
70 E felony for a person to knowingly or negligently obtain a false signature on a
71 petition for the recall of a public officer. **Section 19** of this bill sets forth certain
72 civil penalties for violations of the provisions of law relating to a petition for the
73 recall of a public officer.

74 **Section 24** of this bill declares void certain regulations that would conflict with
75 the amendatory provisions of this bill.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 293.127565 is hereby amended to read as
2 follows:

3 293.127565 1. At each building that is open to the general
4 public and occupied by the government of this State or a political
5 subdivision of this State or an agency thereof, other than a building
6 of a public elementary or secondary school, an area must be
7 designated for the use of any person to gather signatures on a
8 petition at any time that the building is open to the public. The area
9 must be reasonable and may be inside or outside of the building.
10 Each public officer or employee in control of the operation of a
11 building governed by this subsection shall:

12 (a) Designate the area at the building for the gathering of
13 signatures; and

14 (b) On an annual basis, submit to the Secretary of State and the
15 county clerk for the county in which the building is located a notice
16 of the area at the building designated for the gathering of signatures
17 on a petition. The Secretary of State and the county clerks shall
18 make available to the public a list of the areas at public buildings
19 designated for the gathering of signatures on a petition.

20 2. Before a person may use an area designated pursuant to
21 subsection 1, the person must notify the public officer or employee
22 in control of the operation of the building governed by subsection 1
23 of the dates and times that the person intends to use the area to
24 gather signatures on a petition. The public officer or employee may
25 not deny the person the use of the area.

26 3. Not later than 3 working days after the date of the decision
27 that aggrieved the person, a person aggrieved by a decision made by
28 a public officer or employee pursuant to subsection 1 or 2 may
29 appeal the decision to the Secretary of State. The Secretary of State
30 shall review the decision to determine whether the public officer or
31 employee violated subsection 1 or 2. If the Secretary of State
32 determines a public officer or employee violated subsection 1 or 2
33 and that a person was denied the use of a public building for the



1 purpose of gathering signatures on a petition, the Secretary of State
2 shall order that the deadline for filing the petition provided pursuant
3 to NRS 293.128, 293.172, 293.200, 295.056, 298.109, ~~306.035~~
4 **306.015** or 306.110 must be extended for a period equal to the time
5 that the person was denied the use of a public building for the
6 purpose of gathering signatures on a petition, but in no event may
7 the deadline be extended for a period of more than 5 days.

8 4. The decision of the Secretary of State is a final decision for
9 the purposes of judicial review. Not later than 7 days after the date
10 of the decision by the Secretary of State, the decision of the
11 Secretary of State may only be appealed in the First Judicial District
12 Court. If the First Judicial District Court determines that the public
13 officer or employee violated subsection 1 or 2 and that a person was
14 denied the use of a public building for the purpose of gathering
15 signatures on a petition, the Court shall order that the deadline for
16 filing the petition provided pursuant to NRS 293.128, 293.172,
17 293.200, 295.056, 298.109, ~~306.035~~ **306.015** or 306.110 must be
18 extended for a period equal to the time that the person was denied
19 the use of a public building for the purpose of gathering signatures
20 on a petition, but in no event may the deadline be extended for a
21 period of more than 5 days.

22 5. The Secretary of State may adopt regulations to carry out the
23 provisions of subsection 3.

24 **Sec. 2.** NRS 293.1277 is hereby amended to read as follows:

25 293.1277 1. If the Secretary of State finds that the total
26 number of signatures submitted to all the county clerks is 100
27 percent or more of the number of registered voters needed to declare
28 the petition sufficient, the Secretary of State shall immediately so
29 notify the county clerks. After the notification, each of the county
30 clerks shall determine the number of registered voters who have
31 signed the documents submitted in the county clerk's county and, in
32 the case of a petition for initiative or referendum proposing a
33 constitutional amendment or statewide measure, shall tally the
34 number of signatures for each petition district contained or fully
35 contained within the county clerk's county. This determination must
36 be completed within 9 days, excluding Saturdays, Sundays and
37 holidays, after the notification pursuant to this subsection regarding
38 a petition containing signatures which are required to be verified
39 pursuant to NRS 293.128, 295.056, 298.109 ~~306.035~~ or 306.110,
40 *within 20 days, excluding Saturdays, Sundays and holidays, after*
41 *the notification pursuant to this subsection regarding a petition*
42 *containing signatures which are required to be verified pursuant*
43 *to NRS 306.035, and within 3 days, excluding Saturdays, Sundays*
44 *and holidays, after the notification pursuant to this subsection*
45 regarding a petition containing signatures which are required to be



1 verified pursuant to NRS 293.172 or 293.200. For the purpose of
2 verification pursuant to this section, the county clerk shall not
3 include in his or her tally of total signatures any signature included
4 in the incorrect petition district.

5 2. Except as otherwise provided in ~~[subsection]~~ **subsections 3**
6 **[H]** **and 4**, if more than 500 names have been signed on the
7 documents submitted to a county clerk, the county clerk shall
8 examine the signatures by sampling them at random for verification.
9 The random sample of signatures to be verified must be drawn in
10 such a manner that every signature which has been submitted to the
11 county clerk is given an equal opportunity to be included in the
12 sample. The sample must include an examination of at least 500 or 5
13 percent of the signatures, whichever is greater. If documents were
14 submitted to the county clerk for more than one petition district
15 wholly contained within that county, a separate random sample must
16 be performed for each petition district.

17 3. If a petition district comprises more than one county and the
18 petition is for an initiative or referendum proposing a constitutional
19 amendment or a statewide measure, and if more than 500 names
20 have been signed on the documents submitted for that petition
21 district, the appropriate county clerks shall examine the signatures
22 by sampling them at random for verification. The random sample of
23 signatures to be verified must be drawn in such a manner that every
24 signature which has been submitted to the county clerks within the
25 petition district is given an equal opportunity to be included in the
26 sample. The sample must include an examination of at least 500 or 5
27 percent of the signatures presented in the petition district, whichever
28 is greater. The Secretary of State shall determine the number of
29 signatures that must be verified by each county clerk within the
30 petition district.

31 4. *If a petition is for the recall of a public officer circulated*
32 *pursuant to NRS 306.035, each county clerk shall:*

33 *(a) Examine for verification every signature on the documents*
34 *submitted to the county clerk; and*

35 *(b) When determining the total number of valid signatures on*
36 *the documents, remove each name of a registered voter who*
37 *submitted a request to have his or her name removed from the*
38 *petition pursuant to NRS 306.015.*

39 5. In determining from the records of registration the number
40 of registered voters who signed the documents, the county clerk may
41 use the signatures contained in the file of applications to register to
42 vote. If the county clerk uses that file, the county clerk shall ensure
43 that every application in the file is examined, including any
44 application in his or her possession which may not yet be entered
45 into the county clerk's records. Except as otherwise provided in



1 subsection ~~[5.]~~ 6, the county clerk shall rely only on the appearance
2 of the signature and the address and date included with each
3 signature in making his or her determination.

4 ~~[5.]~~ 6. If:

5 (a) Pursuant to NRS 293.506, a county clerk establishes a
6 system to allow persons to register to vote by computer; or

7 (b) A person registers to vote pursuant to NRS 293D.230 and
8 signs his or her application to register to vote using a digital
9 signature or an electronic signature,

10 ↪ the county clerk may rely on such other indicia as prescribed by
11 the Secretary of State in making his or her determination.

12 ~~[6.]~~ 7. In the case of a petition for initiative or referendum
13 proposing a constitutional amendment or statewide measure, when
14 the county clerk is determining the number of registered voters who
15 signed the documents from each petition district contained fully or
16 partially within the county clerk's county, he or she must use the
17 statewide voter registration list available pursuant to NRS 293.675.

18 ~~[7.]~~ 8. Except as otherwise provided in subsection ~~[9.]~~ 10,
19 upon completing the examination, the county clerk shall
20 immediately attach to the documents a certificate properly dated,
21 showing the result of the examination, including the tally of
22 signatures by petition district, if required, and transmit the
23 documents with the certificate to the Secretary of State. In the case
24 of a petition for initiative or referendum proposing a constitutional
25 amendment or statewide measure, if a petition district comprises
26 more than one county, the appropriate county clerks shall comply
27 with the regulations adopted by the Secretary of State pursuant to
28 this section to complete the certificate. A copy of this certificate
29 must be filed in the clerk's office. When the county clerk transmits
30 the certificate to the Secretary of State, the county clerk shall notify
31 the Secretary of State of the number of requests to remove a name
32 received by the county clerk pursuant to NRS 295.055. ~~[or 306.015-~~

33 ~~—8.]~~ 9. A person who submits a petition to the county clerk
34 which is required to be verified pursuant to NRS 293.128, 293.172,
35 293.200, 295.056, 298.109, 306.035 or 306.110 must be allowed to
36 witness the verification of the signatures. A public officer who is the
37 subject of a recall petition must also be allowed to witness the
38 verification of the signatures on the petition.

39 ~~[9.]~~ 10. For any petition containing signatures which are
40 required to be verified pursuant to the provisions of NRS 293.200,
41 306.035 or 306.110 for any county, district or municipal office
42 within one county, the county clerk shall not transmit to the
43 Secretary of State the documents containing the signatures of the
44 registered voters.



1 ~~HO~~ **II.** The Secretary of State shall by regulation establish
2 further procedures for carrying out the provisions of this section.

3 **Sec. 3.** NRS 293.1278 is hereby amended to read as follows:

4 293.1278 1. If the certificates received by the Secretary of
5 State from all the county clerks establish that the number of valid
6 signatures is less than 90 percent of the required number of
7 registered voters, the petition shall be deemed to have failed to
8 qualify, and the Secretary of State shall immediately so notify the
9 petitioners and the county clerks.

10 2. If those certificates establish that the number of valid
11 signatures is equal to or more than the sum of 100 percent of the
12 number of registered voters needed to make the petition sufficient
13 plus the total number of requests to remove a name received by the
14 county clerks pursuant to NRS 295.055 ~~for 306.015~~ and, in the case
15 of a petition for initiative or referendum proposing a constitutional
16 amendment or statewide measure, that the petition has the minimum
17 number of signatures required for each petition district, the petition
18 shall be deemed to qualify as of the date of receipt by the Secretary
19 of State of those certificates, and the Secretary of State shall
20 immediately so notify the petitioners and the county clerks.

21 3. If the certificates establish that the petitioners have 100
22 percent or more of the number of registered voters needed to make
23 the petition sufficient but the petition fails to qualify pursuant to
24 subsection 2, each county clerk who received a request to remove a
25 name pursuant to NRS 295.055 ~~for 306.015~~ shall remove each
26 name as requested, amend the certificate and transmit the amended
27 certificate to the Secretary of State. If the amended certificates
28 establish that the petitioners have 100 percent or more of the number
29 of registered voters needed to make the petition sufficient and, in the
30 case of a petition for initiative or referendum proposing a
31 constitutional amendment or statewide measure, that the petition has
32 the minimum number of signatures required for each petition
33 district, the petition shall be deemed to qualify as of the date of
34 receipt by the Secretary of State of the amended certificates, and the
35 Secretary of State shall immediately so notify the petitioners and the
36 county clerks.

37 **Sec. 4.** NRS 293.1279 is hereby amended to read as follows:

38 293.1279 1. ~~HH~~ *Except for a petition to recall a public*
39 *officer submitted pursuant to NRS 306.015, if* the statistical
40 sampling *of a petition* shows that the number of valid signatures
41 filed is 90 percent or more, but less than the sum of 100 percent of
42 the number of signatures of registered voters needed to declare the
43 petition sufficient plus the total number of requests to remove a
44 name received by the county clerks pursuant to NRS 295.055 , ~~for~~
45 ~~306.015,~~ the Secretary of State shall order the county clerks to



1 examine the signatures for verification. The county clerks shall
2 examine the signatures for verification until they determine that 100
3 percent of the number of signatures of registered voters needed to

16 requests to remove a name received by the county clerk in that
17 county pursuant to NRS 295.055, ~~for 306.015,~~ the Secretary of
18 State may order the county clerk in that county to examine every
19 signature for verification. If the county clerk received a request to
20 remove a name pursuant to NRS 295.055, ~~for 306.015,~~ the county
21 clerk may not determine that 100 percent or more of the number of

17 certificate must be filed in the county clerk's office. In the case of a
18 petition for initiative or referendum to propose a constitutional
19 amendment or statewide measure, if a petition district comprises
20 more than one county, the county clerks shall comply with the
21 regulations adopted by the Secretary of State pursuant to this section
22 to complete the amended certificate.

23 5. For any petition containing signatures which are required to
24 be verified pursuant to the provisions of NRS 293.200, 306.035 or
25 306.110 for any county, district or municipal office within one
26 county, the county clerk shall not forward to the Secretary of State
27 the documents containing the signatures of the registered voters.

28 6. Except for a petition to recall a county, district or municipal
29 officer, the petition shall be deemed filed with the Secretary of State
30 as of the date on which the Secretary of State receives certificates
31 from the county clerks showing the petition to be signed by the
32 requisite number of voters of the State.

33 7. If the amended certificates received from all county clerks
34 by the Secretary of State establish that the petition is still
35 insufficient, the Secretary of State shall immediately so notify the
36 petitioners and the county clerks. If the petition is a petition to recall
37 a county, district or municipal officer, the Secretary of State shall
38 also notify the officer with whom the petition is to be filed.

39 8. The Secretary of State shall adopt regulations to carry out
40 the provisions of this section.

41 **Sec. 5.** NRS 293.12795 is hereby amended to read as follows:

42 293.12795 1. If an appeal is based upon the results of the
43 verification of signatures on a petition performed pursuant to NRS
44 293.1277 or 293.1279, the Secretary of State shall:



1 (a) If the Secretary of State finds for the appellant, order the
2 county clerk to recertify the petition, including as verified signatures
3 all contested signatures which the Secretary of State determines are
4 valid. If the county clerk has not yet removed each name as
5 requested pursuant to NRS 295.055 , [~~or 306.015,~~] the county clerk
6 shall do so before recertifying the petition.

7 (b) If the Secretary of State does not find for the appellant,
8 notify the appellant and the county clerk that the petition remains
9 insufficient.

10 2. If the Secretary of State is unable to make a decision on the
11 appeal based upon the documents submitted, the Secretary of State
12 may order the county clerk to reverify the signatures.

13 3. The decision of the Secretary of State is a final decision for
14 the purposes of judicial review. The decision of the Secretary of
15 State may only be appealed in the First Judicial District Court.

16 **Sec. 6.** Chapter 294A of NRS is hereby amended by adding
17 thereto a new section to read as follows:

18 *1. A person shall not make or commit to make a contribution*
19 *or contributions to a candidate in a special election to recall a*
20 *public officer, in an amount which exceeds \$5,000, regardless of*
21 *the number of candidates for the office.*

22 *2. No contribution to a candidate in a recall election may be*
23 *given or received except during the period:*

24 *(a) Beginning on the date that a notice of intent to recall a*
25 *public officer is filed pursuant to NRS 306.015; and*

26 *(b) Ending:*

27 *(1) If a petition for recall is not submitted to the filing*
28 *officer before the expiration of the notice of intent pursuant to the*
29 *provisions of chapter 306 of NRS or is otherwise legally*
30 *insufficient when submitted to the filing officer pursuant to the*
31 *provisions of that chapter, on the date that the notice of intent*
32 *expires or the petition is determined to be legally insufficient, as*
33 *applicable.*

34 *(2) If a district court determines that a petition for recall is*
35 *legally insufficient pursuant to chapter 306 of NRS, on the date of*
36 *the order of the district court.*

37 *(3) If a recall election is held, on the date of the special*
38 *election to recall a public officer.*

39 *3. No contribution made, committed to be made or accepted*
40 *pursuant to this section for a special election to recall a public*
41 *officer affects the limitations on the amount of contributions that*
42 *may be committed, contributed or accepted pursuant to NRS*
43 *294A.100 for a primary election or general election.*

44 *4. A candidate shall not accept a contribution or commitment*
45 *to make a contribution made in violation of this section.*



1 ***5. A person who willfully violates any provision of this***
2 ***section is guilty of a category E felony and shall be punished as***
3 ***provided in NRS 193.130.***

4 **Sec. 7.** NRS 294A.100 is hereby amended to read as follows:

5 294A.100 1. A person shall not make or commit to make a
6 contribution or contributions to a candidate for any office, except a
7 federal office, in an amount which exceeds \$5,000 for the primary
8 election, regardless of the number of candidates for the office, and
9 \$5,000 for the general election, regardless of the number of
10 candidates for the office, during the period:
