AN ACT making appropriations to the State Department of Conservation and Natural Resources for the replacement or purchase of certain information technology, vehicles and equipment; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** There is hereby appropriated from the State General
2 Fund to the State Department of Conservation and Natural
3 Resources the sum of \$296,261 for the Conservation and Natural
4 Resources Administration budget account for the replacement of
5 computer hardware and associated software and parts of the shared
6 information technology infrastructure.

7 **Sec. 2.** There is hereby appropriated from the State General
8 Fund to the State Department of Conservation and Natural
9 Resources the sum of \$11,378 for the Conservation Districts
10 Program budget account for the replacement of computer hardware
11 and associated software.



1 **Sec. 3.** There is hereby appropriated from the State General
2 Fund to the Division of State Parks of the State Department of
3 Conservation and Natural Resources the sum of \$3,693,714 for the
4 replacement of heavy equipment, vehicles and water vessels.

5 **Sec. 4.** There is hereby appropriated from the State General
6 Fund to the Division of State Parks of the State Department of
7 Conservation and Natural Resources the sum of \$72,498 for the
8 replacement of handheld and vehicle radios.

9 **Sec. 5.** There is hereby appropriated from the State General
10 Fund to the Division of State Parks of the State Department of
11 Conservation and Natural Resources the sum of \$50,838 for the
12 purchase of a wood chipper.

13 **Sec. 6.** There is hereby appropriated from the State General
14 Fund to the Division of State Parks of the State Department of
15 Conservation and Natural Resources the sum of \$181,906 for the
16 replacement of computer hardware and associated software.

17 **Sec. 7.** There is hereby appropriated from the State General
18 Fund to the Division of State Parks of the State Department of
19 Conservation and Natural Resources the sum of \$307,980 for the
20 purchase of equipment for operational duties within the state parks.

21 **Sec. 8.** There is hereby appropriated from the State General
22 Fund to the Division of Water Resources of the State Department of
23 Conservation and Natural Resources the sum of \$78,506 for the
24 replacement of a vehicle.

25 **Sec. 9.** There is hereby appropriated from the State General
26 Fund to the Division of Water Resources of the State Department of
27 Conservation and Natural Resources the sum of \$296,499 for the
28 replacement of computer hardware and associated software.

29 **Sec. 10.** There is hereby appropriated from the State General
30 Fund to the Division of Forestry of the State Department of
31 Conservation and Natural Resources the sum of \$5,000,000 for the
32 replacement of a helicopter.

33 **Sec. 11.** There is hereby appropriated from the State General
34 Fund to the Division of Forestry of the State Department of
35 Conservation and Natural Resources the sum of \$1,463,204 for the
36 replacement of vehicles.

37 **Sec. 12.** There is hereby appropriated from the State General
38 Fund to the Division of Forestry of the State Department of
39 Conservation and Natural Resources the sum of \$419,773 for the
40 replacement of computer hardware and associated software.

41 **Sec. 13.** There is hereby appropriated from the State General
42 Fund to the Division of Forestry of the State Department of
43 Conservation and Natural Resources the sum of \$1,471,136 for the
44 Forestry Conservation Camps budget account for the replacement of
45 command trucks.



1 **Sec. 14.** There is hereby appropriated from the State General
2 Fund to the Division of Forestry of the State Department of
3 Conservation and Natural Resources the sum of \$1,116,526 for the
4 Forestry Conservation Camps budget account for the replacement of
5 trailers for transporting portable toilets and tools.

6 **Sec. 15.** There is hereby appropriated from the State General
7 Fund to the Division of Forestry of the State Department of
8 Conservation and Natural Resources the sum of \$291,377 for the
9 Forestry Conservation Camps budget account for the replacement of
10 computer hardware and associated software.

11 **Sec. 16.** There is hereby appropriated from the State General
12 Fund to the Division of State Lands of the State Department of
13 Conservation and Natural Resources the sum of \$15,335 for the
14 replacement of computer hardware and associated software.

15 **Sec. 17.** There is hereby appropriated from the State General
16 Fund to the Division of Outdoor Recreation of the State Department
17 of Conservation and Natural Resources the sum of \$1,402 for the
18 replacement of computer hardware and associated software.

19 **Sec. 18.** Any remaining balance of the appropriations made by
20 sections 1 to 17, inclusive, of this act must not be committed for
21 expenditure after June 30, 2025, by the entity to which the
22 appropriation is made or any entity to which money from the
23 appropriation is granted or otherwise transferred in any manner, and
24 any portion of the appropriated money remaining must not be spent
25 for any purpose after September 19, 2025, by either the entity to
26 which the money was appropriated or the entity to which the money
27 was subsequently granted or transferred, and must be reverted to the
28 State General Fund on or before September 19, 2025.

29 **Sec. 19.** This act becomes effective upon passage and
30 approval.
