AN ACT relating to public employees; making appropriations for the implementation of certain collective bargaining agreements; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
- 2 General Fund to the Office of Finance in the Office of the Governor
- 3 the sum of \$12,269,308 for the costs of implementing all provisions
- 4 of the collective bargaining agreement covering personnel
- 5 represented by the bargaining units established in paragraphs (a), (e)
- 6 and (f) of subsection 1 of NRS 288.515, except those costs for
- 7 which the 82nd Session of the Nevada Legislature appropriated or
- 8 authorized the expenditure of money in another act this session that
- 9 was approved by the Governor.
- 10 2. There is hereby appropriated from the State Highway Fund
- 11 to the Office of Finance in the Office of the Governor the sum of
- 12 \$2,022,496 for the costs of implementing all provisions of the
- 13 collective bargaining agreement covering personnel represented by
- 14 the bargaining units established in paragraphs (a), (e) and (f) of



1 subsection 1 of NRS 288.515, except those costs for which the 82nd
2 Session of the Nevada Legislature appropriated or authorized the
3 expenditure of money in another act this session that was approved
4 by the Governor.

5 **Sec. 2.** 1. There is hereby appropriated from the State
6 General Fund to the Office of Finance in the Office of the Governor
7 the sum of \$4,644,028 for the costs of implementing all provisions
8 of the collective bargaining agreement covering personnel
9 represented by the bargaining unit established in paragraph (g) of
10 subsection 1 of NRS 288.515, except those costs for which the 82nd
11 Session of the Nevada Legislature appropriated or authorized the
12 expenditure of money in another act this session that was approved
13 by the Governor.

14 2. There is hereby appropriated from the State Highway Fund
15 to the Office of Finance in the Office of the Governor the sum of
16 \$4,806,954 for the costs of implementing all provisions of the
17 collective bargaining agreement covering personnel represented by
18 the bargaining units established in paragraph (g) of subsection 1 of
19 NRS 288.515, except those costs for which the 82nd Session of the
20 Nevada Legislature appropriated or authorized the expenditure of
21 money in another act this session that was approved by the
22 Governor.

23 **Sec. 3.** 1. There is hereby appropriated from the State
24 General Fund to the Office of Finance in the Office of the Governor
25 the sum of \$1,304,025 for the costs of implementing all provisions
26 of the collective bargaining agreement covering personnel
27 represented by the bargaining unit established in paragraph (h) of
28 subsection 1 of NRS 288.515, except those costs for which the 82nd
29 Session of the Nevada Legislature appropriated or authorized the
30 expenditure of money in another act this session that was approved
31 by the Governor.

32 2. There is hereby appropriated from the State Highway Fund
33 to the Office of Finance in the Office of the Governor the sum of
34 \$262,153 for the costs of implementing all provisions of the
35 collective bargaining agreement covering personnel represented by
36 the bargaining unit established in paragraph (h) of subsection 1 of
37 NRS 288.515, except those costs for which the 82nd Session of the
38 Nevada Legislature appropriated or authorized the expenditure of
39 money in another act this session that was approved by the
40 Governor.

41 **Sec. 4.** 1. There is hereby appropriated from the State
42 General Fund to the Office of Finance in the Office of the Governor
43 the sum of \$45,531,463 for the costs of implementing all provisions
44 of the collective bargaining agreement covering personnel
45 represented by the bargaining unit established in paragraph (i) of



1 subsection 1 of NRS 288.515, except those costs for which the 82nd
2 Session of the Nevada Legislature appropriated or authorized the
3 expenditure of money in another act this session that was approved
4 by the Governor.

5 2. Expenditure of \$5,275,000 not appropriated from the State
6 General Fund or State Highway Fund is hereby authorized during
7 Fiscal Year 2023-2024 and Fiscal Year 2024-2025 by the Office of
8 Finance in the Office of the Governor for the same purpose as set
9 forth in subsection 1.

10 **Sec. 5.** There is hereby appropriated from the State General
11 Fund to the Office of Finance in the Office of the Governor the sum
12 of \$413,488 for the costs of implementing all provisions of the
13 collective bargaining agreement covering personnel represented by
14 the bargaining unit established in paragraph (k) of subsection 1 of
15 NRS 288.515, except those costs for which the 82nd Session of the
16 Nevada Legislature appropriated or authorized the expenditure of
17 money in another act this session that was approved by the
18 Governor.

19 **Sec. 6.** Any remaining balance of the appropriations made by
20 sections 1 to 5, inclusive, of this act must not be committed for
21 expenditure after June 30, 2025, by the entity to which the
22 appropriation is made or any entity to which money from the
23 appropriation is granted or otherwise transferred in any manner, and
24 any portion of the appropriated money remaining must not be spent
25 for any purpose after September 19, 2025, by either the entity to
26 which the money was appropriated or the entity to which the money
27 was subsequently granted or transferred, and must be reverted to the
28 fund from which it was appropriated on or before September 19,
29 2025.

30 **Sec. 7.** This act becomes effective on July 1, 2023.
