SUMMARY—Makes appropriations to the Division of State Parks of the State Department of Conservation and Natural Resources for projects at certain parks and recreation areas. (BDR S-1205)

AN ACT making appropriations to the Division of State Parks of the State Department of Conservation and Natural Resources for projects at certain parks and recreation areas; authorizing the expenditure of certain money by the Division for the Walker River State Recreation Area; and providing other matters properly relating thereto.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

- 1 **Section 1.** 1. There is hereby appropriated from the State
2 General Fund to the Division of State Parks of the State Department
3 of Conservation and Natural Resources the sum of \$1,200,000 for
4 the stabilization and restoration project at the Fort Churchill State
5 Historic Park.
6 2. There is hereby appropriated from the State General Fund to
7 the Division of State Parks of the State Department of Conservation
8 and Natural Resources the sum of \$550,000 for the construction of
9 cabins at the Walker River State Recreation Area.
10 3. There is hereby appropriated from the State General Fund to
11 the Division of State Parks of the State Department of Conservation
12 and Natural Resources the sum of \$1,420,000 for the construction of
13 campgrounds with full hook-ups at the Walker River State
14 Recreation Area.

1 4. Expenditure of \$1,200,000 not appropriated from the State
2 General Fund or the State Highway Fund is hereby authorized
3 during Fiscal Year 2017-2018 and Fiscal Year 2018-2019 by the
4 State Department of Conservation and Natural Resources for the
5 same purpose as set forth in subsection 3.

6 5. There is hereby appropriated from the State General Fund to
7 the Division of State Parks of the State Department of Conservation
8 and Natural Resources the sum of \$168,000 for the construction of
9 pull-through campsites at 10 state park campgrounds.

10 6. There is hereby appropriated from the State General Fund to
11 the Division of State Parks of the State Department of Conservation
12 and Natural Resources the sum of \$159,000 for the construction of
13 cabins at the Wild Horse State Recreation Area.

14 **Sec. 2.** Any remaining balance of the appropriations made by
15 section 1 of this act must not be committed for expenditure after
16 June 30, 2019, by the entity to which the appropriation is made or
17 any entity to which money from the appropriation is granted or
18 otherwise transferred in any manner, and any portion of the
19 appropriated money remaining must not be spent for any purpose
20 after September 20, 2019, by either the entity to which the money
21 was appropriated or the entity to which the money was subsequently
22 granted or transferred, and must be reverted to the State General
23 Fund on or before September 20, 2019.

24 **Sec. 3.** This act becomes effective on July 1, 2017.
