SUMMARY—Revises provisions relating to the State Board of Agriculture. (BDR 50-263)

AN ACT relating to agriculture; revising the qualifications of the members of the State Board of Agriculture; and providing other matters properly relating thereto.

#### **Legislative Counsel's Digest:**

Existing law creates the State Board of Agriculture, consisting of 11 members, and sets forth the qualifications of the members. (NRS 561.045, 561.055) **Section 1** of this bill revises the membership of the Board by requiring that: (1) two members are actively engaged in livestock production; (2) two members are actively engaged in growing crops, at least one of which is a specialty crop harvested by mechanical cultivation; (3) one member is working in the field of supplemental nutrition distribution; and (4) one member is actively engaged in food manufacturing or animal processing. **Section 1** also removes the requirement that certain members be actively engaged in: (1) range or semirange cattle or sheep production; (2) general farming; and (3) growing crops which are planted in rows. **Section 2** of this bill: (1) provides that each member who is serving on the State Board on June 30, 2022, continues to serve until the expiration of his or her term or until a vacancy occurs, whichever occurs first; and (2) requires the Governor to appoint the members representing supplemental nutrition distribution and food manufacturing or animal processing to terms commencing on July 1, 2022.

# THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

**Section 1.** NRS 561.055 is hereby amended to read as follows: 561.055 1. [Three members] The membership of the Board [must be] consists of:

- (a) Two members who are actively engaged in [range or semirange cattle] livestock production. [, one in]
- (b) One member who is actively engaged in dairy production. [, one in range or semirange sheep production, one in general farming, one]
- (c) One member who is actively engaged in general agriculture. [, one in growing crops which are planted in rows spaced to permit mechanical cultivation, one]
- (d) Two members who are actively engaged in growing crops, at least one of which is a specialty crop harvested by mechanical cultivation.
- (e) One member who is actively engaged in the control of pests [, one]
- (f) One member who is actively engaged in the petroleum industry. [and one]
- (g) One member who is actively engaged in raising nursery stock.
- (h) One member who is working in the field of supplemental nutrition distribution.
- (i) One member who is actively engaged in food manufacturing or animal processing.
- 2. Not more than two members may be residents of the same county, and the [range or semirange cattle production] members appointed pursuant to paragraph (a) of subsection 1 and the members appointed pursuant to paragraph (d) of subsection 1 must be residents of different counties.
- **Sec. 2.** The amendatory provisions of section 1 of this act do not affect the current term of any person who, on June 30, 2022, is a member of the State Board of Agriculture, and each such member continues to serve until the expiration of his or her current term or until a vacancy occurs, whichever occurs first. On or before July 1, 2022, the Governor shall appoint to the State Board of Agriculture:
- 1. One person who satisfies the qualifications set forth in paragraph (h) of subsection 1 of NRS 561.055, as amended by section 1 of this act, to a term commencing on July 1, 2022; and
- 2. One person who satisfies the qualifications set forth in paragraph (i) of subsection 1 of NRS 561.055, as amended by section 1 of this act, to a term commencing on July 1, 2022.
- **Sec. 3.** 1. This section and section 2 of this act become effective upon passage and approval.
  - 2. Section 1 of this act becomes effective on July 1, 2022.
