AN ACT relating to older persons; revising the crimes against an older person that are subject to an additional civil penalty; and providing other matters properly relating thereto.

Legislative Counsel's Digest:

1 Existing law authorizes the Attorney General to bring a civil action to recover a
2 civil penalty against any person who is found guilty of abuse, neglect, exploitation
3 or isolation of an older person. (NRS 228.280) This bill expands the list of crimes
4 that are subject to an additional civil penalty to include certain crimes committed
5 against a person who is 60 years of age or older.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 228.280 is hereby amended to read as follows:
2 228.280 1. In addition to any criminal penalty, a person who
3 is **[found guilty]** **convicted** of a **crime against an older person for**
4 **which an additional term of imprisonment may be imposed**
5 **pursuant to subsection 1 of NRS 193.167 or of the** abuse, neglect,
6 exploitation or isolation of an older person pursuant to NRS
7 200.5099 or 200.50995 is liable for a civil penalty to be recovered
8 by the Attorney General in a civil action brought in the name of the
9 State of Nevada:
10 (a) For the first offense, in an amount which is not less than
11 \$5,000 and not more than \$20,000.

1 (b) For a second or subsequent offense, in an amount which is
2 not less than \$10,000 and not more than \$30,000.

3 2. The Attorney General shall deposit any money collected for
4 civil penalties pursuant to subsection 1 in equal amounts to:

5 (a) A separate account in the Fund for the Compensation of
6 Victims of Crime created pursuant to NRS 217.260 to provide
7 compensation to older persons who are ~~abused,~~:

8 (1) *Victims of a crime for which an additional term of*
9 *imprisonment may be imposed pursuant to subsection 1 of NRS*
10 *193.167; or*

11 (2) *Abused*, neglected, exploited or isolated in violation of
12 NRS 200.5099 and 200.50995. ~~& and~~

13 (b) The Account for the Unit for the Investigation and
14 Prosecution of Crimes Against Older Persons created pursuant to
15 NRS 228.285.

16 **Sec. 2.** This act becomes effective on July 1, 2011.
