SUMMARY—Revises provisions relating to the state business portal. (BDR 7-448)

AN ACT relating to business; declaring certain records to be confidential; revising provisions governing the state business portal; revising provisions governing applications for certain authorizations to conduct a business in this State issued by state and local agencies and health districts; requiring the Secretary of State to issue unique business identification numbers under certain circumstances; revising provisions governing the issuance of certain licenses by incorporated cities and counties; removing the prohibition against a county clerk refusing to accept for filing certain business certificates in certain circumstances; revising provisions governing the disclosure of certain information by the Employment Security Division of the Department of Employment, Training and Rehabilitation; repealing certain provisions relating to the collection of information from businesses seeking certain authorizations to conduct business in this State; and providing other matters properly relating thereto.



Legislative Counsel's Digest:

1 Under existing law, the Secretary of State is required to establish the state
2 business portal to facilitate interaction among businesses and governmental
3 agencies in this State by allowing businesses to conduct necessary transactions with
4 governmental agencies in this State through the state business portal. (NRS
5 75A.100) **Section 4** of this bill requires the Secretary of State to: (1) establish
6 common business registration information that is used by state and local agencies
7 and health districts to conduct necessary transactions with businesses in this State;
8 and (2) cause the state business portal to provide common business registration
9 information to state and local agencies and health districts that conduct necessary
10 transactions with businesses in this State. **Section 4** further requires that state and
11 local agencies and health districts to the extent practicable: (1) integrate their
12 electronic applications processes into the state business portal; (2) use the state
13 business portal to accept and disseminate common business registration information
14 that is needed by the state or local agency or health district to issue a license,
15 certificate, registration, permit or similar type of authorization to conduct a business
16 in this State or to engage in an occupation or profession in this State; (3) make
17 available on the Internet applications for a license, certificate, registration, permit
18 or similar type of authorization to conduct a business in this State or to engage in an
19 occupation or profession in this State and to integrate such applications into the
20 state business portal; and (4) meet certain other requirements related to
21 participation in the state business portal. However, **section 4** also specifies that a
22 state or local agency or health district is not required to disseminate or release
23 information if such action would result in the state or local agency or health district
24 violating any provision of state or federal law relating to the confidentiality of the
25 information. **Section 3** of this bill deems that the records and files collected as
26 common business registration information are confidential and privileged unless an
27 exception applies.

28 **Section 5** of this bill requires the Secretary of State to assign a unique business
29 identification number to each business entity organized in this State and to each
30 person who is issued a state business license or who claims to be excluded or
31 exempt from the requirement to obtain a state business license. Under **section 4**: (1)
32 the Secretary of State must cause the state business portal to interface with the
33 system used by the Secretary of State to assign business identification numbers; and
34 (2) state and local agencies and health districts that issue licenses, certificates,
35 registrations, permits or similar types of authorization to conduct a business in this
36 State or to engage in an occupation or profession in this State must require an
37 applicant for such a license, certificate, registration or permit to include the
38 applicant's business identification number on the application.

39 **Sections 7 and 8** of this bill amend provisions governing city and county
40 business licenses so that certain information regarding industrial insurance is
41 provided through the state business portal. **Section 9** of this bill removes the
42 provision from existing law which prohibits a county clerk, in certain
43 circumstances, from refusing to accept for filing a certificate or renewal certificate
44 concerning persons doing business in this State under an assumed or fictitious name
45 that is filed by a foreign artificial person or persons. **Section 10** of this bill
46 authorizes the Employment Security Division of the Department of Employment,
47 Training and Rehabilitation to make certain information available to the Secretary
48 of State for certain purposes related to operating and maintaining the state business
49 portal. **Section 12** of this bill repeals certain provisions relating to: (1) the
50 coordination of the collection of certain information and forms from businesses by
51 state agencies and local governments; and (2) the affidavit required to be filed by
52 an applicant who wishes to obtain a local business license to sell certain retail
53 merchandise.



THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 75A of NRS is hereby amended by adding
2 thereto the provisions set forth as sections 2 and 3 of this act.

3 **Sec. 2.** *As used in this chapter, unless the context otherwise*
4 *requires, "health district" means a health district created pursuant*
5 *to NRS 439.362 or 439.370.*

6 **Sec. 3. 1.** *Except as otherwise provided in subsection 2 and*
7 *NRS 239.0115, the records and files collected by the Secretary of*
8 *State, a state or local agency or health district pursuant to*
9 *paragraph (f) of subsection 2 of NRS 75A.100 are confidential*
10 *and privileged. The Secretary of State, any employee of the*
11 *Secretary of State and any state or local agency or health district,*
12 *or employee of an agency or health district, which is authorized to*
13 *view or use the information in such records or files:*

14 (a) *Shall not disclose any information obtained from such*
15 *records or files other than specific information contained in the*
16 *record or file that is deemed a public record; and*

17 (b) *May not be required to produce any of the records, files*
18 *and information for the inspection of any person or governmental*
19 *entity or for use in any action or proceeding.*

20 **2.** *The records and files collected pursuant to paragraph (f)*
21 *of subsection 2 of NRS 75A.100 are not confidential and*
22 *privileged in the following cases:*

23 (a) *Testimony by the Secretary of State, or any employee of the*
24 *Secretary of State, or a member or employee of any state or local*
25 *agency or health district and production of records, files and*
26 *information on behalf of the Secretary of State, any state or local*
27 *agency or health district or a person in any action or proceeding*
28 *before the Secretary of State, any state or local agency or health*
29 *district, or court in this State if that testimony or the records, files*
30 *or information, or the facts shown thereby, are directly involved in*
31 *the action or proceeding.*

32 (b) *Delivery to a person or his or her authorized representative*
33 *of a copy of any document filed by the person pursuant to this*
34 *chapter.*

35 (c) *Publication by a governmental agency of statistics so*
36 *classified as to prevent the identification of a particular business*
37 *or document.*

38 (d) *Exchanges of information with the Secretary of State, any*
39 *state or local agency, health district or federal governmental*
40 *agency in accordance with any agreement made and provided for*
41 *in such cases or disclosure in confidence to any federal agency*



1 *that requests the information for use by the agency in a civil or*
2 *criminal investigation or prosecution.*

3 *(e) Disclosure in confidence to the Attorney General or other*
4 *legal representative of the State or a local or federal agency in*
5 *connection with an action or proceeding relating to a taxpayer, or*
6 *to any agency of this or any other state or the Federal Government*
7 *charged with the administration or enforcement of laws relating to*
8 *workers' compensation, unemployment compensation, public*
9 *assistance, taxation, labor or gaming or which issues licenses,*
10 *certificates, registrations, permits or similar types of authorization*
11 *to conduct a business in this State.*

12 *(f) Disclosure by the Secretary of State or a state or local*
13 *agency or health district for the purpose of collection of a debt, fee*
14 *or obligation owed to the Secretary of State or the agency or*
15 *district.*

16 *(g) A business that submits information to the state business*
17 *portal and agrees to a provision authorizing the release of*
18 *information contained in the records and files of the state business*
19 *portal for a purpose which must be specified in the provision.*

20 **Sec. 4.** NRS 75A.100 is hereby amended to read as follows:

21 75A.100 1. The Secretary of State shall provide for the
22 establishment of a state business portal to facilitate interaction
23 among businesses and governmental agencies in this State by
24 allowing businesses to conduct necessary transactions with
25 governmental agencies in this State through use of the state business
26 portal.

27 2. The Secretary of State shall:

28 (a) Establish, through cooperative efforts ~~and~~ *and consultation*
29 *with representatives of state agencies, local governments, health*
30 *districts and businesses,* the standards and requirements necessary
31 to design, build and implement the state business portal;

32 (b) Establish the standards and requirements necessary for a
33 state or local agency to participate in the state business portal;

34 (c) Authorize a state or local agency to participate in the state
35 business portal if the Secretary of State determines that the agency
36 meets the standards and requirements necessary for such
37 participation ~~and~~ *and the agency has entered into an agreement for*
38 *access to the state business portal which is prescribed by the*
39 *Secretary of State;*

40 (d) Determine the appropriate requirements to be used by
41 businesses and governmental agencies conducting transactions
42 through use of the state business portal;

43 (e) *Cause the state business portal to interface with the system*
44 *established by the Secretary of State to assign business*
45 *identification numbers;*



1 *(f) For the purpose of coordinating the collection of common*
2 *information from businesses using the state business portal:*

3 *(1) Establish common business registration information to*
4 *be collected from businesses by state and local agencies and health*
5 *districts which issue licenses, certificates, registrations, permits or*
6 *similar types of authorization to conduct a business in this State,*
7 *which collect taxes or fees or which conduct other necessary*
8 *transactions with businesses in this State; and*

9 *(2) Cause the state business portal to provide the common*
10 *business registration information to state and local agencies and*
11 *health districts which participate in the state business portal and*
12 *which use the common business registration information to issue*
13 *licenses, certificates, registrations, permits or similar types of*
14 *authorization to conduct a business in this State, to collect taxes or*
15 *fees or to conduct other necessary transactions with businesses in*
16 *this State;*

17 *(g) In carrying out the provisions of this section, consult with*
18 *the Executive Director of the Office of Economic Development to*
19 *ensure that the activities of the Secretary of State are consistent with*
20 *the State Plan for Economic Development developed by the*
21 *Executive Director pursuant to subsection 2 of NRS 231.053; and*

22 ~~(h)~~ *(h) Adopt such regulations and take any appropriate action*
23 *as necessary to carry out the provisions of this chapter.*

24 *3. Each state or local agency or health district that issues a*
25 *license, certificate, registration, permit or similar type of*
26 *authorization to conduct a business in this State shall, to the*
27 *extent practicable:*

28 *(a) Make available on its Internet website any of its*
29 *applications for a license, certificate, registration, permit or*
30 *similar type of authorization to conduct a business in this State.*

31 *(b) Accept the electronic transfer of common business*
32 *registration information from the state business portal for use in*
33 *any electronic application for a license, certificate, registration,*
34 *permit or similar type of authorization to conduct a business in*
35 *this State or for use in an application processing system.*

36 *(c) Integrate with the state business portal any of its*
37 *applications for a license, certificate, registration, permit or*
38 *similar type of authorization to conduct a business in this State. As*
39 *used in this paragraph, “integrate” means to consolidate an*
40 *electronic application process so that it is capable of collecting and*
41 *disseminating information to a state or local agency or health*
42 *district for the processing of the application for a license,*
43 *certificate, registration, permit or similar type of authorization to*
44 *conduct a business in this State.*



1 (d) Allow for the acceptance of an electronic signature for a
2 declaration or affirmation under penalty of perjury or as provided
3 for in statute.

4 (e) Require an applicant for a license, certificate, registration,
5 permit or similar type of authorization to conduct a business in
6 this State to include in the application the applicant's business
7 identification number.

8 (f) Ensure that the state or local agency or health district, as
9 applicable, is capable of using the state business portal to accept
10 and disseminate to participating state and local agencies and
11 health districts the common business registration information
12 established pursuant to subparagraph (1) of paragraph (f) of
13 subsection 2 which is needed by the state or local agency or health
14 district to issue a license, certificate, registration, permit or similar
15 type of authorization to conduct a business in this State.

16 (g) Establish and maintain its rules, data and processes
17 relating to businesses in accordance with the agreement entered
18 into by the state or local agency or health district pursuant to
19 paragraph (c) of subsection 2 and any corresponding technical
20 documentation.

21 4. The provisions of subsection 3 do not require a state or
22 local agency or health district to disseminate or release
23 information if such action would result in the state or local agency
24 or health district violating any provision of state or federal law
25 relating to the confidentiality of the information.

26 5. Except as otherwise provided in NRS 239.0115, all records
27 containing technical specifications, processing protocols or
28 programmatic or system architecture of the state business portal,
29 and any other records containing information the disclosure of
30 which would endanger the security of the state business portal, or
31 proprietary information related to the functions, operations,
32 processes or architecture of the state business portal, are deemed
33 confidential and privileged.

34 6. As used in this section:

35 (a) "Business identification number" means the number
36 assigned by the Secretary of State pursuant to section 5 of this act
37 to an entity organized pursuant to this title or to a person who is
38 issued a state business license or who claims to be excluded or
39 exempt from the requirement to obtain a state business license
40 pursuant to chapter 76 of NRS.

41 (b) "Disseminate" means to distribute in an electronic format
42 that is capable of being accepted by participating state and local
43 agencies and health districts and used by participants as the
44 common business registration information used to issue a license,
45 certificate, registration, permit or similar type of authorization, to



1 *collect taxes or fees or to conduct other necessary transactions*
2 *with businesses in this State.*

3 **Sec. 5.** Chapter 225 of NRS is hereby amended by adding
4 thereto a new section to read as follows:

5 *For the purpose of establishing the identity of an entity*
6 *organized pursuant to title 7 of NRS or a person who is issued a*
7 *state business license pursuant to chapter 76 of NRS or who*
8 *claims to be excluded or exempt from the requirement to obtain a*
9 *state business license pursuant to NRS 76.105, the Secretary of*
10 *State shall assign a unique business identification number to each*
11 *such entity or person.*

43 affect in any other manner the rights of a person in any written book
44 or record which is copyrighted pursuant to federal law.



1 2. A governmental entity may not reject a book or record
2 which is copyrighted solely because it is copyrighted.

3 3. A governmental entity that has legal custody or control of a
4 public book or record shall not deny a request made pursuant to
5 subsection 1 to inspect or copy or receive a copy of a public book or
6 record on the basis that the requested public book or record contains
7 information that is confidential if the governmental entity can
8 redact, delete, conceal or separate the confidential information from
9 the information included in the public book or record that is not
10 otherwise confidential.

11 4. A person may request a copy of a public record in any
12 medium in which the public record is readily available. An officer,
13 employee or agent of a governmental entity who has legal custody
14 or control of a public record:

15 (a) Shall not refuse to provide a copy of that public record in a
16 readily available medium because the officer, employee or agent has
17 already prepared or would prefer to provide the copy in a different
18 medium.

19 (b) Except as otherwise provided in NRS 239.030, shall, upon
20 request, prepare the copy of the public record and shall not require
21 the person who has requested the copy to prepare the copy himself
22 or herself.

TEXT OF REPEALED SECTIONS

237.180 Requirements; annual meeting to design and modify joint forms.

1. The agencies of this State, and the local governments within this State, that collect taxes or fees from persons engaged in business, or require such persons to provide related information and forms, shall coordinate their collection of information and forms so that each enterprise is required to furnish information in as few separate reports as possible. This section applies specifically, but is not limited, to the Department of Taxation, the Employment Security Division of the Department of Employment, Training and Rehabilitation, the State Department of Conservation and Natural Resources, and the counties and cities that require a business license.

2. On or before October 1 of each year, the Executive Director of the Department of Taxation shall convene the heads, or persons designated by the respective heads, of the state agencies named in subsection 1 and the appropriate officers of the cities and counties that require a business license. The Secretary of State, a representative of the Nevada Association of Counties and a representative of the Nevada League of Cities must be invited to attend the meeting. If the Executive Director knows, or is made aware by persuasive information furnished by any enterprise required to pay a tax or fee or to provide information, that any other state or local agency needs to participate to accomplish the purpose set forth in subsection 1, the Executive Director shall also invite the head of that agency or the appropriate officer of the local government, and the person so invited shall attend. The Administrator of the Division of Enterprise Information Technology Services of the Department of Administration shall assist in effecting the consolidation of the information and the creation of the forms.



3. The persons so assembled shall design and modify, as appropriate, the necessary joint forms for use during the ensuing fiscal year to accomplish the purpose set forth in subsection 1. If any dispute cannot be resolved by the participants, it must be referred to the Nevada Tax Commission for a decision that is binding on all parties.

4. The provisions of chapter 241 of NRS apply to a meeting held pursuant to this section. The Executive Director of the Department of Taxation shall provide members of the staff of the Department of Taxation to assist in complying with the requirements of chapter 241 of NRS.

364.110 Licensing authority to require affidavit. No county license board and no other licensing authority, whether county, city or township, within the State of Nevada, shall issue an initial license or transfer any license to any person, firm or corporation authorizing the person, firm or corporation to engage in, or in any manner carry on, any business of the retail sale of wines, beers, liquors, soft drinks, produce, meats or other foodstuffs, clothing, hardware, or any other type or class of merchandise whatever, without requiring the applicant or applicants for the license to file with the licensing authority an affidavit showing:

1. Whether the applicant or applicants are engaged in business under a fictitious name, and if so engaged in business, that the applicant or applicants have complied with the provisions of chapter 602 of NRS.

2. Whether there has been any change in ownership in the business of the applicant or applicants during the preceding calendar year, and if there has been any such change in ownership, that the change was made in compliance with the provisions of chapter 104 of NRS.

364.120 Filing fee for required affidavit. Any licensing authority coming within the provisions of NRS 364.110 is authorized to collect a filing fee of not to exceed \$3 for the filing of the affidavit required to be filed by NRS 364.110.
