SUMMARY—Makes various changes relating to education. (BDR 34-331)

AN ACT relating to education; revising provisions governing the annual reports of accountability for public schools; revising requirements for a plan to improve the achievement of pupils enrolled in a public school; requiring the State Board of Education to develop nonbinding recommendations for the pupil-specialized instructional support personnel ratio in public schools; requiring a school safety specialist to be designated for each public school; revising provisions related to providing a safe and respectful learning environment; revising provisions related to plans used by schools in responding to a crisis, emergency or suicide; revising provisions related to a statewide framework for providing integrated student supports for pupils enrolled in a public school and the families of such pupils; revising provisions related to school police officers; revising provisions relating to pupil discipline; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Existing law requires the boards of trustees of school districts, the sponsors of  
2 charter schools and the State Board of Education to prepare annual reports of  
3 accountability that contain certain information regarding public schools and pupils  
4 enrolled in public schools. (NRS 385A.070, 385A.240, 385A.250) **Sections 1 and**  
5 **2** of this bill require that the information must be included in the annual reports of



6 accountability in a manner that allows the disaggregation of the information by  
7 certain categories of pupils.

8 Existing law requires the principal of each school, in consultation with the  
9 employees of the school, to prepare a plan to improve the achievement of pupils  
10 enrolled in the school and prescribes the requirements of such a plan. (NRS  
11 385A.650) **Section 3** of this bill requires such a plan to improve the achievement of  
12 pupils to include methods for evaluating and improving the school climate.

13 Existing law provides for the establishment of the Safe-to-Tell Program within  
14 the Office for a Safe and Respectful Learning Environment within the Department  
15 of Education. The Program enables any person to anonymously report any  
16 dangerous, violent or unlawful activity which is being conducted or threatened to  
17 be conducted on the property of a public school, at an activity sponsored by a  
18 public school or on a school bus of a public school. (NRS 388.1455) **Section 13** of  
19 this bill: (1) revises the name of the Program to the SafeVoice Program; (2)  
20 requires that under certain circumstances a person who makes a report to the  
21 Program will not remain anonymous; and (3) requires that certain public safety  
22 agencies be authorized to access certain pupil information in response to a report to  
23 the Program. **Sections 11-16** of this bill make conforming changes.

24 **Section 5** of this bill requires the Governor to appoint a committee on statewide  
25 school safety to review certain issues and make recommendations related to school  
26 safety and the well-being of pupils.

27 Existing law requires the board of trustees of a school district or the governing  
28 body of a charter school or a private school to establish a committee to develop,  
29 review and update, on an annual basis, one plan to be used by all schools in the  
30 school district or every charter school or private school, as applicable, to use in  
31 responding to a crisis, emergency or suicide. (NRS 388.241-388.245, 394.1685-  
32 394.1688) **Section 20** of this bill instead requires such a committee to develop a  
33 plan which constitutes the minimum requirements of a plan for a school to use.  
34 **Section 6** of this bill: (1) requires the Division of Emergency Management of the  
35 Department of Public Safety to report to the Legislature certain information relating  
36 to the plan used by a public school, charter school or private school in response to a  
37 crisis, emergency or suicide; and (2) authorizes the Division to conduct random  
38 audits of plans submitted to the Division by public schools or charter schools.  
39 **Sections 18-27** of this bill revise other provisions relating to the development,  
40 contents, approval and usage of plans used by a public school or charter school  
41 when responding to a crisis, emergency or suicide. **Section 36** of this bill requires  
42 the development committee that developed or reviewed and updated the plan used  
43 by a private school when responding to a crisis, emergency or suicide to provide a  
44 copy of the plan to the governing body of the school on or before July 1 of each  
45 year.

46 **Section 28** of this bill requires the statewide framework for providing and  
47 coordinating integrated student supports, which existing law specifies as the  
48 academic and nonacademic supports for pupils enrolled in public school and the  
49 families of such pupils, to include methods for: (1) engaging the parents and  
50 guardians of pupils; (2) assessing the social, emotional and academic development  
51 of pupils; and (3) screening, intervening and monitoring the social, emotional and  
52 academic progress of pupils. (NRS 388.885) **Section 7** of this bill requires the State  
53 Board of Education to develop nonbinding recommendations for the ratio of pupils  
54 to specialized instructional support personnel in public schools for kindergarten and  
55 grades 1 to 12, inclusive. **Section 7** also requires the board of trustees of each  
56 school district to develop a plan to achieve such ratios. **Section 7.5** of this bill  
57 requires a school safety specialist to be designated for each school district and each  
58 charter school. The school safety specialist will be responsible for reviewing  
59 policies and procedures and overseeing various other functions relating to school  
60 safety.



61 **Section 31** of this bill requires a person in charge of a school building to ensure  
62 that drills provided for the purpose of providing instruction to pupils in the  
63 appropriate procedures are followed in the event of a lockdown, fire or other  
64 emergency and the drills occur at different times during school hours.  
65 (NRS 392.450)

66 Existing law authorizes a board of county commissioners to impose a surcharge  
67 on certain telecommunications lines for the purpose of enhancement of the  
68 telephone system for reporting an emergency in the county and for the purpose of  
69 purchasing and maintaining portable event recording devices and vehicular event  
70 recording devices. (NRS 244A.7643) **Section 37** of this bill prescribes the entities  
71 authorized to use money from the surcharge to purchase and maintain recording  
72 devices, which include a school district that employs school police officers and  
73 certain other law enforcement and criminal justice agencies.

74 **Section 38** of this bill removes school police officers from the list of “category  
75 II” peace officers, thereby making school police officers “category I” peace officers  
76 with unrestricted duties. (NRS 289.470) **Sections 29 and 41** of this bill revise  
77 provisions relating to the jurisdiction and training of school police officers. **Section**  
78 **40** of this bill deems a board of trustees of a county school district that employs or  
79 appoints school police officers to be a “law enforcement agency” for the purposes  
80 of requiring such officers to wear portable event recording devices while on duty.

81 Existing law requires the principal of each public school to establish a plan to  
82 provide for the progressive discipline of pupils. (NRS 392.4644) **Section 32** of this  
83 bill revises such criteria by instead providing for restorative discipline. **Section 9** of  
84 this bill requires the Department to adopt requirements and methods for restorative  
85 discipline practices. **Section 33** of this bill authorizes, rather than requires, a pupil  
86 who is removed from school premises to be assigned to a temporary alternative  
87 placement.

88 Existing law authorizes the governing body of a charter school to contract with  
89 the board of trustees of the school district in which the charter school is located to  
90 provide school police officers. Existing law also requires the board of trustees of a  
91 school district to enter into a contract to provide school police officers to a charter  
92 school if the governing body of a charter school makes a request for the provision  
93 of school police officers. (NRS 388A.378, 388A.384) **Section 34** of this bill enacts  
94 a similar provision for a private school, including certain institutions that are not  
95 required to be licensed pursuant to chapter 394 of NRS.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** NRS 385A.240 is hereby amended to read as  
2 follows:

3 385A.240 1. The annual report of accountability prepared  
4 pursuant to NRS 385A.070 must include information on the  
5 attendance, truancy and transiency of pupils, including, without  
6 limitation:

7 (a) Records of the attendance and truancy of pupils in all grades,  
8 including, without limitation:

9 (1) The average daily attendance of pupils, for each school in  
10 the district and the district as a whole, including, without limitation,  
11 each charter school sponsored by the district.



1 (2) For each elementary school, middle school and junior  
2 high school in the district, including, without limitation, each charter  
3 school sponsored by the district that provides instruction to pupils  
4 enrolled in a grade level other than high school, information that  
5 compares the attendance of the pupils enrolled in the school with the  
6 attendance of pupils throughout the district and throughout this  
7 State. The information required by this subparagraph must be  
8 provided in consultation with the Department to ensure the accuracy  
9 of the comparison.

10 (b) The number of pupils in each grade who are retained in the  
11 same grade pursuant to NRS 392.033, 392.125 or 392.760, for each  
12 school in the district and the district as a whole, including, without  
13 limitation, each charter school sponsored by the district.

14 (c) The transiency rate of pupils for each school in the district  
15 and the district as a whole, including, without limitation, each  
16 charter school sponsored by the district. For the purposes of this  
17 paragraph, a pupil is not transient if the pupil is transferred to a  
18 different school within the school district as a result of a change in  
19 the zone of attendance by the board of trustees of the school district  
20 pursuant to NRS 388.040.

21 (d) The number of habitual truants reported for each school in  
22 the district and for the district as a whole, including, without  
23 limitation, the number who are:

24 (1) Reported to an attendance officer, a school police officer  
25 or a local law enforcement agency pursuant to paragraph (a) of  
26 subsection 2 of NRS 392.144;

27 (2) Referred to an advisory board to review school  
28 attendance pursuant to paragraph (b) of subsection 2 of NRS  
29 392.144; and

30 (3) Referred for the imposition of administrative sanctions  
31 pursuant to paragraph (c) of subsection 2 of NRS 392.144.

32 2. *The information included pursuant to subsection 1 must*  
33 *allow such information to be disaggregated by:*

34 (a) *Pupils who are economically disadvantaged;*

35 (b) *Pupils from major racial and ethnic groups;*

36 (c) *Pupils with disabilities;*

37 (d) *Pupils who are English learners;*

38 (e) *Pupils who are migratory children;*

39 (f) *Gender;*

40 (g) *Pupils who are homeless;*

41 (h) *Pupils in foster care; and*

42 (i) *Pupils whose parent or guardian is a member of the Armed*  
43 *Forces of the United States, a reserve component thereof or the*  
44 *National Guard.*

45 3. On or before September 30 of each year:



1 (a) The board of trustees of each school district shall submit to  
2 each advisory board to review school attendance created in the  
3 county pursuant to NRS 392.126 the information required by  
4 paragraph (a) of subsection 1.

5 (b) The State Public Charter School Authority, the Achievement  
6 School District and each college or university within the Nevada  
7 System of Higher Education that sponsors a charter school shall  
8 submit to each advisory board to review school attendance created  
9 in a county pursuant to NRS 392.126 the information regarding  
10 the records of the attendance and truancy of pupils enrolled in the  
11 charter school located in that county, if any, in accordance with the  
12 regulations prescribed by the Department pursuant to subsection 3  
13 of NRS 385A.070.

14 **Sec. 2.** NRS 385A.250 is hereby amended to read as follows:

15 385A.250 1. The annual report of accountability prepared  
16 pursuant to NRS 385A.070 must include information on the  
17 discipline of pupils, including, without limitation:

18 (a) Records of incidents involving weapons or violence for each  
19 school in the district, including, without limitation, each charter  
20 school sponsored by the district.

21 (b) Records of incidents involving the use or possession of  
22 alcoholic beverages or controlled substances for each school in the  
23 district, including, without limitation, each charter school sponsored  
24 by the district.

25 (c) Records of the suspension ~~and~~ *or* expulsion, *or both*, of  
26 pupils required or authorized pursuant to NRS 392.466 and 392.467.

27 (d) The number of pupils who are deemed habitual disciplinary  
28 problems pursuant to NRS 392.4655, for each school in the district  
29 and the district as a whole, including, without limitation, each  
30 charter school sponsored by the district.

31 (e) For each school in the district and the district as a whole,  
32 including, without limitation, each charter school sponsored by the  
33 district:

34 (1) The number of reported violations of NRS 388.135  
35 occurring at a school or otherwise involving a pupil enrolled at a  
36 school, regardless of the outcome of the investigation conducted  
37 pursuant to NRS 388.1351;

38 (2) The number of incidents determined to be bullying or  
39 cyber-bullying after an investigation is conducted pursuant to  
40 NRS 388.1351;

41 (3) The number of incidents resulting in suspension or  
42 expulsion, *or both*, for bullying or cyber-bullying; and

43 (4) Any actions taken to reduce the number of incidents of  
44 bullying or cyber-bullying including, without limitation, training



1 that was offered or other policies, practices and programs that were  
2 implemented.

3 (f) For each high school in the district, including, without  
4 limitation, each charter school sponsored by the district that operates  
5 as a high school, and for high schools in the district as a whole:

6 (1) The number and percentage of pupils whose violations of  
7 the code of honor relating to cheating prescribed pursuant to NRS  
8 392.461 or any other code of honor applicable to pupils enrolled in  
9 high school were reported to the principal of the high school,  
10 reported by the type of violation;

11 (2) The consequences, if any, to the pupil whose violation is  
12 reported pursuant to subparagraph (1), reported by the type of  
13 consequence;

14 (3) The number of any such violations of a code of honor in a  
15 previous school year by a pupil whose violation is reported pursuant  
16 to subparagraph (1), reported by the type of violation; and

17 (4) The process used by the high school to address violations  
18 of a code of honor which are reported to the principal.

19 2. *The information included pursuant to subsection 1 must*  
20 *allow such information to be disaggregated by:*

- 21 (a) *Pupils who are economically disadvantaged;*
- 22 (b) *Pupils from major racial and ethnic groups;*
- 23 (c) *Pupils with disabilities;*
- 24 (d) *Pupils who are English learners;*
- 25 (e) *Pupils who are migratory children;*
- 26 (f) *Gender;*
- 27 (g) *Pupils who are homeless;*
- 28 (h) *Pupils in foster care; and*
- 29 (i) *Pupils whose parent or guardian is a member of the Armed*  
30 *Forces of the United States, a reserve component thereof or the*  
31 *National Guard.*

32 3. As used in this section:

33 (a) "Bullying" has the meaning ascribed to it in NRS 388.122.

34 (b) "Cyber-bullying" has the meaning ascribed to it in

36 **Sec. 3.** NRS 385A.650 is hereby amended to read as follows:

37 385A.650 1. The principal of each school, including, without  
38 limitation, each charter school, shall, in consultation with the  
39 employees of the school, prepare a plan to improve the achievement  
40 of the pupils enrolled in the school.

41 2. The plan developed pursuant to subsection 1 must:

42 (a) Include any information prescribed by regulation of the State  
43 Board; ~~and~~

44 (b) *Include, without limitation, methods for evaluating and*  
45 *improving the school climate in the school; and*



1 (c) Comply with the provisions of 20 U.S.C. § 6311(d).  
2 3. The principal of each school shall, in consultation with the  
3 employees of the school:

4 (a) Review the plan prepared pursuant to this section annually to  
5 evaluate the effectiveness of the plan; and

6 (b) Based upon the evaluation of the plan, make revisions, as  
7 necessary, to ensure that the plan is designed to improve the  
8 academic achievement of pupils enrolled in the school.

9 4. On or before the date prescribed by the Department, the  
10 principal of each school shall submit the plan or the revised plan, as  
11 applicable, to the:

12 (a) Department;

13 (b) Committee;

14 (c) Bureau; and

15 (d) Board of trustees of the school district in which the school is  
16 located or, if the school is a charter school, the sponsor of the  
17 charter school and the governing body of the charter school.

18 *5. As used in this section, "school climate" means the basis of*  
19 *which to measure the relationships between pupils and the parents*  
20 *or legal guardians of pupils and educational personnel, the*  
21 *cultural and linguistic competence of instructional materials and*  
22 *educational personnel, the emotional and physical safety of pupils*  
23 *and educational personnel and the social, emotional and academic*  
24 *development of pupils and educational personnel.*

25 **Sec. 4.** Chapter 388 of NRS is hereby amended by adding  
26 thereto the provisions set forth as sections 5 to 7.5, inclusive, of this  
27 act.

28 **Sec. 5. 1.** *The Governor shall appoint a committee on*  
29 *statewide school safety. Appointments must be made to represent*  
30 *each of the geographic areas of the State.*

31 **2.** *The committee must consist of:*

32 (a) *One representative of the Department of Education;*

33 (b) *One representative of the Department of Public Safety;*

34 (c) *One representative of the Division of Emergency*  
35 *Management of the Department of Public Safety;*

36 (d) *One representative of the Department of Health and*  
37 *Human Services;*

38 (e) *One representative who is a licensed teacher in this State;*

39 (f) *One representative who is the principal of a school in this*  
40 *State;*

41 (g) *One superintendent of a school district in this State;*

42 (h) *One school resource officer assigned to a school in this*  
43 *State;*

44 (i) *One person employed as a paraprofessional, as defined in*  
45 *NRS 391.008, by a school in this State;*



- 1 (j) *One school psychologist employed by a school in this State;*
- 2 (k) *One provider of mental health other than a psychologist*
- 3 *who provides services to pupils at a school in this State;*
- 4 (l) *The State Fire Marshal or his or her designee;*
- 5 (m) *One parent or legal guardian of a pupil enrolled in a*
- 6 *school in this State;*
- 7 (n) *At least two pupils enrolled in a school in this State; and*
- 8 (o) *Any other representative the Governor deems appropriate.*

9 **3. The committee shall:**

10 (a) *Establish methods which facilitate the ability of a pupil*

11 *enrolled in a school in this State to express his or her ideas related*

12 *to school safety and the well-being of pupils enrolled in schools in*

13 *this State;*

14 (b) *Evaluate the impact of social media on school safety and*

15 *the well-being of pupils enrolled in schools in this State; and*

16 (c) *Discuss and make recommendations to the Governor and*

17 *the Department related to the findings of the committee.*

18 **4. As used in this section, "social media" has the meaning**

19 **ascribed to it in NRS 232.003.**

20 **Sec. 6. The Division of Emergency Management of the**

21 **Department of Public Safety:**

22 **1. Shall prepare a report regarding the extent to which:**

23 (a) *The board of trustees of each school district, governing*

24 *body of a charter school and each public school has complied with*

25 *the provisions of NRS 388.243 and 388.245; and*

26 (b) *Each private school has complied with the provisions of*

27 *NRS 394.1687 and 394.1688;*

28 **2. Shall, on or before January 1 of each year, submit the**

29 **report prepared pursuant to subsection 1 to the Director of the**

30 **Legislative Counsel Bureau for transmittal to the Legislature or, if**

31 **the Legislature is not in session, to the Legislative Committee on**

32 **Education; and**

33 **3. May conduct on a random basis audits of any plan**

34 **submitted pursuant to NRS 388.243 and 388.245.**

35 **Sec. 7. 1. The State Board shall develop nonbinding**

36 **recommendations for the ratio of pupils to specialized**

37 **instructional support personnel in this State for kindergarten and**

38 **grades 1 to 12, inclusive. The board of trustees of each school**

39 **district shall develop a 15-year strategic plan to achieve the ratio**

40 **of pupils to specialized instructional support personnel in the**

41 **district.**

42 **2. The recommendations developed by the State Board must:**

43 (a) *Prescribe a suggested ratio of pupils per each type of*

44 *specialized instructional support personnel in kindergarten and*

45 *grades 1 to 12, inclusive;*





1 (b) *Be based on evidence-based national standards; and*  
2 (c) *Take into account the unique needs of certain pupils,*  
3 *including, without limitation, pupils who are English learners.*

4 3. *As used in this section, "specialized instructional support*  
5 *personnel" includes persons employed by each school to provide*  
6 *necessary services such as assessment, diagnosis, counseling,*  
7 *educational services, therapeutic services and related services, as*  
8 *defined in 20 U.S.C. § 1401(26), to pupils. Such persons employed*  
9 *by a school include, without limitation:*

- 10 (a) *A school counselor;*  
11 (b) *A school psychologist;*  
12 (c) *A school social worker;*  
13 (d) *A school nurse;*  
14 (e) *A speech-language pathologist;*  
15 (f) *A school library media specialist; and*  
16 (g) *Any other qualified professional.*

17 **Sec. 7.5. 1.** *The superintendent of schools of each school*  
18 *district shall designate an employee at the district level to serve as*  
19 *the school safety specialist for the district. The principal of each*  
20 *charter school shall designate an employee to serve as the school*  
21 *safety specialist for the charter school. Not later than 1 year after*  
22 *being designated pursuant to this subsection, a school safety*  
23 *specialist shall complete the training provided by the Office for a*  
24 *Safe and Respectful Learning Environment pursuant to*  
25 *NRS 388.1323.*

26 2. *A school safety specialist shall:*

27 (a) *Review policies and procedures of the school district or*  
28 *charter school, as applicable, that relate to school safety to*  
29 *determine whether those policies and procedures comply with state*  
30 *laws and regulations;*

31 (b) *Ensure that each school employee who interacts directly*  
32 *with pupils as part of his or her job duties receives information*  
33 *concerning mental health services available in the school district*  
34 *or charter school, as applicable, and persons to contact if a pupil*  
35 *needs such services;*

36 (c) *Ensure the provision to school employees and pupils of*  
37 *appropriate training concerning:*

- 38 (1) *Mental health;*  
39 (2) *Emergency procedures, including, without limitation,*  
40 *the plan developed pursuant to NRS 388.243; and*  
41 (3) *Other matters relating to school safety and security;*

42 (d) *Annually conduct a school security risk assessment and*  
43 *submit the school security risk assessment to the Office for a Safe*  
44 *and Respectful Learning Environment for review pursuant to*  
45 *NRS 388.1323;*



1 (e) *Present a summary of the school security risk assessment*  
2 *conducted pursuant to paragraph (d) and any recommendations to*  
3 *improve school safety and security based on the assessment at a*  
4 *public meeting of the board of trustees of the school district or*  
5 *governing body of the charter school, as applicable;*

6 (f) *Not later than 30 days after the meeting described in*  
7 *paragraph (e), provide to the Director a summary of the school*  
8 *security risk assessment, any recommendations to improve school*  
9 *safety and security based on the assessment and any actions taken*  
10 *by the board of trustees or governing body, as applicable, based on*  
11 *those recommendations;*

12 (g) *Serve as the liaison for the school district or charter school,*  
13 *as applicable, with local public safety agencies, other*  
14 *governmental agencies, nonprofit organizations and the public*  
15 *regarding matters relating to school safety and security;*

16 (h) *At least once every 3 years, provide a tour of each school in*  
17 *the district or the charter school, as applicable, to employees of*  
18 *public safety agencies that are likely to be first responders to a*  
19 *crisis, emergency or suicide at the school; and*

20 (i) *Provide a written record to the board of trustees of the*  
21 *school district or the governing body of the charter school, as*  
22 *applicable, of any recommendations made by an employee of a*  
23 *public safety agency as a result of a tour provided pursuant to*  
24 *paragraph (h). The board of trustees or governing body, as*  
25 *applicable, shall maintain a record of such recommendations.*

26 3. *In a school district in a county whose population is*  
27 *100,000 or more, the school safety specialist shall collaborate with*  
28 *the emergency manager designated pursuant to NRS 388.262*  
29 *where appropriate in the performance of the duties prescribed in*  
30 *subsection 2.*

31 4. *As used in this section:*

32 (a) *“Crisis” has the meaning ascribed to it in NRS 388.231.*

33 (b) *“Emergency” has the meaning ascribed to it in*  
34 *NRS 388.233.*

35 **Sec. 8.** NRS 388.121 is hereby amended to read as follows:

36 388.121 As used in NRS 388.121 to 388.1395, inclusive, *and*  
37 *section 5 of this act*, unless the context otherwise requires, the  
38 words and terms defined in NRS 388.1215 to 388.127, inclusive,  
39 have the meanings ascribed to them in those sections.

40 **Sec. 9.** NRS 388.133 is hereby amended to read as follows:

41 388.133 1. The Department shall, in consultation with the  
42 governing bodies, educational personnel, local associations and  
43 organizations of parents whose children are enrolled in schools  
44 throughout this State, and individual parents and legal guardians  
45 whose children are enrolled in schools throughout this State,



1 prescribe by regulation a policy for all school districts and schools  
2 to provide a safe and respectful learning environment that is free of  
3 bullying and cyber-bullying.

4 2. The policy must include, without limitation:

5 (a) Requirements and methods for reporting violations of NRS  
6 388.135, including, without limitation, violations among teachers  
7 and violations between teachers and administrators, coaches and  
8 other personnel of a school district or school;

9 (b) Requirements and methods for addressing the rights and  
10 needs of persons with diverse gender identities or expressions; ~~and~~

11 (c) *Requirements and methods for restorative disciplinary*  
12 *practices; and*

13 (d) A policy for use by school districts and schools to train
