

SENATE BILL NO. 96—COMMITTEE ON  
COMMERCE, LABOR AND ENERGY

FEBRUARY 7, 2013

SUMMARY—Authorizes the imposition of an administrative penalty against an employer under certain circumstances. (BDR 53-579)

AN ACT relating to employment; authorizing the imposition of an administrative penalty against an employer who misclassifies an employee as an independent contractor or otherwise fails to properly classify a person as an employee of the employer under certain circumstances; and providing other matters properly relating thereto.

**Legislative Counsel’s Digest:**

1 Under existing law, the Labor Commissioner is required to enforce the labor  
2 laws and regulations of the State of Nevada. In carrying out that requirement, the  
3 Labor Commissioner may take any appropriate action against a person who violates  
4 those laws or regulations. Before enforcing an administrative penalty against the  
5 person, the Labor Commissioner is required to provide the person with notice and  
6 an opportunity for a hearing. (NRS 607.160) **Section 1** of this bill confers upon the  
7 Labor Commissioner the authority to impose an administrative penalty against an  
8 employer who misclassifies an employee as an independent contractor or otherwise  
9 fails to properly classify a person as an employee of the employer. **Section 1** sets  
10 forth the required amount of any administrative penalty imposed by the Labor  
11 Commissioner against the employer and, if the violation is a third or subsequent  
12 offense, requires the Secretary of State to revoke or suspend the state business  
13 license of the employer for not more than 3 years as determined by the Labor  
14 Commissioner. **Section 1** also authorizes the Labor Commissioner to impose the  
15 administrative penalty against the employer if the employer fails to prove to the  
16 satisfaction of the Labor Commissioner that the employee is not misclassified as an  
17 independent contractor or the employer did not otherwise fail to properly classify  
18 the person as an employee of the employer.

19 Under existing law, an employer is required to post a notice upon his or her  
20 premises identifying the employer’s industrial insurer and setting forth certain other



21 information concerning the employer. (NRS 616A.490) **Section 2** of this bill  
22 requires the employer to include in the notice the definitions of the terms  
23 “employee” and “independent contractor.”

24 **Section 3** of this bill subjects a person to liability in a civil action brought by  
25 the Attorney General if the person advises an employer or an employee, officer or  
26 agent of an employer to misrepresent the classification of an employee of the  
27 employer. **Section 3** also subjects the person to liability for an amount that is equal  
28 to three times the total amount of any reasonable expenses incurred by the State in  
29 enforcing the provisions of that section against the person.

THE PEOPLE OF THE STATE OF NEVADA, REPRESENTED IN  
SENATE AND ASSEMBLY, DO ENACT AS FOLLOWS:

1 **Section 1.** Chapter 613 of NRS is hereby amended by adding  
2 thereto a new section to read as follows:

3 *1. In addition to any other remedy or penalty, the Labor*  
4 *Commissioner may impose an administrative penalty against an*  
5 *employer who misclassifies an employee of the employer as an*  
6 *independent contractor or otherwise fails to properly classify a*  
7 *person as an employee of the employer. If imposed, the*  
8 *administrative penalty must be collected in the following amounts*  
9 *as determined by the Labor Commissioner:*

10 (a) *For a first offense:*

11 (1) *At least \$250 but less than \$1,000 for each employee or*  
12 *person who is misclassified unintentionally or is otherwise not*  
13 *properly classified unintentionally.*

14 (2) *At least \$5,000 but less than \$15,000 for each employee*  
15 *or person who is misclassified willfully or is otherwise not properly*  
16 *classified willfully.*

17 (b) *For a second offense, at least \$15,000 but less than \$25,000*  
18 *for each employee or person misclassified or otherwise not*  
19 *properly classified.*

20 (c) *For a third or subsequent offense, at least \$25,000 for each*  
21 *employee or person misclassified or otherwise not properly*  
22 *classified.*

23 *2. In addition to imposing an administrative penalty against*  
24 *an employer pursuant to paragraph (c) of subsection 1, the Labor*  
25 *Commissioner may submit a notice to the Secretary of State*  
26 *requiring the revocation or suspension of the state business*  
27 *license, if any, issued to the employer pursuant to chapter 76 of*  
28 *NRS. The Labor Commissioner shall provide a copy of the notice*  
29 *to the employer. If a state business license is issued to the*  
30 *employer, the Secretary of State shall, as soon as practicable after*  
31 *receiving the notice, revoke or suspend the state business license*  
32 *for not more than 3 years as specified in the notice.*



1       3. *Before the Labor Commissioner may enforce an*  
2 *administrative penalty against an employer pursuant to this*  
3 *section, the Labor Commissioner must provide the employer with*  
4 *notice and an opportunity for a hearing as set forth in NRS*  
5 *607.207. The Labor Commissioner may impose the administrative*  
6 *penalty against the employer if the employer, during any such*  
7 *hearing, fails to prove to the satisfaction of the Labor*  
8 *Commissioner that:*

9       (a) *The employee is not misclassified as an independent*  
10 *contractor; or*

11       (b) *The employer did not otherwise fail to properly classify the*  
12 *person as an employee of the employer,*

13       *↳ as applicable.*

14       4. *As used in this section:*

15       (a) *“Employee” has the meaning ascribed to it in*  
16 *NRS 608.010.*

17       (b) *“Employer” has the meaning ascribed to it in*  
18 *NRS 608.011.*

19       (c) *“Independent contractor” has the meaning ascribed to it in*  
20 *NRS 616A.255.*

21       **Sec. 2.** NRS 616A.490 is hereby amended to read as follows:

22       616A.490 *1.* Every employer shall post a notice upon his or  
23 her premises in a conspicuous place identifying the employer’s  
24 industrial insurer. The notice must include the insurer’s name,  
25 business address and telephone number and the name, business  
26 address and telephone number of its nearest adjuster in this State.  
27 The employer shall at all times maintain the notice provided for the  
28 information of his or her employees.

29       2. *In addition to the provisions of subsection 1, each notice*  
30 *posted pursuant to that subsection must prominently set forth the*  
31 *definition of “employee,” as defined in NRS 616A.105, and the*  
32 *definition of “independent contractor,” as defined in*  
33 *NRS 616A.255.*

34       **Sec. 3.** Chapter 616D of NRS is hereby amended by adding  
35 thereto a new section to read as follows:

36       1. *A person who, for money or other valuable consideration,*  
37 *knowingly advises an employer or any employee, officer or agent*  
38 *of an employer to misrepresent the classification or duties of an*  
39 *employee of the employer, including, without limitation,*  
40 *misrepresenting that the employee is an independent contractor, is*  
41 *liable in a civil action commenced by the Attorney General for:*

42       (a) *Not more than \$5,000 for the first occurrence;*

43       (b) *Not more than \$15,000 for the second occurrence; and*

44       (c) *Not more than \$25,000 for the third or any subsequent*  
45 *occurrence.*



- 1        ***2. In addition to any amount imposed pursuant to subsection***  
2 ***1, in any civil action against a person specified in that subsection,***  
3 ***the person is liable for an amount that is equal to three times the***  
4 ***total amount of any reasonable expenses incurred by the State in***  
5 ***enforcing the provisions of this section against the person.***  
6        ***3. Any money collected pursuant to this section must be used***  
7 ***to pay the salaries and other expenses of the Fraud Control Unit***  
8 ***for Industrial Insurance established pursuant to NRS 228.420.***  
9 ***Any money remaining at the end of any fiscal year does not revert***  
10 ***to the State General Fund.***
