SENATE CONCURRENT RESOLUTION—Creating a subcommittee of the Legislative Commission to study the Nevada Legislature.

1 WHEREAS, As the economy and population in this State
2 continue to change and evolve, the Nevada Legislature is called
3 upon to address increasingly complex issues and to discover new
4 ways in which to stimulate the economy and to address the needs of
5 a growing and often transient population; and

6 WHEREAS, In this changing environment, the Legislature must
7 find ways in which to obtain the knowledge and resources necessary
8 to efficiently and effectively resolve the important issues facing this
9 State; and

10 WHEREAS, An independent study of the structure and operation
11 of the Nevada Legislature is necessary to assist the Legislature in
12 discovering creative ways to become more responsive to and
13 effective in addressing the needs of the people of this State; now,
14 therefore, be it

15 RESOLVED BY THE SENATE OF THE STATE OF NEVADA, THE
16 ASSEMBLY CONCURRING, That the Legislative Commission's
17 Subcommittee on the Nevada Legislature, consisting of 15
18 members, is hereby created; and be it further

1 RESOLVED, That the Legislative Commission shall appoint the
2 members to the Subcommittee, none of whom may be current
3 Legislators, as follows:

4 1. Four members who are former Nevada Legislators, one of
5 whom is selected from nominations submitted by the Majority
6 Leader of the Senate, one of whom is selected from nominations
7 submitted by the Speaker of the Assembly, one of whom is selected
8 from nominations submitted by the Minority Leader of the Senate
9 and one of whom is selected from nominations submitted by the
10 Minority Leader of the Assembly; and

11 2. Eleven members who are not former Nevada Legislators,
12 who must be selected from nominations submitted by consensus of
13 the Speaker and the Minority Leader of the Assembly and the
14 Majority and Minority Leaders of the Senate to represent the public
15 at large; and be it further

16 RESOLVED, That, at its first meeting, the Subcommittee shall
17 elect a Chair and a Vice Chair from among its members; and be it
18 further

19 RESOLVED, That, during the 2013-2015 interim, the
20 Subcommittee shall:

21 1. Study the effectiveness of the current process for developing
22 a legislative budget;

23 2. Study the structure and operation of the Nevada Legislature,
24 including, without limitation, the compensation of Legislators and
25 the structure and operations of the interim committees of the Nevada
26 Legislature; and

27 3. Study the timing, frequency and length of regular legislative
28 sessions, including, without limitation, an examination of the
29 efficiency and effectiveness of annual regular legislative sessions;
30 and be it further

31 RESOLVED, That the Legislative Counsel Bureau shall provide
32 such staff and administrative services as necessary to carry out the
33 business of the Subcommittee; and be it further

34 RESOLVED, That while engaged in the business of the
35 Subcommittee, each member serves without salary but is entitled to
36 receive out of the Legislative Fund the per diem allowance and
37 travel expenses provided for state officers and employees generally;
38 and be it further

39 RESOLVED, That the Subcommittee shall submit a written
40 report of the results of its study to the Legislative Commission on or
41 before September 1, 2014, and may request the drafting of not
42 more than five legislative measures which relate to matters within
43 the scope of the study conducted by the Subcommittee, which must
44 be submitted in the manner prescribed pursuant to NRS 218D.160
