SENATE JOINT RESOLUTION NO. 6-SENATOR HANSEN

SUMMARY—Urges Congress to take any action necessary to ensure cooperation between this State, the Bureau of Land Management and the United States Forest Service in carrying out a program of mining reclamation in this State. (BDR R-1081)

SENATE JOINT RESOLUTION—Urging Congress to take any action necessary to ensure cooperation between this State, the Bureau of Land Management and the United States Forest Service in carrying out a program of mining reclamation in this State.

1 WHEREAS, In 1989, the Nevada Legislature enacted the 2 provisions of chapter 519A of NRS, which provide that any land 3 that is used in exploration projects and mining operations must be 4 reclaimed in accordance with an extensive program of reclamation; 5 and

6 WHEREAS, The purpose of the program of reclamation is to 7 return the land to a safe and stable condition to ensure public safety 8 and minimize adverse visual effects after exploration projects and 9 mining operations are completed; and

10 WHEREAS, The success of reclamation efforts in this State is 11 dependent upon cooperation among state and federal agencies; and

WHEREAS, The Division of Environmental Protection of the State Department of Conservation and Natural Resources is required to administer and enforce the program of reclamation in this State; and

16 WHEREAS, The Division is also required to enter into a 17 memorandum of understanding with the Bureau of Land





Management and the United States Forest Service concerning the
 adoption by those agencies of plans of reclamation which
 substantially provide for the reclamation and security required under
 chapter 519A of NRS for public lands in this State; and

5 WHEREAS, Because the activities of some operators of small 6 exploration projects and small mining operations may be managed 7 entirely by the Bureau of Land Management and the United States 8 Forest Service, the operators may also be subject to differing 9 requirements in conducting those activities on public lands, 10 including differences in the amount of land which may be disturbed 11 each year and the use of vehicles by the operators; and

WHEREAS, To ensure a successful program of reclamation in this State, all operators should be given uniform treatment under any memorandum of understanding entered into between the Division and the Bureau of Land Management and the United Forest Service and any applicable federal laws and regulations, including, without limitation, the General Mining Law of 1872, 30 U.S.C. §§ 22 et seq.; now, therefore, be it

19 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF 20 NEVADA, JOINTLY, That the members of the 80th Session of the Nevada Legislature hereby urge Congress to take any action 21 22 necessary to ensure, to the greatest extent practicable, cooperation 23 between this State, the Bureau of Land Management and the United 24 States Forest Service in carrying out a program of mining 25 reclamation in this State and any memorandum of understanding or 26 other agreement entered into pursuant to the program; and be it 27 further

RESOLVED, If required to ensure that cooperation, Congress is
further urged to amend the General Mining Law of 1872, 30 U.S.C.
§§ 22 et seq., and any other applicable federal law to ensure uniform
treatment of all operators of small exploration projects and small
mining operations on public lands in this State; and be it further

RESOLVED, That the Secretary of the Senate prepare and transmit a copy of this resolution to the Vice President of the United States as the presiding officer of the United States Senate, the Speaker of the United States House of Representatives and each member of the Nevada Congressional Delegation; and be it further
