SENATE JOINT RESOLUTION—Urging the Director of the Bureau of Land Management to expedite the process for approving special recreation permits for certain uses of federal public lands in Nevada.

- 1 WHEREAS, Outdoor recreation in Nevada generates \$14.9 billion
2 in consumer spending annually, creates 148,000 jobs and generates
3 \$4.8 billion in wages and salaries and \$1 billion in state and local
4 tax revenue; and
5 WHEREAS, Nevada has an abundance of federal public lands
6 suitable for outdoor recreation that are managed by the Bureau of
7 Land Management of the United States Department of the Interior;
8 and
9 WHEREAS, Operators of outdoor recreation-related businesses
10 are required to apply to the Bureau of Land Management for special



1 recreation permits for commercial and competitive uses of those
2 public lands; and

3 WHEREAS, The Bureau of Land Management has adopted
4 regulations, 43 C.F.R. Part 2930, Subpart 2932, which set forth the
5 procedure for applying for a special recreation permit; and

6 WHEREAS, The processing of special recreation permits by the
7 Bureau of Land Management is often slow; and

8 WHEREAS, The slow processing of special recreation permits by
9 the Bureau of Land Management deters outdoor recreation-related
10 businesses from operating effectively and profitably; and

11 WHEREAS, Expedited processing of special recreation permits
12 by the Bureau of Land Management would serve to create additional
13 jobs for Nevadans and generate additional state and local tax
14 revenue; now, therefore, be it

15 RESOLVED BY THE SENATE AND ASSEMBLY OF THE STATE OF
16 NEVADA, JOINTLY, That the Nevada Legislature hereby urges:

17 1. The Director of the Bureau of Land Management to expedite
18 the process of approving special recreation permits for commercial
19 and competitive uses of federal public lands in Nevada;

20 2. The Director of the Bureau of Land Management to amend
21 the provisions of 43 C.F.R. Part 2930, Subpart 2932, to further
22 expedite the process of approving special recreation permits; and

23 3. The Nevada Congressional Delegation to use its best efforts
24 to encourage the Director of the Bureau of Land Management to
25 expedite the process of approving special recreation permits for
26 commercial and competitive uses of federal public land in Nevada
27 and to make any necessary amendments to the provisions of 43
28 C.F.R. Part 2930, Subpart 2932; and be it further

29 RESOLVED, That the Secretary of the Senate prepare and
30 transmit a copy of this resolution to the Secretary of the Interior, the
31 Director of the Bureau of Land Management and each member of
32 the Nevada Congressional Delegation; and be it further

33 RESOLVED, That this resolution becomes effective upon
34 passage.
