**A BILL**

To amend section 3302.09 of the Revised Code 1  
regarding procedures for approval or disapproval 2  
of the state education plan for the federal 3  
Every Student Succeeds Act. 4

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That section 3302.09 of the Revised Code be 5  
amended to read as follows: 6

**Sec. 3302.09.** (A) Whenever the United States department of 7  
education makes changes in its policies or rules regarding 8  
implementation of the ~~No Child Left Behind~~ Every Student 9  
Succeeds Act of ~~2001~~ 2015, Pub. L. No. 114-95, the Ohio 10  
department of education shall submit a written description of 11  
those changes to each member of the standing committees on 12  
primary and secondary education of the senate and house of 13  
representatives. 14

(B) (1) The Ohio department of education shall submit to 15  
each member of the standing committees a written copy of the 16  
state plan that must be submitted to the United States 17

department of education under the Every Student Succeeds Act of 18  
2015, not later than thirty days prior to the date on which the 19  
Ohio department of education will begin implementation of the 20  
plan. 21

(2) If the Ohio department of education plans to change 22  
any of its policies or procedures regarding the state's 23  
implementation of the ~~No Child Left Behind~~ Every Student 24  
Succeeds Act of 2001-2015 based on changes in federal polices or 25  
rules described in division (A) of this section, the Ohio 26  
department of education shall submit to each member of the 27  
standing committees a written outline of the existing Ohio 28  
policy regarding that implementation and a written description 29  
of the changes it proposes to make. 30

(C) (1) The Ohio department of education shall not 31  
implement the state plan submitted under division (B) (1) of this 32  
section if the general assembly has adopted a concurrent 33  
resolution disapproving the plan prior to the date on which the 34  
plan is scheduled to be effective. 35

(2) On and after ~~July 1, 2005~~ the effective date of this 36  
amendment, the Ohio department of education shall not make any 37  
change proposed under division (B) (2) of this section unless the 38  
general assembly has adopted a concurrent resolution approving 39  
the proposed change. 40

**Section 2.** That existing section 3302.09 of the Revised 41  
Code is hereby repealed. 42
