BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4501.21 be amended and sections	6
4503.88, 4503.881, 4503.882, 4503.883, 4503.884, and 4503.885 of	7
the Revised Code be enacted to read as follows:	8
Sec. 4501.21. (A) There is hereby created in the state	9
treasury the license plate contribution fund. The fund shall	10
consist of all contributions paid by motor vehicle registrants	11
and collected by the registrar of motor vehicles pursuant to	12
sections 4503.491, 4503.492, 4503.493, 4503.494, 4503.496,	13
4503.498, 4503.499, 4503.50, 4503.501, 4503.502, 4503.505,	14
4503.51, 4503.522, 4503.523, 4503.524, 4503.525, 4503.526,	15

These 48 chapters shall use the money they receive under this section to49assist in paying the expenses they incur in providing services50directly to their clients.51

The registrar shall pay the contributions the registrar 52 receives pursuant to section 4503.496 of the Revised Code to the 53 Ohio sickle cell and health association, which shall use the 54 contributions to help support educational, clinical, and social 55 support services for adults who have sickle cell disease. 56

The registrar shall pay the contributions the registrar 57 receives pursuant to section 4503.498 of the Revised Code to 58 special olympics Ohio, inc., which shall use the contributions 59 for its programs, charitable efforts, and other activities. 60

The registrar shall pay the contributions the registrar 61 receives pursuant to section 4503.499 of the Revised Code to the 62 children's glioma cancer foundation, which shall use the 63 contributions for its research and other programs. 64

The registrar shall pay the contributions the registrar 65 receives pursuant to section 4503.50 of the Revised Code to the 66 future farmers of America foundation, which shall deposit the 67 contributions into its general account to be used for 68 educational and scholarship purposes of the future farmers of 69 America foundation. 70

The registrar shall pay the contributions the registrar 71 receives pursuant to section 4503.501 of the Revised Code to the 72 4-H youth development program of the Ohio state university 73 extension program, which shall use those contributions to pay 74 the expenses it incurs in conducting its educational activities. 75

The registrar shall pay the contributions received76pursuant to section 4503.502 of the Revised Code to the Ohio77

cattlemen's foundation, which shall use those contributions for 78 scholarships and other educational activities. 79 The registrar shall pay the contributions received 80 pursuant to section 4503.505 of the Revised Code to the 81 organization Ohio region phi theta kappa, which shall use those 82 contributions for scholarships for students who are members of 83 that organization. 84 The registrar shall pay each contribution the registrar 85 receives pursuant to section 4503.51 of the Revised Code to the 86 university or college whose name or marking or design appears on 87 collegiate license plates that are issued to a person under that 88 section. A university or college that receives contributions 89 from the fund shall deposit the contributions into its general 90 scholarship fund. 91 The registrar shall pay the contributions the registrar 92 receives pursuant to section 4503.522 of the Revised Code to the 93 "friends of Perry's victory and international peace memorial, 94 incorporated," a nonprofit corporation organized under the laws 95 of this state, to assist that organization in paying the 96

The registrar shall pay the contributions the registrar 99 receives pursuant to section 4503.523 of the Revised Code to the 100 fairport lights foundation, which shall use the money to pay for 101 the restoration, maintenance, and preservation of the 102 lighthouses of fairport harbor. 103

expenses it incurs in sponsoring or holding charitable,

educational, and cultural events at the monument.

The registrar shall pay the contributions the registrar104receives pursuant to section 4503.524 of the Revised Code to the105Massillon tiger football booster club, which shall use the106

contributions only to promote and support the football team of 107 Washington high school of the Massillon city school district. 108

The registrar shall pay the contributions the registrar 109 receives pursuant to section 4503.525 of the Revised Code to the 110 United States power squadron districts seven, eleven, twenty-111 four, and twenty-nine in equal amounts. Each power squadron 112 district shall use the money it receives under this section to 113 pay for the educational boating programs each district holds or 114 sponsors within this state. 115

The registrar shall pay the contributions the registrar 116 receives pursuant to section 4503.526 of the Revised Code to the 117 Ohio district Kiwanis foundation of the Ohio district of Kiwanis 118 international, which shall use the money it receives under this 119 section to pay the costs of its educational and humanitarian activities.

The registrar shall pay the contributions the registrar 122 receives pursuant to section 4503.531 of the Revised Code to the 123 thank you foundation, incorporated, a nonprofit corporation 124 organized under the laws of this state, to assist that 125 organization in paying for the charitable activities and 126 programs it sponsors in support of United States military 127 personnel, veterans, and their families. 128

The registrar shall pay the contributions the registrar 129 receives pursuant to section 4503.534 of the Revised Code to the 130 disabled American veterans department of Ohio, to be used for 131 programs that serve disabled American veterans and their 132 families. 133

The registrar shall pay the contributions the registrar 134 receives pursuant to section 4503.55 of the Revised Code to the 135

pro football hall of fame, which shall deposit the contributions136into a special bank account that it establishes and which shall137be separate and distinct from any other account the pro football138hall of fame maintains, to be used exclusively for the purpose139of promoting the pro football hall of fame as a travel140destination.141

The registrar shall pay the contributions that are paid to 142 the registrar pursuant to section 4503.545 of the Revised Code 143 to the national rifle association foundation, which shall use 144 the money to pay the costs of the educational activities and 145 programs the foundation holds or sponsors in this state. 146

The registrar shall pay to the Ohio pet fund the 147 contributions the registrar receives pursuant to section 148 4503.551 of the Revised Code and any other money from any other 149 source, including donations, gifts, and grants, that is 150 designated by the source to be paid to the Ohio pet fund. The 151 Ohio pet fund shall use the moneys it receives under this 152 section to support programs for the sterilization of dogs and 153 cats and for educational programs concerning the proper 154 veterinary care of those animals, and for expenses of the Ohio 155 pet fund that are reasonably necessary for it to obtain and 156 maintain its tax-exempt status and to perform its duties. 157

The registrar shall pay the contributions the registrar158receives pursuant to section 4503.552 of the Revised Code to the159rock and roll hall of fame and museum, incorporated.160

The registrar shall pay the contributions the registrar 161 receives pursuant to section 4503.553 of the Revised Code to the 162 Ohio coalition for animals, incorporated, a nonprofit 163 corporation. Except as provided in division (B) of this section, 164 the coalition shall distribute the money to its members, and the 165

members shall use the money only to pay for educational, 166 charitable, and other programs of each coalition member that 167 provide care for unwanted, abused, and neglected horses. The 168 Ohio coalition for animals may use a portion of the money to pay 169 for reasonable marketing costs incurred in the design and 170 promotion of the license plate and for administrative costs 171 incurred in the disbursement and management of funds received 172 under this section. 173

The registrar shall pay the contributions the registrar 174 receives pursuant to section 4503.554 of the Revised Code to the 175 Ohio state council of the knights of Columbus, which shall use 176 the contributions to pay for its charitable activities and 177 programs. 178

The registrar shall pay the contributions the registrar 179 receives pursuant to section 4503.561 of the Revised Code to the 180 state of Ohio chapter of ducks unlimited, inc., which shall 181 deposit the contributions into a special bank account that it 182 establishes. The special bank account shall be separate and 183 distinct from any other account the state of Ohio chapter of 184 ducks unlimited, inc., maintains and shall be used exclusively 185 for the purpose of protecting, enhancing, restoring, and 186 managing wetlands and conserving wildlife habitat. The state of 187 Ohio chapter of ducks unlimited, inc., annually shall notify the 188 registrar in writing of the name, address, and account to which 189 such payments are to be made. 190

The registrar shall pay the contributions the registrar 191 receives pursuant to section 4503.562 of the Revised Code to the 192 Mahoning river consortium, which shall use the money to pay the 193 expenses it incurs in restoring and maintaining the Mahoning 194 river watershed. 195

The registrar shall pay the contributions the registrar 196 receives pursuant to section 4503.564 of the Revised Code to 197 Antioch college for the use of the Glen Helen ecology institute 198 to pay expenses related to the Glen Helen nature preserve. 199

The registrar shall pay the contributions the registrar 200 receives pursuant to section 4503.576 of the Revised Code to the 201 Ohio state beekeepers association, which shall use those 202 contributions to promote beekeeping, provide educational 203 information about beekeeping, and to support other state and 204 local beekeeping programs. 205

The registrar shall pay to a sports commission created 206 pursuant to section 4503.591 of the Revised Code each 207 contribution the registrar receives under that section that an 208 applicant pays to obtain license plates that bear the logo of a 209 professional sports team located in the county of that sports 210 commission and that is participating in the license plate 211 program pursuant to division (E) of that section, irrespective 212 of the county of residence of an applicant. 213

The registrar shall pay to a community charity each214contribution the registrar receives under section 4503.591 of215the Revised Code that an applicant pays to obtain license plates216that bear the logo of a professional sports team that is217participating in the license plate program pursuant to division218(G) of that section.219

The registrar shall pay the contributions the registrar 220 receives pursuant to section 4503.67 of the Revised Code to the 221 Dan Beard council of the boy scouts of America. The council 222 shall distribute all contributions in an equitable manner 223 throughout the state to regional councils of the boy scouts. 224

The registrar shall pay the contributions the registrar 225 receives pursuant to section 4503.68 of the Revised Code to the 226 great river council of the girl scouts of the United States of 227 America. The council shall distribute all contributions in an 228 equitable manner throughout the state to regional councils of 229 the girl scouts. 230

The registrar shall pay the contributions the registrar 231 receives pursuant to section 4503.69 of the Revised Code to the 232 Dan Beard council of the boy scouts of America. The council 233 shall distribute all contributions in an equitable manner 234 throughout the state to regional councils of the boy scouts. 235

The registrar shall pay the contributions the registrar 236 receives pursuant to section 4503.701 of the Revised Code to the 237 Prince Hall grand lodge of free and accepted masons of Ohio, 238 which shall use the contributions for scholarship purposes. 239

The registrar shall pay the contributions the registrar 240 receives pursuant to section 4503.71 of the Revised Code to the 241 fraternal order of police of Ohio, incorporated, which shall 242 deposit the fees into its general account to be used for 243 purposes of the fraternal order of police of Ohio, incorporated. 244

The registrar shall pay the contributions the registrar 245 receives pursuant to section 4503.711 of the Revised Code to the 246 fraternal order of police of Ohio, incorporated, which shall 247 deposit the contributions into an account that it creates to be 248 used for the purpose of advancing and protecting the law 249 enforcement profession, promoting improved law enforcement 250 methods, and teaching respect for law and order. 251

The registrar shall pay the contributions received252pursuant to section 4503.712 of the Revised Code to Ohio253

The registrar shall pay the contributions received 258 pursuant to section 4503.713 of the Revised Code to the greater 259 Cleveland peace officers memorial society, which shall use those 260 contributions to honor law enforcement officers who have died in 261 the line of duty and support its charitable purposes. 262

The registrar shall pay the contributions the registrar 263 receives pursuant to section 4503.72 of the Revised Code to the 264 organization known on March 31, 2003, as the Ohio CASA/GAL 265 association, a private, nonprofit corporation organized under 266 Chapter 1702. of the Revised Code. The Ohio CASA/GAL association 267 shall use these contributions to pay the expenses it incurs in 268 administering a program to secure the proper representation in 269 the courts of this state of abused, neglected, and dependent 270 children, and for the training and supervision of persons 271 participating in that program. 272

The registrar shall pay the contributions the registrar273receives pursuant to section 4503.73 of the Revised Code to274Wright B. Flyer, incorporated, which shall deposit the275contributions into its general account to be used for purposes276of Wright B. Flyer, incorporated.277

The registrar shall pay the contributions the registrar 278 receives pursuant to section 4503.732 of the Revised Code to the 279 Siegel & Shuster society, a nonprofit organization dedicated to 280 commemorating and celebrating the creation of Superman in 281 Cleveland, Ohio. 282

The registrar shall pay the contributions the registrar 283 receives pursuant to section 4503.74 of the Revised Code to the 284 Columbus zoological park association, which shall disburse the 285 moneys to Ohio's major metropolitan zoos, as defined in section 286 4503.74 of the Revised Code, in accordance with a written 287 agreement entered into by the major metropolitan zoos. 288

The registrar shall pay the contributions the registrar 289 receives pursuant to section 4503.75 of the Revised Code to the 290 rotary foundation, located on March 31, 2003, in Evanston, 291 Illinois, to be placed in a fund known as the permanent fund and 292 used to endow educational and humanitarian programs of the 293 rotary foundation. 294

The registrar shall pay the contributions the registrar 295 receives pursuant to section 4503.751 of the Revised Code to the 296 Ohio association of realtors, which shall deposit the 297 contributions into a property disaster relief fund maintained 298 under the Ohio realtors charitable and education foundation. 299

The registrar shall pay the contributions the registrar 300 receives pursuant to section 4503.85 of the Revised Code to the 301 Ohio sea grant college program to be used for Lake Erie area 302 research projects. 303

The registrar shall pay the contributions the registrar 304 receives pursuant to section 4503.86 of the Revised Code to the 305 Ohio Lincoln highway historic byway, which shall use those 306 contributions solely to promote and support the historical 307 preservation and advertisement of the Lincoln highway in this 308 state. 309

pursuant to section 4503.92 of the Revised Code to support our373troops, incorporated, a national nonprofit corporation, which374shall use those contributions in accordance with its articles of375incorporation and for the benefit of servicemembers of the armed376forces of the United States and their families when they are in377financial need.378

The registrar shall pay the contributions the registrar 379 receives pursuant to section 4503.94 of the Revised Code to the 380 Michelle's leading star foundation, which shall use the money 381 solely to fund the rental, lease, or purchase of the simulated 382 driving curriculum of the Michelle's leading star foundation by 383 boards of education of city, exempted village, local, and joint 384 vocational school districts. 385

(C) All investment earnings of the license plate 386 contribution fund shall be credited to the fund.
