**A BILL**

To enact sections 5533.532, 5534.183, 5534.423, 1  
5534.486, 5534.497, 5534.499, 5534.614, 2  
5534.616, 5534.653, 5534.655, 5534.656, 3  
5534.659, 5534.661, 5534.663, 5534.664, 4  
5534.667, 5534.669, 5534.671, 5534.874, 5  
5534.875, 5534.876, 5534.914, 5534.921, 6  
5534.924, 5534.926, 5534.941, 5534.961, 7  
5534.963, 5534.964, 5534.966, and 5534.967 of 8  
the Revised Code to make multiple highway and 9  
bridge designations. 10

**BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:**

**Section 1.** That sections 5533.532, 5534.183, 5534.423, 11  
5534.486, 5534.497, 5534.499, 5534.614, 5534.616, 5534.653, 12  
5534.655, 5534.656, 5534.659, 5534.661, 5534.663, 5534.664, 13  
5534.667, 5534.669, 5534.671, 5534.874, 5534.875, 5534.876, 14

5534.914, 5534.921, 5534.924, 5534.926, 5534.941, 5534.961, 15  
5534.963, 5534.964, 5534.966, and 5534.967 of the Revised Code 16  
be enacted to read as follows: 17

Sec. 5533.532. In addition to any other name prescribed in 18  
the Revised Code or otherwise, the eastbound and westbound lanes 19  
of state route number eighty-seven between Bundysburg road and 20  
Madison road, in Geauga county, shall be known as the "John P. 21  
Lennon Memorial Highway." 22

The director of transportation may erect suitable markers 23  
along the highway indicating its name. 24

Sec. 5534.183. In addition to any other name prescribed in 25  
the Revised Code or otherwise, the northbound and southbound 26  
lanes of state route number one hundred eighty-five between 27  
Burns road and Progress way, in Darke county, shall be known as 28  
the "LCpl Gerald Subler Memorial Highway." 29

The director of transportation may erect suitable markers 30  
along the highway indicating its name. 31

Sec. 5534.423. In addition to any other name prescribed in 32  
the Revised Code or otherwise, that portion of the highway known 33  
as interstate route number seventy-six, between Lakewood road 34  
and Industry road, in Portage county, shall be known as the 35  
"Patrolman William J. Keller Memorial Highway." 36

The director of transportation may erect suitable markers 37  
along the highway indicating its name. 38

Sec. 5534.486. In addition to any other name prescribed in 39  
the Revised Code or otherwise, that portion of the road known as 40  
state route number ninety-seven, running in a northwesterly and 41  
southeasterly direction between the municipal corporations of 42  
Bellville and Butler, in Richland county, shall be known as the 43

"Firefighter Charles D. Swank Memorial Highway." 44

The director of transportation may erect suitable markers 45  
along the highway indicating its name. 46

**Sec. 5534.497.** In addition to any other name prescribed in 47  
the Revised Code or otherwise, the northbound and southbound 48  
lanes of state route number two hundred thirty-six between state 49  
route ninety-three, in Summit county, and Lafayette drive, in 50  
Stark county, shall be known as the "Patrolman Sean VanDenberg 51  
Memorial Highway." 52

The director of transportation may erect suitable markers 53  
along the highway indicating its name. 54

**Sec. 5534.499.** In addition to any other name prescribed in 55  
the Revised Code or otherwise, the northeastbound and 56  
southwestbound lanes of United States route number twenty 57  
between Center road and Gerald road, in Ashtabula county, shall 58  
be known as the "Corporal John E. Ruch Memorial Highway." 59

The director of transportation may erect suitable markers 60  
along the highway indicating its name. 61

**Sec. 5534.614.** In addition to any other name prescribed in 62  
the Revised Code or otherwise, the northbound and southbound 63  
lanes of United States route number one hundred twenty-seven 64  
between road number one hundred twenty-six and Paulding county 65  
road number sixty, in Paulding county, shall be known as the 66  
"Staff Sgt. Zachary Wobler Memorial Highway." 67

The director of transportation may erect suitable markers 68  
along the highway indicating its name. 69

**Sec. 5534.616.** The bridge spanning Indian creek, located 70  
immediately outside the municipal corporation of Versailles in 71

Darke county, and being a part of the road known as state route 72  
number forty-seven, shall be known as the "SSgt Gene F. Morrison 73  
Memorial Bridge." 74

The director of transportation may erect suitable markers 75  
upon the bridge or its approaches indicating its name. 76

**Sec. 5534.653.** In addition to any other name prescribed in 77  
the Revised Code or otherwise, the northbound and southbound 78  
lanes of interstate route number seventy-one between the border 79  
of Franklin and Delaware counties and the border of Delaware and 80  
Morrow counties, in Delaware county, shall be known as the 81  
"Delaware County Veterans Memorial Highway." 82

The director of transportation may erect suitable markers 83  
along the highway indicating its name. 84

**Sec. 5534.655.** The bridge spanning state route number 85  
eleven, located in Vienna township in Trumbull county and being 86  
a part of the road known as Niles Vienna road, shall be known as 87  
the "Vienna Township Veterans Bridge." 88

The director of transportation may erect suitable markers 89  
upon the bridge or its approaches indicating its name. 90

**Sec. 5534.656.** In addition to any other name prescribed in 91  
the Revised Code or otherwise, the northeastbound and 92  
southwestbound lanes of state route number seven between archers 93  
fork road and Grandview hill road, in Washington county, shall 94  
be known as the "Specialist Five Frederick Wayne Taylor Memorial 95  
Highway." 96

The director of transportation may erect suitable markers 97  
along the highway indicating its name. 98

**Sec. 5534.659.** In addition to any other name prescribed in 99

the Revised Code or otherwise, the northbound and southbound 100  
lanes of United States route number sixty-eight between the 101  
intersections of Dallas road and Hickory Grove road, in 102  
Champaign county, shall be known as the "Army Corporal Charles 103  
E. Hiltibran Memorial Highway." 104

The director of transportation may erect suitable markers 105  
along the highway indicating its name. 106

**Sec. 5534.661.** In addition to any other name prescribed in 107  
the Revised Code or otherwise, the eastbound and westbound lanes 108  
of state route number one hundred seventy-two between 109  
seventeenth street NW and thirty-second street NW, in Stark 110  
county, shall be known as the "Sgt. Cory M. Endlich Corridor." 111

The director of transportation may erect suitable markers 112  
along the highway indicating its name. 113

**Sec. 5534.663.** In addition to any other name prescribed in 114  
the Revised Code or otherwise, the eastbound and westbound lanes 115  
of state route number one hundred sixty-three between Fostoria 116  
road and Hartshorn road, in Ottawa county, shall be known as the 117  
"Ottawa County Veterans Memorial Highway." 118

The director of transportation may erect suitable markers 119  
along the highway indicating its name. 120

**Sec. 5534.664.** In addition to any other name prescribed in 121  
the Revised Code or otherwise, the northbound and southbound 122  
lanes of state route number forty-four between Prouty road and 123  
Mentor avenue, in Lake county, shall be known as the "Lance 124  
Corporal Austin B. Schwenk Memorial Highway." 125

The director of transportation may erect suitable markers 126  
along the highway indicating its name. 127

Sec. 5534.667. In addition to any other name prescribed in 128  
the Revised Code or otherwise, the northbound and southbound 129  
lanes of United States route number sixty-eight between the 130  
intersections of township road number two hundred nineteen east 131  
and county road number thirty-seven, in Logan county, shall be 132  
known as the "Army PFC Herbert S. Bechtel Memorial Highway." 133

The director of transportation may erect suitable markers 134  
along the highway indicating its name. 135

Sec. 5534.669. In addition to any other name prescribed in 136  
the Revised Code or otherwise, the northbound and southbound 137  
lanes of state route number two hundred thirty-five between the 138  
intersections of township road number forty-three and state 139  
route number forty-seven, in Logan county, shall be known as the 140  
"Patrolman Frank J. Hossler Memorial Highway." 141

The director of transportation may erect suitable markers 142  
along the highway indicating its name. 143

Sec. 5534.671. In addition to any other name prescribed in 144  
the Revised Code or otherwise, the eastbound and westbound lanes 145  
of state route number one hundred sixty-one in Licking county 146  
shall be known as the "Licking County Veterans Memorial 147  
Highway." 148

The director of transportation may erect suitable markers 149  
along the highway indicating its name. 150

Sec. 5534.874. In addition to any other name prescribed in 151  
the Revised Code or otherwise, that portion of United States 152  
route number thirty-three commencing at mile marker twenty-four 153  
and proceeding in an easterly direction to mile marker twenty- 154  
nine, in Auglaize county, shall be known as the "Army SSgt. 155  
Charles V. Kettler Memorial Highway." 156

The director of transportation may erect suitable markers 157  
along the highway indicating its name. 158

**Sec. 5534.875.** In addition to any other name prescribed in 159  
the Revised Code or otherwise, that portion of state route 160  
number twenty-nine between mile marker twenty and mile marker 161  
twenty-five, in Auglaize county, shall be known as the "Army 162  
Sgt. Herbert C. Linville Memorial Highway." 163

The director of transportation may erect suitable markers 164  
along the highway indicating its name. 165

**Sec. 5534.876.** In addition to any other name prescribed in 166  
the Revised Code or otherwise, that portion of state route 167  
number sixty-six between mile marker twenty-nine and mile marker 168  
thirty-two, in Auglaize county, shall be known as the "Army Sgt. 169  
Ronnie Blair Memorial Highway." 170

The director of transportation may erect suitable markers 171  
along the highway indicating its name. 172

**Sec. 5534.914.** In addition to any other name prescribed by 173  
the Revised Code or otherwise, the northbound and southbound 174  
lanes of state route number thirteen, between Lexington road and 175  
Beckley road, in Knox county, shall be known as the "William 176  
'Bill' Burgett Memorial Highway." 177

The director of transportation may erect suitable markers 178  
along the highway indicating its name. 179

**Sec. 5534.921.** In addition to any other name prescribed in 180  
the Revised Code or otherwise, the northbound and southbound 181  
lanes of state route number seven between Washington boulevard 182  
and Western reserve road, in Mahoning county, shall be known as 183  
the "Clarence "Sonny" Smith, Jr. Highway." 184

The director of transportation may erect suitable markers 185  
along the highway indicating its name. 186

**Sec. 5534.924.** In addition to any other name prescribed in 187  
the Revised Code or otherwise, the portion of the road known as 188  
state route number eighty-seven, running in an easterly and 189  
westerly direction, between state route number forty-four and 190  
Sperry road, in Geauga county, shall be known as the "Dr. Steven 191  
Takacs Memorial Highway." 192

The director of transportation may erect suitable markers 193  
along the highway indicating its name. 194

**Sec. 5534.926.** In addition to any other name prescribed in 195  
the Revised Code or otherwise, the eastbound and westbound lanes 196  
of interstate route number seventy between the eastern and 197  
western borders of Etna township, in Licking County, shall be 198  
known as the "Tuscarawas Valley Memorial Highway." 199

The director of transportation may erect suitable markers 200  
along the highway indicating its name. 201

**Sec. 5534.941.** In addition to any other name prescribed in 202  
the Revised Code or otherwise, the portion of the road known as 203  
state route number two hundred sixty-nine, running in a 204  
northerly and southerly direction, between west Lucas street and 205  
Oxbo road, in the municipal corporation of Castalia, shall be 206  
known as the "Scott G. Gast Memorial Highway." 207

The director of transportation may erect suitable markers 208  
along the highway indicating its name. 209

**Sec. 5534.961.** In addition to any other name prescribed by 210  
the Revised Code or otherwise, the northbound and southbound 211  
lanes of United States route number thirty-three, between north 212  
plains road and Columbus road, in Athens county, shall be known 213



as the "Joe Burrow Highway." 214

The director of transportation may erect suitable markers 215  
along the highway indicating its name. 216

**Sec. 5534.963.** In addition to any other name prescribed in 217  
the Revised Code or otherwise, the portion of the road known as 218  
state route number thirty-nine, running in a northwesterly and 219  
southeasterly direction, between state route number four hundred 220  
thirty and interstate route number seventy-one, in Richland 221  
county, shall be known as the "SM1 Cornelius Anthony McCafferty, 222  
Jr. Memorial Highway." 223

The director of transportation may erect suitable markers 224  
along the highway indicating its name. 225

**Sec. 5534.964.** In addition to any other name prescribed by 226  
the Revised Code or otherwise, the eastbound and westbound lanes 227  
of state route number one hundred twenty-five, between rocky 228  
fork road and United States route number fifty-two, in Scioto 229  
county, shall be known as the "Al Oliver Highway." 230

The director of transportation may erect suitable markers 231  
along the highway indicating its name. 232

**Sec. 5534.966.** The interchange of interstate route number 233  
four hundred eighty and west one hundred fiftieth street, 234  
located in the municipal corporation of Cleveland in Cuyahoga 235  
county, shall be known as the "Louis P. Shuster Memorial 236  
Interchange." 237

The director of transportation may erect suitable markers 238  
at the interchange indicating its name. 239

**Sec. 5534.967.** In addition to any other name prescribed in 240  
the Revised Code or otherwise, the northeastbound and 241

southwestbound lanes of state route number ten between west 242  
forty-seventh street and west fiftieth street, in the municipal 243  
corporation of Cleveland in Cuyahoga county, shall be known as 244  
"Gallagher Way." 245

The director of transportation may erect suitable markers 246  
along the highway indicating its name. 247
