	nonprofit organization to sell beer at events	3
	that benefit the nonprofit organization.	4

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That section 4303.2011 of the Revised Code be	5
enacted to read as follows:	6
Sec. 4303.2011. (A) As used in this section, "nonprofit	7
organization" means a charitable organization that has received	8
from the internal revenue service a determination letter that is	9
currently in effect stating that the organization is exempt from	10
federal income taxation under subsection 501(a) of the Internal	11
Revenue Code.	12
(B) Subject to division (C) of this section, the division	13
of liquor control may issue an F-12 permit to a nonprofit	14
organization to sell beer at an event held by the nonprofit	15
organization if the proceeds of the event benefit the nonprofit	16
organization. An F-12 permit holder may sell beer at not more	17

than four such events per month during the time period that the	18
F-12 permit is valid. Each event held by the nonprofit	19
organization under an F-12 permit shall not exceed three days in	20
duration.	21
(C) The division may issue an F-12 permit to a nonprofit	22
organization only if the premises of the event for which the F-	23
12 permit is sought is located in a precinct, or at a particular	24
location in a precinct, in which the sale of beer is otherwise	25
permitted by law.	26
(D)(1) The fee for an F-12 permit is nine hundred dollars.	27
(2) The division may issue an F-12 permit for a period not	28
to exceed nine months.	29
(3) An F-12 permit is not transferable or renewable.	30
However, the holder of an expired F-12 permit may apply for a	31
new F-12 permit at any time after such expiration.	32
(E)(1) An F-12 permit holder may purchase beer from the	33
holder of an A-1, A-1c, or B-1 permit for purposes of an event	34
held under this section.	35
(2) Prior to an event held by an F-12 permit holder, the	36
permit holder shall provide notice of the event to the division	37
of liquor control, the department of public safety, and the	38
chief, sheriff, or other principal peace officer of the local	39
law enforcement agencies having jurisdiction over the permit	40
premises. The F-12 permit holder shall not conduct beer sales or	41
allow beer sales to be conducted at an event unless the permit	42
holder has provided such notice.	43
(3) An F-12 permit holder shall ensure that the premises	44
of the event for which an F-12 permit is issued is clearly	45
defined and sufficiently restricted to allow proper enforcement	46
