A BILL
To amend sections 4503.47, 4503.471, 4503.71, and 4503.711 of the Revised Code to eliminate the 2 Bureau of Motor Vehicles administrative fee for 3 nonstandard license plates related to 4 firefighters and police officers. 5

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 4503.47, 4503.471, 4503.71, and 6 4503.711 of the Revised Code be amended to read as follows: 7

Sec. 4503.47. (A) Any person who is a volunteer 8
firefighter may apply to the registrar of motor vehicles for the 9 registration of one passenger car or other vehicle of a class 10 approved by the registrar the person owns or leases. The 11 application shall be accompanied by such written evidence as the 12 registrar may require by rule, that the person is a volunteer 13 firefighter. 14

Upon receipt of an application for the registration of a 15
