<b>Section 1.</b> That section 2305.52 of the Revised Code be	4

Sec. 2305.52. (A) Except as provided in division (B) of	6
this section, a provision, clause, covenant, or agreement	7
contained in, collateral to, or affecting a motor carrier	8
transportation contract that purports to indemnify, defend, or	9
hold harmless, or has the effect of indemnifying, defending, or	10
holding harmless, the promisee from or against any liability for	11
loss or damage resulting from the negligence or intentional acts	12
or omissions of the promisee is void as against public policy.	13

(C) For purposes of this section:	19
(1) "Motor carrier" has the same meaning as in section	20
4923.01 of the Revised Code.	21
(2) "Motor carrier transportation contract" means a	22
contract, agreement, or understanding covering any of the	23

(a) The transportation of property for compensation or	25
hire by a motor carrier;	26
(b) Entrance onto property by a motor carrier for the	27
purpose of loading, unloading, or transporting property for	28

(3) "Promisee" means the person who enters into a motor	32
carrier transportation contract with a motor carrier. "Promisee"	33
includes any agent, employee, servant, or independent contractor	34
who is directly responsible to the promisee. "Promisee" does not	35
include a motor carrier who is a party to a motor carrier	36
transportation contract with the promisee, and that motor	37
carrier's agents, employees, servants, or independent	38
contractors directly responsible to that motor carrier.	39
