BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES OF THE STATE OF OHIO:

WHEREAS, Following the September 11, 2001, attacks, the	6	
United States invaded Afghanistan and, with the help of allies,	7	
drove the Taliban from power; and	8	
WHEREAS, In the two decades of war, over 2,400 United	9	
States service members, over 3,800 United States contractors,	10	
and over 1,100 allied service members have been killed in	11	
theater; and	12	
WHEREAS, On February 29, 2020, the United States and the	13	
Taliban signed a conditional peace deal, which required that	14	
United States troops be withdrawn from Afghanistan within		
fourteen months so long as the Taliban complied with the terms		
of the agreement, specifically not to allow any of its members,	17

other individuals or groups, including Al Qaeda, to use the soil	18	
of Afghanistan to threaten the security of the United States and	19	
its allies; and	20	
WHEREAS, President Joseph R. Biden rushed decisions to	21	
withdraw United States troops without taking into account the	22	
national security interests of the United States; and	23	
WHEREAS, President Biden and his administration failed to	24	
properly prepare the Afghanistan military for a withdrawal of	25	
United States troops from Afghanistan; and	26	
WHEREAS, The administration failed to have well-prepared	27	
contingency plans for the evacuation of United States citizens,	28	
personnel, and allies from the embassy, the Capital, and	29	
elsewhere in Afghanistan; and	30	
WHEREAS, On August 15, 2021, the Taliban took control of	31	
the country of Afghanistan, including the capital city of Kabul;	32	
and	33	
WHEREAS, President Biden's decisions have jeopardized the	34	
economic and social freedoms enjoyed by the people of	35	
Afghanistan; and	36	
WHEREAS, The people of Afghanistan, particularly women,	37	
girls, political activists, journalists, and those who have been	38	
outspoken about the Taliban, face the threat of arrest, torture,	39	
and possibly death at the hands of the Taliban; and	40	
WHEREAS, The precipitous withdrawal from Afghanistan may	41	
cause United States allies to question the resolve of the United	42	
States to defend freedom abroad; and	43	
WHEREAS, The withdrawal put American lives in harm's way,	44	
and further jeopardized American troops who are in or who are	45	
heading to Afghanistan to facilitate the evacuation; now	46
