A BILL

To enact a 17-day interim budget.

BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. Within the limits set forth in this act, the	2
Director of Budget and Management shall establish accounts	3
indicating the source and amount of funds for each appropriation	4
made in this act, and shall determine the form and manner in	5
which appropriation accounts shall be maintained.	6
Section 2. (A) Except as provided in divisions (B), (C),	7
(E), (F), and (G) of this section, there is hereby appropriated	8
for the period July 1, 2019, through July 17, 2019, to each	9
agency, board, commission, department, office, authority, or	10
other organization for which an appropriation was made by the	11
132nd General Assembly, including the legislative and judicial	12
oranches and their respective agencies, out of money in the	13
state treasury to the credit of the respective funds of the	14
state from which appropriations were made for the 2019 fiscal	15
year, for each specific item for which an appropriation was made	16

by the 132nd General Assembly, taking into account Controlling	17
Board actions and executive budget reductions, an amount equal	18
to the following:	19
(1) For General Revenue Fund appropriation items, one	20
hundred per cent of one twenty-second of each item's expenditure	21
levels for the 2019 fiscal year.	22
(2) For federal, dedicated purpose, or proprietary	23
appropriation items, one hundred per cent of one twenty-second	24
of each item's expenditure levels for the 2019 fiscal year.	25
(B) There is hereby appropriated from the money in the	26
state treasury for the period July 1, 2019, through July 17,	27
2019, an amount sufficient to make the following payments based	28
on each item's expenditure level for the 2019 fiscal year as	29
determined by the Director of Budget and Management:	30
(1) Payments to schools from appropriation items 200550,	31
Foundation Funding, 200502, Pupil Transportation, and 200540,	32
Special Education Enhancements, in the same manner as made in	33
fiscal year 2019;	34
(2) Payments to institutions of higher education from	35
appropriation item 235501, State Share of Instruction, in the	36
same manner as made in fiscal year 2019;	37
(3) Necessary payments to Medicaid providers incurred for	38
appropriation items 651525, Medicaid/Health Care Services, and	39
651526, Medicare Part D. Rates reimbursed for providers shall be	40
the same as rates on June 30, 2019;	41
(4) Payments necessary for the wages, benefits, and other	42
payroll-related expenses of state employees who are paid	43
directly by warrant of the Director of Budget and Management,	44
including elected state officials;	45

(5) Payments necessary to reappropriate the unexpended	46
balance of operating appropriations or reappropriations that a	47
state agency lawfully encumbered prior to the close of fiscal	48
year 2019;	49
(6) Payments necessary to support mission critical	50
expenditures through July 17, 2019, that are not otherwise	51
authorized in this act.	52
(C) No money is appropriated or shall be expended as	53
follows:	54
(1) For programs or agencies that were terminated by	55
action of law, other than the expiration of an appropriation	56
item, prior to June 30, 2019;	57
(2) For any program that is new or to the extent it has	58
been expanded other than by operation of law;	59
(3) For any purpose for which appropriations are made	60
elsewhere in this act;	61
(4) For purposes that have full fiscal year 2020	62
appropriations by another act of the General Assembly.	63
(D) The Director of Budget and Management shall make any	64
determinations necessary to decide which provision applies from	65
this section. Any expenditures authorized by the Director of	66
Budget and Management under this section are hereby	67
appropriated. The Director of Budget and Management may transfer	68
cash between funds as needed for this purpose.	69
(E) There is hereby appropriated amounts necessary to	70
fully pay debt service and financing costs, and lease rental	71
payments pursuant to lease agreements, for fiscal years 2020 and	72
2021 on bonds and notes, or other obligations of the state	73

issued under the Ohio Constitution and acts of the General	74
Assembly.	75
(F) There is hereby appropriated from the money in the	76
state treasury an amount necessary to fully pay the state's	77
costs incurred for the 2020 fiscal year due to the homestead	78
exemption, the manufactured home property tax rollback, the	79
property tax rollback, and other payments required under	80
division (C) of section 5705.2110 of the Revised Code.	81
(G) There is hereby appropriated from the money in the	82
state treasury an amount equal to one hundred per cent of the	83
expenditure levels for the 2019 fiscal year for Fund 3AS0	84
appropriation item 050616, Help America Vote Act.	85
(H) The General Revenue Fund appropriations contained in	86
this act for the Auditor of State shall be allocated across the	87
following appropriation items as determined by the Director of	88
Budget and Management in consultation with the Auditor of State:	89
070401, Audit Management and Services; 070402, Performance	90
Audits; 070403, Fiscal Watch/Emergency Technical Assistance;	91
070404, Fraud/Corruption Audits and Investigations; 070412,	92
Local Government Audit Support.	93
Section 3. All appropriations contained in this act shall	94
be cumulative with any subsequent appropriation act of the 133rd	95
General Assembly, and the Director of Budget and Management	96
shall account for expenditures from appropriations contained in	97
this act accordingly.	98
Section 4. The Director of Budget and Management shall	99
determine the surplus General Revenue Fund revenue that existed	100
on June 30, 2019. Notwithstanding section 131.44 of the Revised	101
Code, the surplus shall remain in the General Revenue Fund.	102

exempt from the referendum under Ohio Constitution, Article II,	104
Section 1d and section 1.471 of the Revised Code, and therefore	105
take effect immediately when this act becomes law.	106
