Any amounts set aside for a 64 fiscal year by a board or commission to allow for the payment of 65 fees shall be used only for the services performed by the agency 66 in that fiscal year. All receipts collected by the agency shall 67 be deposited in the state treasury to the credit of the central 68 service agency fund, which is hereby created. All expenses 69 incurred by the agency in performing services for the boards or 70 (F) Nothing in this section shall be construed as a grant of authority for the central service agency to initiate or deny personnel or fiscal actions for the boards and commissions.

Sec. 4112.12. (A) There is hereby created the commission 75 on African-American malesAfrican-Americans, which shall consist 76 of not more than twenty-five twelve members as follows: the 77 78 directors or their designees of the departments of health, development, mental health and addiction services, and job and 79 80 family services; the equal employment opportunity officer of the department of administrative services or the equal employment-81 opportunity officer's designee; the executive director or the 82 executive director's designee of the Ohio civil rights-83 commission; the executive director or the executive director's 84 designee of the division of criminal justice services in the 85 department of public safety; the superintendent of public 86 instruction; the chancellor or the chancellor's designee of the 87 Ohio board of regents; two members of the house of 88 representatives appointed by the speaker of the house of 89 representatives each of whom shall be members of different 90 political parties; and two members of the senate appointed by 91 the president of the senate each of whom shall be members of 92 different political parties. The members who are members of the 93 general assembly shall be nonvoting members. The Ohio state 94 95 university African American and African studies community extension Bell national resource center, in consultation with 96 the governor, shall appoint four two members from the private 97 corporate sector, at least four members from the public sector, 98 and two members from or the nonprofit sector, and one member 99 with experience in the philanthropic community. 100

(B) Terms of office shall be for three years, except that 101 members of the general assembly appointed to the commission 102 shall be members only so long as they are members of the general 103 assembly. Each term ends on the same day of the same month as 104 did the term that it succeeds. Each member shall hold office 105 from the date of appointment until the end of the term for which 106 the member was appointed. Members may be reappointed. Vacancies 107 shall be filled in the manner provided for original 108 appointments. Any member appointed to fill a vacancy occurring 109 prior to the expiration date of the term for which the member's 110 predecessor was appointed shall hold office as a member for the 111 remainder of that term. A member shall continue in office 112 subsequent to the expiration date of the member's term until the 113 member's successor takes office or until a period of sixty days 114 has elapsed, whichever occurs first. 115

The commission annually shall elect a chairperson from 116 among its members. 117

(C) Members of the commission and members of subcommittees
appointed under division (B) of section 4112.13 of the Revised
Code shall not be compensated, but shall be reimbursed for their
necessary and actual expenses incurred in the performance of
their official duties.

(D) The Ohio state university African American and African 123 studies community extension Bell national resource center, in 124 consultation with the governor, shall appoint an executive 125 director of the commission on African-American malesAfrican-126 Americans, who shall be in the unclassified civil service. The 127 executive director shall supervise the commission's activities 128 and report to the commission and to the Ohio state university 129 African American and African studies community extension Bell_ 130

Sec. 6301.10. Beginning January 1, 2013, and each calendar 251 year thereafter, the state board, with the assistance of all 252 state agencies engaged in workforce development activities, 253 shall prepare a report concerning the state of Ohio's workforce. 254 Upon completion of the annual workforce report, the state board 255 shall provide an electronic copy of the report to the president 256 257 and minority leader of the senate, the speaker and minority leader of the house of representatives, the governor's office of 258 Appalachian Ohio, the commission on Hispanic-Latino affairs, and 259 the commission on African-American males African-Americans, and 260 shall post the report on the state board's internet web site. 261

Section 2. That existing sections 125.22, 4112.12, 262 4112.13, and 6301.10 of the Revised Code are hereby repealed. 263

Section 3. On the effective date of the amendment by this264act of section 4112.12 of the Revised Code, members of the265Commission on African-Americans who were appointed under that266section and are serving on that date as members from the private267corporate sector, the public sector, and the nonprofit sector,268shall cease to be members of the Commission on that date.269

Not later than thirty days after the effective date of the 270 amendment by this act of section 4112.12 of the Revised Code, 271 the Ohio state university Bell national resource center, in 272 consultation with the governor, shall appoint, to the Commission 273 on African-Americans, two members from the private corporate 274 sector or from the nonprofit sector, and one member with 275 experience in the philanthropic community. The appointments 276 shall be for three year terms. An individual whose membership on 277
