## A BILL

	enact the "Forming Open and Robust University	4
	Minds Act" regarding free speech on college	5
	campuses.	6

## BE IT ENACTED BY THE GENERAL ASSEMBLY OF THE STATE OF OHIO:

Section 1. That sections 3345.021 and 3345.21 be amended	7
and sections 3345.0211, 3345.0212, 3345.0213, 3345.0214, and	8
3345.0215 of the Revised Code be enacted to read as follows:	9
Sec. 3345.021. The Subject to sections 3345.0212 to	10
3345.0215 of the Revised Code, the board of trustees of any	11
college or university, which receives any state funds in support	12
thereof, shall have full power and authority on all matters	13
relative to the administration of such college or university.	14
Such power shall include but not be limited to the	15
authority to withhold use of the facilities of any such college-	16
or university for meetings or speaking purposes from persons who	17
are members of the communist party persons who advocate or	1.8

persons who hold membership in or support organizations which	19
advocate the overthrow of the government of the United States	20
and its free institutions by force or violence or whose presence	21
is not conducive to high ethical and moral standards or the	22
primary educational purposes and orderly conduct of the	23
functions of the institution.	24
The board of trustees of any such college or university	25
may delegate any administrative authority-mentioned in this-	26
section, including but not limited to, the enforcement of rules	27
or regulations with respect to the use of university or college	28
facilities for speaking purposes, to the president of any such	29
college or university, or to such other administrative personnel	30
as may be designated or appointed therefor by the board of	31
trustees.	32
Sec. 3345.0211. (A) As used in this section and sections	33
3345.0212 to 3345.0215 of the Revised Code:	34
(1) "Benefits" has the same meaning as in section 3345.023	35
of the Revised Code.	36
(2) "Campus community" means students, student groups,	37
faculty, staff, and employees of a state institution of higher	38
education and their invited guests.	39
(3) "Expressive activities" means any lawful verbal,	40
written, audiovisual, or electronic means by which individuals	41
may communicate ideas, including all forms of peaceful assembly,	42
protests, speeches, distribution of literature, carrying and	43
displaying signs, and circulating petitions.	44
(4) "Harassment" means only expression that is unwelcome	45
and so severe, pervasive, and subjectively and objectively	46
offensive that it unreasonably interferes with an individual's	47

access to educational opportunities or benefits provided by a	48
state institution of higher education.	
(5) "Materially and substantially disrupts" means when a	50
person, with the intent to, or with knowledge of doing so,	51
significantly hinders another person's or group's expressive	52
activity, prevents communication of their message, or prevents	53
the transaction of the business of a lawful meeting, gathering,	54
or procession by either:	55
(a) Engaging in violent or otherwise unlawful behavior; or	56
(b) Physically blocking or using threats of violence to	57
prevent any person from attending, listening to, viewing, or	58
otherwise participating in an expressive activity. This shall	59
not include conduct that is protected under the First Amendment	60
to the United States Constitution or Section 3 of Article I of	61
the Ohio Constitution.	62
(6) "Outdoor areas of campus" means the generally	63
accessible outside areas of campus where members of the campus	64
community are commonly allowed, such as grassy areas, walkways,	65
and other similar common areas. This does not include outdoor	66
areas where access is restricted to a majority of the campus	67
community.	68
(7) "State institution of higher education" has the same	69
meaning as in section 3345.011 of the Revised Code.	70
(8) "Student" means any person who is enrolled on a full-	71
time or part-time basis in a state institution of higher	72
education.	73
(9) "Student group" means an officially recognized group	74
at a state institution of higher education, or a group seeking	75
official recognition, comprised of admitted students that	76

receive, or are seeking to receive, benefits through the	77
institution of higher education.	78
(B) The provisions and requirements of sections 3345.0212	79
to 3345.0215 of the Revised Code supersede any rule, policy,	80
action, communication, or requirement of any state institution	81
of higher education or other agency of the state. No rule,	82
policy, action, communication, or requirement shall contradict	83
or diminish the effect of those sections of the Revised Code.	84
(C) If any provision of sections 3345.0212 to 3345.0215 of	85
the Revised Code is declared unconstitutional, or its	86
application to any person or circumstances is held invalid, the	87
remainder of those sections and their application to other	88
persons or circumstances shall not be affected.	89
Sec. 3345.0212. (A) No state institution of higher	90
education, or any of its administrators acting in their official	91
capacity, shall prohibit any individual from engaging in	92
noncommercial expressive activity on campus, so long as the	93
individual's conduct is lawful and does not materially and	94
substantially disrupt the functioning of the institution.	95
(B) Each state institution of higher education shall do	96
<pre>the following:</pre>	97
(1) Make public in its handbook, on its web site, and in	98
its orientation programs for students the policies, regulations,	99
and expectations of students regarding free expression on	100
<pre>campus;</pre>	101
(2) Develop and distribute materials, programs, and	102
procedures to individuals responsible for the education or	103
discipline of students, such as administrators, campus police	104
officers, residence life officials, and professors, to inform	105

them of the policies, regulations, and duties of the institution	106
regarding free expression on campus.	107
(C)(1) Nothing in this section shall be interpreted as	108
preventing state institutions of higher education from	109
prohibiting harassment or restricting expressive activities that	110
the First Amendment to the United States Constitution does not	111
protect.	112
(2) Nothing in this section shall enable individuals to	113
engage in conduct that intentionally or materially and	114
substantially disrupts another individual's expressive activity	115
if it occurs in a campus space reserved for exclusive use or	116
control of a particular group.	117
Sec. 3345.0213. (A)(1) Outdoor areas of campuses of state	118
institutions of higher education are public forums for campus	119
<pre>communities.</pre>	120
(2) State institutions of higher education shall not	121
create "free speech zones" or designate other outdoor areas of	122
campuses where expressive activities are prohibited.	123
(3) State institutions of higher education may maintain	124
and enforce reasonable time, place, and manner restrictions	125
specifically developed in service of a significant institutional	126
interest only when such restrictions employ clear, published,	127
viewpoint- and content-neutral criteria, and provide for ample	128
alternative means of expressive activities. Any such	129
restrictions shall allow for members of a campus community to	130
spontaneously and contemporaneously assemble and distribute	131
literature.	132
(B) Nothing in this section shall be interpreted as	133
limiting the right of student expression elsewhere on campus.	134

Sec. 3345.0214. (A) (1) Within one hundred eighty days	135
after the effective date of this section, and in a manner that	136
complies with the "Family Educational Rights and Privacy Act of	137
1974," 88 Stat. 571, 20 U.S.C. 1232g, each state institution of	138
higher education shall submit to the governor, speaker of the	139
house of representatives, and president of the senate a report	140
detailing its course of action in accordance with sections	141
3345.0212, 3345.0213, and 3345.0215 of the Revised Code. The	142
report shall contain the following information:	143
(a) A description of any barriers to or incidents of	144
disruption of free expression occurring on campus, including	145
attempts to block or prohibit speakers and any investigation of	146
students or student groups on the basis of expression. The	147
description also shall include the nature of each barrier or	148
incident and the disciplinary action, if any, taken against	149
members of the campus community determined to be responsible for	150
the barriers or incidents;	151
(b) Any other information the state institution of higher	152
education finds necessary and appropriate for the public to	153
evaluate whether the free expression rights for members of the	154
campus community have been adequately protected.	155
(2) Each state institution of higher education shall	156
publish the report prescribed by this division on its web site.	157
The report must do the following:	158
(a) Be accessible from the main page of an institution's	159
web site by use of not more than three links;	160
(b) Be word-searchable;	161
(c) Be accessible to the public without requiring user	162
registration of any kind.	163

(3) Within thirty days after an action is brought against	164
a state institution of higher education for an alleged violation	165
of expression rights, the institution shall submit a	166
supplementary report, containing the information described in	167
division (A)(1) of this section and a copy of the complaint.	168
Sec. 3345.0215. (A) Notwithstanding Chapter 2743. of the	169
Revised Code, the state hereby waives its immunity from suit in	170
a federal court under the Eleventh Amendment to the United	171
States Constitution, and consents to the jurisdiction of the	172
federal courts over its civil liability, and the civil liability	173
of a state institution of higher education, for any violation of	174
sections 3345.0212 and 3345.0213 of the Revised Code. A state	175
institution of higher education shall not be immune from suit or	176
liability for those violations.	177
(B) Any member of the campus community aggrieved by a	178
violation of sections 3345.0212 and 3345.0213 of the Revised	179
Code may bring a civil action against the state, a state	180
institution of higher education, and its employees acting in	181
their official capacities. In the action, the aggrieved may seek	182
and obtain appropriate relief, including injunctive relief,	183
compensatory damages, reasonable attorney's fees, and court	184
costs. If a court finds a violation of section 3345.0212 or	185
3345.0213 of the Revised Code, it shall issue an award of not	186
less than one thousand dollars.	187
(C) Any member of the campus community aggrieved by a	188
violation of sections 3345.0212 and 3345.0213 of the Revised	189
Code may assert such violation as a defense or counterclaim in	190
any disciplinary action or in any civil or administrative	191
proceedings brought against such individual or student group.	192
Nothing in this section shall be interpreted to limit any other	193

remedies available to the individual or student group.	194
(D) Except as otherwise provided in this division, an	195
action against the state, a state institution of higher	196
education, or an employee acting in their official capacity for	197
a violation of section 3345.0212 or 3345.0213 of the Revised	198
Code shall be brought within one year after the cause of action	199
has occurred. A court may allow an action described in this	200
division to be brought after the expiration of that one-year	201
period if the court determines that there is just cause for a	202
delay in bringing the claim.	203
Sec. 3345.21. The board of trustees of any college or	204
university which receives any state funds in support thereof,	205
shall regulate the use of the grounds, buildings, equipment, and	206
facilities of such college or university and the conduct of the	207
students, staff, faculty, and visitors to the campus so that law	208
and order are maintained and the college or university may	209
pursue its educational objectives and programs in an orderly	210
manner.	211
The board of trustees of each such college or university	212
shall adopt rules for the conduct of the students, faculty,	213
visitors, and staff, and may provide for the ejection from	214
college or university property, suspension or expulsion of a	215
person who violates such regulations. All such rules shall be	216
published in a manner reasonably designed to come to the	217
attention of, and be available to, all faculty, staff, visitors,	218
and students.	219
The board of trustees shall provide for the administration	220
and enforcement of its rules and may authorize the use of state	221
university law enforcement officers provided for in section	222
33/15 O/L of the Powigod Code to assist in enforcing the rules and	223

the law on the campus of the college or university. The board of	224
trustees, or appropriate officials of such college or university	225
when the authority to do so has been delegated by the board of	226
trustees, may seek the assistance of other appropriate law	227
enforcement officers to enforce the rules and to enforce laws	228
for the preservation of good order on the campus, and to prevent	229
the disruption of the educational functions of the college or	230
university.	231
The In accordance with section 3345.0213 of the Revised	232
<u>Code</u> , the rules of the board of trustees shall not restrict	233
freedom of speech nor the right of persons on the campus to	234
assemble peacefully.
