A RESOLUTION

In memory of Representative Kristopher W. Jordan.

WHEREAS, The members of the Senate of the 135th General Assembly 1
of Ohio are deeply saddened to learn of the death of Representative 2
Kristopher W. Jordan and offer our heartfelt condolences to his family 3
and friends; and 4

WHEREAS, Kris Jordan's zealous love of life and his selfless 5
concern for the welfare of others distinguished him as an outstanding 6
human being and as a leading citizen. A proud and tireless public 7
servant, he served six years as a Delaware County Commissioner before 8
being elected to the Ohio House of Representatives in 2008, a position 9
he held for two terms, and he became the first freshman legislator in 10
the history of the state to be named Assistant Minority Whip. 11
Following eight years with the Ohio Senate, he was re-elected to a 12
third term in the Ohio House, and he brought a wealth of experience 13
and insight to the Financial Institutions, Insurance, Public Health 14
Policy, and Ways and Means committees. Clearly, his love for Ohio, 15
particularly Delaware County, and his sincere desire to serve its 16
people to the best of his ability, have shown him to be a truly 17
concerned and responsible individual; and 18

WHEREAS, Kris Jordan's passion for community service was evident 19
in his approach to the public well-being, and he could always be 20
relied upon to favor a worthy cause. Indeed, he was active with 21
numerous organizations, including the National Rifle Association, 22

Delaware County Right to Life, the Delaware County Farm Bureau, and 23
the County Commissioner Association of Ohio, and his many 24
contributions will stand as a testament to his personal character; and 25

WHEREAS, Without question, Kris Jordan made the world much fuller 26
for those around him, and he was endlessly devoted to his loved ones, 27
including his children Macy, David, and Everly. It is our hope that 28
all those who knew him best can find strength in the love of family 29
