attendance at the receiving school unless the transfer is from a school district which does not offer the grade the student is entitled to pursue if the student did not letter in the school-related extramural athletic competition at the student's prior school.

- B. A student who transfers prior to his or her sophomore year of high school, pursuant to the Education Open Transfer Act or Section 8-113 of this title, shall be eligible to participate in school-related extramural athletic competition governed by the Oklahoma Secondary School Activities Association on the first day of attendance at the receiving school.
- C. If the student is granted an emergency transfer pursuant to Section 8-104 of this title, was granted a transfer for any reason prior to January 1, 2000, or enrolls pursuant to the Education Open Transfer Act and qualifies for a hardship waiver pursuant to the rules of the Oklahoma Secondary School Activities Association, eligibility to participate in school-related extramural athletic competition shall be determined by the Oklahoma Secondary School Activities Association. If the student does not meet the criteria provided in subsection A or B of this section and does not qualify for a hardship waiver, the student shall not be eligible to participate in school-related extramural athletic competition governed by the Oklahoma Secondary School Activities Association for
