17	and shall be punished by imprisonment in the county jail for a term
18	not exceeding one (1) year, or fined a sum not exceeding Five
19	Hundred Dollars (\$500.00) for the first or second offense One
20	Thousand Dollars (\$1,000.00), or by both such fine and imprisonment.
21	Any person convicted of a <del>third</del> <u>second</u> or subsequent violation of
22	any provision of Section 1040.76 of this title shall be guilty of a
23	misdemeanor felony and shall be punished by imprisonment in the
24	custody of the Department of Corrections for a term not exceeding

1	five (5) years, or fined a sum not exceeding One Thousand Dollars
2	(\$1,000.00) Five Thousand Dollars (\$5,000.00), or by both such fine
3	and imprisonment. Each day that any violation of Section 1040.76 of
4	this title occurs or continues shall constitute a separate offense
5	and shall be punishable as a separate violation. Every act or
6	transaction prohibited by Section 1040.76 of this title shall
7	constitute a separate offense as to each item, issue or title
8	involved and shall be punishable as such. For the purpose of this
9	section, multiple copies of the same identical title, monthly issue,
10	volume and number issue or other such identical material as
11	prohibited by Section 1040.76 of this title shall constitute a
12	single offense.
13	SECTION 2. This act shall become effective November 1, 2023.
