1	"G. <u>1. A three-day nonresident medical marijuana patient</u>
2	permit shall be available to any nonresident medical marijuana
3	patient licensee.
4	2. Upon presentation of a valid medical marijuana license and
5	state-issued driver license or state-issued identification card by a
6	nonresident medical marijuana patient to a licensed medical
7	marijuana dispensary, the medical marijuana dispensary shall verify
8	the authenticity and status of the nonresident medical marijuana
9	patient license through the website or telephone verification system
10	of the Oklahoma Medical Marijuana Authority. Upon said
11	verification, the medical marijuana dispensary may issue a three-day
12	nonresident medical marijuana patient permit to the person. The
13	cost of the three-day nonresident medical marijuana patient permit
14	shall be Seventy-five Dollars (\$75.00). Renewal of the three-day
15	nonresident medical marijuana patient permit shall be granted with
16	resubmission of the permit fee and verification of the authenticity
17	and status of the nonresident medical marijuana patient license.
18	There shall be no limit to the number of times a person may receive
19	a three-day nonresident medical marijuana patient permit.
20	3. A person who has been issued a three-day nonresident medical
21	marijuana patient permit shall be authorized to obtain no more than
22	a three-day supply of medical marijuana. As used in this
23	subsection, a "three-day supply" means the amount of medical
24	marijuana reasonably necessary to ensure uninterrupted availability

1	of supply for a three-day period, which amounts shall be determined
2	by the Authority.
3	4. The Authority shall maintain and publish a list of states
4	that authorize the medical use of marijuana. The Authority shall
5	make the information available to licensed medical marijuana
6	dispensaries for purposes of verifying the authenticity and status
7	of nonresident medical marijuana patient licenses. The Authority
8	shall be authorized to promulgate rules and procedures to implement
9	the provisions of this subsection."
