11 An Act relating to the Office of Management and
12 Enterprise Services; making appropriations;
13 identifying source; establishing amount; providing
purpose; providing for noncodification; and declaring
an emergency.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law not to be
17 codified in the Oklahoma Statutes reads as follows:

18 There is hereby appropriated to the Office of Management and
19 Enterprise Services from monies not otherwise appropriated from the
20 Statewide Recovery Fund of the State Treasury created in Enrolled
21 House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
22 Legislature, the sum of Four Million Seven Hundred Thousand Dollars
23 (\$4,700,000.00) or so much thereof as may be necessary to pay for
24 expenses arising from implementing programs and expenditures in

1 accordance with actions taken by the Joint Committee on Pandemic
2 Relief Funding. Such funds shall be utilized in a manner consistent
3 with the recommendations adopted by the Joint Committee on Pandemic
4 Relief Funding on May 11, 2023.

5 SECTION 2. NEW LAW A new section of law not to be
6 codified in the Oklahoma Statutes reads as follows:

7 There is hereby appropriated to the ARPA Administrative Costs
8 Fund created in Enrolled House Bill No. 2940 of the 1st Session of
9 the 59th Oklahoma Legislature from monies not otherwise appropriated
10 from the Statewide Recovery Fund of the State Treasury created in
11 Enrolled House Bill No. 3349 of the 2nd Session of the 58th Oklahoma
12 Legislature, the sum of Five Million Eight Hundred Four Thousand
13 Dollars (\$5,804,000.00) or so much thereof as may be necessary to
14 pay for future administrative expenses approved by the Joint
15 Committee on Pandemic Relief Funding in association with
16 implementing, administering, or overseeing programs funded by the
17 Statewide Recovery Fund created in Enrolled House Bill No. 3349 of
18 the 2nd Session of the 58th Oklahoma Legislature.

19 SECTION 3. It being immediately necessary for the preservation
20 of the public peace, health or safety, an emergency is hereby
21 declared to exist, by reason whereof this act shall take effect and
22 be in full force from and after its passage and approval.
