15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified
17 in the Oklahoma Statutes as Section 1698.364 of Title 69, unless
18 there is created a duplication in numbering, reads as follows:

19 The bridge located on U.S. Highway 81, approximately one (1)
20 mile south of the State Highway 19 West intersection, in Grady
21 County shall be designated as the "SGT Mycal Prince Memorial
22 Bridge". The Department of Transportation shall cause suitable
23 permanent markers bearing that name to be placed on the bridge.

1 SECTION 2. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.365 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge over Walnut Creek on State Highway 24, east of the
5 town of Washington in McClain County, shall be designated as the
6 "SSGT Jerry Michael Chitwood Memorial Bridge". The Department of
7 Transportation shall cause suitable permanent markers bearing that
8 name to be placed on the bridge.

9 SECTION 3. NEW LAW A new section of law to be codified
10 in the Oklahoma Statutes as Section 1698.366 of Title 69, unless
11 there is created a duplication in numbering, reads as follows:

12 The section of U.S. Highway 266 beginning at the intersection of
13 Porter Road extending northeasterly to the intersection of County
14 Road N4030 in Okmulgee County shall be designated as the "SP-4
15 Wilbert Gresham Memorial Highway". The Department of Transportation
16 shall cause suitable permanent markers bearing that name to be
17 placed on the highway.

18 SECTION 4. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 1698.367 of Title 69, unless
20 there is created a duplication in numbering, reads as follows:

21 The section of State Highway 51 beginning at the intersection of
22 Country Club Road and extending west to the intersection of Karsten
23 Creek Road in Payne County shall be designated as the "Boone Pickens
24 Memorial Highway". The Department of Transportation shall cause

1 suitable permanent markers bearing that name to be placed on the
2 highway.

3 SECTION 5. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.368 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of Interstate 44 beginning one-half (0.5) mile north
7 of State Highway 36 interchange extending south to U.S. Highway 70
8 interchange in Cotton County shall be designated as the "William
9 Mark Miller Memorial Highway". The Department of Transportation
10 shall cause suitable permanent markers bearing that name to be
11 placed on the highway.

12 SECTION 6. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.369 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The bridge at the interchange of U.S. Highway 81 and State
16 Highway 7 running southwest to northeast in Stephens County shall be
17 designated as the "SSG Rodney Aaron Hagan Memorial Bridge". The
18 Department of Transportation shall cause suitable permanent markers
19 bearing that name to be placed on the bridge.

20 SECTION 7. NEW LAW A new section of law to be codified
21 in the Oklahoma Statutes as Section 1698.370 of Title 69, unless
22 there is created a duplication in numbering, reads as follows:

23 The portion of U.S. Highway 75 beginning at the intersection of
24 E 106th Street N and ending at the intersection of E 116th Street N

1 in Tulsa County shall be designated as the "OHP Captain Larry
2 Jackson Memorial Highway". The Department of Transportation shall
3 cause suitable permanent markers bearing that name to be placed on
4 the highway.

5 SECTION 8. NEW LAW A new section of law to be codified
6 in the Oklahoma Statutes as Section 1698.371 of Title 69, unless
7 there is created a duplication in numbering, reads as follows:

8 The section of U.S. Highway 70 near the southeast edge of Durant
9 beginning at McLean Road and extending northeasterly two and one-
10 half (2.5) miles in Bryan County shall be designated as the "Hunter
11 Ford, Fernando Flores, Jack Sarver, and Kaleb Foster Memorial
12 Highway". The Department of Transportation shall cause suitable
13 permanent markers bearing that name to be placed on the highway.

14 SECTION 9. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 1698.372 of Title 69, unless
16 there is created a duplication in numbering, reads as follows:

17 The bridge crossing over U.S. Highway 69 on U.S. Highway 70 on
18 the south side of Durant in Bryan County shall be designated as the
19 "Senator Billy A. Mickle Memorial Bridge". The Department of
20 Transportation shall cause suitable permanent markers bearing that
21 name to be placed on the bridge.

22 SECTION 10. NEW LAW A new section of law to be codified
23 in the Oklahoma Statutes as Section 1698.373 of Title 69, unless
24 there is created a duplication in numbering, reads as follows:

1 The bridge over Wolf Creek on U.S. Highway 283 north of Shattuck
2 in Ellis County shall be designated as the "Undersheriff Monty
3 Martin Memorial Bridge". The Department of Transportation shall
4 cause suitable permanent markers bearing that name to be placed on
5 the bridge.

6 SECTION 11. NEW LAW A new section of law to be codified
7 in the Oklahoma Statutes as Section 1698.374 of Title 69, unless
8 there is created a duplication in numbering, reads as follows:

9 The section of Interstate 35 beginning at the U.S. Highway 77
10 interchange extending north to the State Highway 33 interchange near
11 Guthrie in Logan County shall be designated as the "Clarence and
12 Ethel Branch Memorial Highway". The Department of Transportation
13 shall cause suitable permanent markers bearing that name to be
14 placed on the highway.

15 SECTION 12. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 1698.375 of Title 69, unless
17 there is created a duplication in numbering, reads as follows:

18 The bridge on U.S. Highway 412 crossing over State Highway 88
19 near Inola in Rogers County shall be designated as the "PFC Travis
20 J. Grigg 101st Airborne Division Memorial Bridge". The Department
21 of Transportation shall cause suitable permanent markers bearing
22 that name to be placed on the bridge.

1 SECTION 13. NEW LAW A new section of law to be codified
2 in the Oklahoma Statutes as Section 1698.376 of Title 69, unless
3 there is created a duplication in numbering, reads as follows:

4 The bridge over the Canadian River on Interstate 40 in Canadian
5 County shall be designated as the "Cecil Davis Memorial Bridge".
6 The Department of Transportation shall cause suitable permanent
7 markers bearing that name to be placed on the bridge.

8 SECTION 14. NEW LAW A new section of law to be codified
9 in the Oklahoma Statutes as Section 1698.377 of Title 69, unless
10 there is created a duplication in numbering, reads as follows:

11 The section of U.S. Highway 81 beginning at the intersection of
12 U.S. Highway 70 near Waurika extending south five and one-half (5.5)
13 miles in Jefferson County shall be designated as the "Gerald Holmes
14 Memorial Highway". The Department of Transportation shall cause
15 suitable permanent markers bearing that name to be placed on the
16 highway.

17 SECTION 15. NEW LAW A new section of law to be codified
18 in the Oklahoma Statutes as Section 1698.378 of Title 69, unless
19 there is created a duplication in numbering, reads as follows:

20 The section of State Highway 3 beginning at the intersection of
21 Morgan Road extending northwesterly to the intersection of Sara Road
22 in Canadian County shall be designated as the "Lt. Shirley Lanning
23 Memorial Highway". The Department of Transportation shall cause
24

1 suitable permanent markers bearing that name to be placed on the
2 highway.

3 SECTION 16. NEW LAW A new section of law to be codified
4 in the Oklahoma Statutes as Section 1698.379 of Title 69, unless
5 there is created a duplication in numbering, reads as follows:

6 The section of U.S. Highway 177 beginning at the intersection of
7 East 1660 Road, north of Sulphur, extending north to the Murray-
8 Garvin County line shall be designated as the "Senator Bruce L.
9 Frazier WWII Veteran Memorial Highway". The Department of
10 Transportation shall cause suitable permanent markers bearing that
11 name to be placed on the highway.

12 SECTION 17. NEW LAW A new section of law to be codified
13 in the Oklahoma Statutes as Section 1698.380 of Title 69, unless
14 there is created a duplication in numbering, reads as follows:

15 The section of U.S. Highway 277 beginning at the intersection of
16 Keeney Road near Elgin extending northeasterly to the H.E. Bailey
17 Turnpike overpass in Comanche County shall be designated as the
18 "Captain Mark A. Barker Memorial Highway". The Department of
19 Transportation shall cause suitable permanent markers bearing that
20 name to be placed on the highway.

21 SECTION 18. AMENDATORY 69 O.S. 2021, Section 1698.300,
22 is amended to read as follows:

23 Section 1698.300 ~~The section of U.S. Highway 277 beginning on~~
24 ~~the west side of the H.E. Bailey Turnpike and extending west to the~~

1 ~~intersection of U.S. Highway 62 in Comanche County~~ bridge crossing
2 over the Arkansas River on Interstate 244 in Tulsa County shall be
3 designated as the "Gold Star Families Memorial ~~Highway~~ Bridge". The
4 Department of Transportation shall cause suitable permanent markers
5 bearing that name to be placed on the ~~highway~~ bridge.

6 SECTION 19. AMENDATORY 69 O.S. 2021, Section 1698.310,
7 is amended to read as follows:

8 Section 1698.310 The bridge over the Cimarron River ~~on Highway~~
9 ~~15 approximately thirteen (13) miles north of Boise City~~ located on
10 U.S. Highway 287, five (5) miles south of the Oklahoma/Colorado
11 state line in Cimarron County shall be designated as the "Private
12 Robert "Bob" Clark Memorial Bridge". The Department of
13 Transportation shall cause suitable permanent markers bearing that
14 name to be placed on the bridge.

15 SECTION 20. AMENDATORY 69 O.S. 2021, Section 1698.322,
16 is amended to read as follows:

17 Section 1698.322 The bridge located on Interstate 44 over State
18 Highway 49 within Comanche County shall be designated as the "~~MSGF~~
19 MSG Michael Werdehoff Vietnam MIA Memorial Bridge". The Department
20 of Transportation shall cause suitable permanent markers bearing
21 that name to be placed on the bridge.

22 SECTION 21. This act shall become effective November 1, 2022.
