17	2017 (70 O.S. Supp. 2020, Section 3-117.3), is amended to read as

19	Section 3-117.3 A. The School Finance Review Commission shall				
20	conduct a review of all matters related to school finance $_{ au}$				
21	including, but not limited to teacher :				
22	1. Teacher compensation, and benefits and administration;				
23	2. Administrative costs including administrative functions that				
24	<pre>may be shared between school districts;</pre>

1	3. Opportunities for school districts to be operated in a cost-
2	effective manner;
3	4. Variances in per-pupil and administrative expenditures among
4	school districts with comparable enrollment, demographics and
5	outcomes on statewide assessments; and
6	5. Expenditures that are not directly or sufficiently related
7	to improving student outcomes.
8	B. The Commission shall submit a report of its findings to the
9	Governor, the President Pro Tempore of the Senate and the Speaker of
10	the House of Representatives no later than December 31, 2023, and
11	every subsequent four (4) years by December 31.
12	SECTION 2. This act shall become effective July 1, 2021.
13	SECTION 3. It being immediately necessary for the preservation
14	of the public peace, health or safety, an emergency is hereby
15	declared to exist, by reason whereof this act shall take effect and
16	be in full force from and after its passage and approval.
