6 AS INTRODUCED

7 An Act relating to general appropriations for the
8 expenses of various agencies of the executive,
9 legislative and judicial departments of the state;
10 repealing Sections 1 through 170, Chapter 371, O.S.L.
11 2017, which relate to appropriations; making
12 appropriations to the Oklahoma Education Lottery
13 Trust Fund, State Board of Education, the Oklahoma
14 Arts Council, the State Board of Career and
15 Technology Education, the Office of Educational
16 Quality and Accountability, the Oklahoma Educational
17 Television Authority, the Oklahoma State Regents for
18 Higher Education, the Commissioners of the Land
19 Office, the Oklahoma Department of Libraries, the
20 Physician Manpower Training Commission, the Board of
21 Trustees of the Oklahoma School of Science and
22 Mathematics, the Oklahoma Center for the Advancement
23 of Science and Technology, the Office of the Attorney
24 General, the Office of the State Auditor and
Inspector, the State Election Board, the Oklahoma
Department of Emergency Management, the Ethics
Commission, the Office of the Governor, the Oklahoma
House of Representatives, the Legislative Service
Bureau, the Office of the Lieutenant Governor, the
Office of Management and Enterprise Services, the
Oklahoma Merit Protection Commission, the Military
Department of the State of Oklahoma, the Oklahoma
State Senate, the Oklahoma Tax Commission, the Office
of the State Treasurer, the Oklahoma Space Industry
Development Authority, the Department of
Transportation, the State Department of Health, the
Oklahoma Health Care Authority, the J.D. McCarty
Center for Children with Developmental Disabilities,
the Department of Mental Health and Substance Abuse
Services, the Oklahoma State University Medical
Authority, the University Hospitals Authority, the

1 Oklahoma Department of Veterans Affairs, the Oklahoma
2 Commission on Children and Youth, the Office of
3 Disability Concerns, the Department of Human
4 Services, the Office of Juvenile Affairs, the State
5 Department of Rehabilitation Services, the Oklahoma
6 Department of Agriculture, Food, and Forestry, the
7 Oklahoma Department of Commerce, the Rural Economic
8 Action Plan Fund, the Oklahoma Conservation
9 Commission, the Corporation Commission, the
10 Department of Environmental Quality, the Oklahoma
11 Historical Society, the J.M. Davis Memorial
12 Commission, the Department of Labor, the Department
13 of Mines, the Oklahoma Tourism and Recreation
14 Department, the Oklahoma Water Resources Board, the
15 Alcoholic Beverage Laws Enforcement Commission, the
16 Department of Corrections, the Oklahoma State Bureau
17 of Investigation, the Council on Law Enforcement
18 Education and Training, the Board of Medicolegal
19 Investigations, the Oklahoma State Bureau of
20 Narcotics and Dangerous Drugs Control, the Department
21 of Public Safety, the Court of Criminal Appeals,
22 district attorneys and the District Attorneys
23 Council, the Supreme Court, the Oklahoma Indigent
24 Defense System and the Pardon and Parole Board;
stating amounts of the appropriations; stating
purposes and restrictions; authorizing certain
expenditures; authorizing certain transfers; and
providing for effect of prior allocations and
expenditures.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. REPEALER Sections 1 through 170, Chapter 371,
O.S.L. 2017, are hereby repealed.

EDUCATION

SECTION 2. There is hereby appropriated to the Oklahoma
Education Lottery Trust Fund from any monies not otherwise
appropriated from the Special Cash Fund of the State Treasury, the

1 sum of Ten Million One Hundred Forty-four Thousand One Hundred
2 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
3 necessary pursuant to the provisions of subsection E of Section 713
4 of Title 3A of the Oklahoma Statutes.

5 SECTION 3. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of One Billion Thirty-six Million Four
9 Hundred Twenty-nine Thousand Four Hundred Thirty-seven Dollars
10 (\$1,036,429,437.00) or so much thereof as may be necessary for the
11 financial support of public schools.

12 SECTION 4. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Education Reform Revolving Fund created in Section 34.89 of Title 62
15 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
16 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
17 (\$695,407,138.00) or so much thereof as may be necessary for the
18 financial support of public schools.

19 SECTION 5. The State Board of Education is hereby authorized to
20 expend during the fiscal year ending June 30, 2018, from the Common
21 Education Technology Revolving Fund of the State Treasury, the sum
22 of Forty-seven Million Three Hundred Seventy-two Thousand Two
23 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
24 may be necessary for the financial support of public schools.

1 SECTION 6. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
5 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
6 necessary for the financial support of public schools.

7 SECTION 7. There is hereby appropriated to the State Board of
8 Education from any monies not otherwise appropriated from the
9 Mineral Leasing Fund of the State Treasury for the fiscal year
10 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
11 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
12 may be necessary for the financial support of public schools.

13 SECTION 8. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Oklahoma Education Lottery Trust Fund of the State Treasury for the
16 fiscal year ending June 30, 2018, the sum of Twenty-five Million
17 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
18 (\$25,939,910.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 9. There is hereby appropriated to the State Board of
21 Education from any monies not otherwise appropriated from the
22 Oklahoma Education Lottery Trust Fund of the State Treasury for the
23 fiscal year ending June 30, 2016, the sum of Five Million Four
24 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars

1 (\$5,429,844.00) or so much thereof as may be necessary for the
2 financial support of public schools.

3 SECTION 10. Notwithstanding any other provision of law, the
4 State Board of Education is hereby authorized to expend during the
5 fiscal year ending June 30, 2018, from the School Consolidation
6 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
7 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 11. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2018, the sum of Ninety-two Million Seventy-four
13 Thousand Thirty-three Dollars (\$92,074,033.00) or so much thereof as
14 may be necessary for the support of public schools activities.

15 SECTION 12. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
19 Three Hundred Twenty Thousand Three Hundred Forty Dollars
20 (\$299,320,340.00) or so much thereof as may be necessary for the
21 Certified Employee Health Benefit Allowance.

22 SECTION 13. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2018, the sum of One Hundred Sixty-three Million
2 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
3 (\$163,375,627.00) so much thereof as may be necessary for the
4 Support Personnel Health Benefit Allowance.

5 SECTION 14. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2018, the sum of Fifteen Million Six Hundred Eighty-
9 one Thousand One Hundred Five Dollars (\$15,681,105.00) or so much
10 thereof as may be necessary for administrative and support functions
11 of the State Department of Education.

12 SECTION 15. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2018, the sum of Two Million Eight
16 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
17 (\$2,882,213.00) or so much thereof as may be necessary for transfer
18 to the School Consolidation Assistance Fund.

19 SECTION 16. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Oklahoma Education Lottery Trust Fund of the State Treasury for the
22 fiscal year ending June 30, 2016, the sum of Six Hundred Three
23 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
24

1 thereof as may be necessary for transfer to the School Consolidation
2 Assistance Fund.

3 SECTION 17. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Oklahoma Education Lottery Trust Fund of the State Treasury for the
6 fiscal year ending June 30, 2018, the sum of Two Million Eight
7 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
8 (\$2,882,213.00) or so much thereof as may be necessary for transfer
9 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

10 SECTION 18. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Oklahoma Education Lottery Trust Fund of the State Treasury for the
13 fiscal year ending June 30, 2016, the sum of Six Hundred Three
14 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
15 thereof as may be necessary for transfer to the Teachers' Retirement
16 System Dedicated Revenue Revolving Fund.

17 SECTION 19. There is hereby appropriated to the Oklahoma Arts
18 Council from any monies not otherwise appropriated from the General
19 Revenue Fund of the State Treasury for the fiscal year ending June
20 30, 2018, the sum of Two Million Seven Hundred Ninety-five Thousand
21 One Hundred Eighty-one Dollars (\$2,795,181.00) or so much thereof as
22 may be necessary to perform the duties imposed upon the Oklahoma
23 Arts Council by law.

24

1 SECTION 20. There is hereby appropriated to the State Board of
2 Career and Technology Education from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2018, the sum of One Hundred Eight
5 Million One Hundred Eighty-one Thousand Four Hundred Seventy-seven
6 Dollars (\$108,181,477.00) or so much thereof as may be necessary to
7 perform the duties imposed upon the State Board of Career and
8 Technology Education by law.

9 SECTION 21. There is hereby appropriated to the State Board of
10 Career and Technology Education from any monies not otherwise
11 appropriated from the Oklahoma Education Lottery Trust Fund of the
12 State Treasury for the fiscal year ending June 30, 2018, the sum of
13 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
14 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection C of
15 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
16 the State Board of Career and Technology Education for the education
17 and general operating budgets of the institutions and for other
18 programs, construction, renovations or repairs administered by the
19 State Board of Career and Technology Education.

20 SECTION 22. There is hereby appropriated to the State Board of
21 Career and Technology Education from any monies not otherwise
22 appropriated from the Oklahoma Education Lottery Trust Fund of the
23 State Treasury for the fiscal year ending June 30, 2016, the sum of
24 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars

1 (\$663,648.00) pursuant to paragraph 2 of subsection C of Section 713
2 of Title 3A of the Oklahoma Statutes for allocation by the State
3 Board of Career and Technology Education for the education and
4 general operating budgets of the institutions and for other
5 programs, construction, renovations or repairs administered by the
6 State Board of Career and Technology Education.

7 SECTION 23. Notwithstanding any other provision of law, the
8 State Board of Career and Technology Education is hereby authorized
9 to expend during the fiscal year ending June 30, 2018, from the
10 State Board of Career and Technology Education Revolving Fund (200
11 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
12 much thereof as may be necessary to perform the duties imposed upon
13 the State Board of Career and Technology Education by law.

14 SECTION 24. There is hereby appropriated to the Office of
15 Educational Quality and Accountability from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2018, the sum of One Million One
18 Hundred Nineteen Thousand Eight Hundred Ninety-eight Dollars
19 (\$1,119,898.00) or so much thereof as may be necessary to perform
20 the duties imposed upon the Office of Educational Quality and
21 Accountability by law.

22 SECTION 25. There is hereby appropriated to the Office of
23 Educational Quality and Accountability from any monies not otherwise
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
2 thereof as may be necessary to perform the duties imposed upon the
3 Office of Educational Quality and Accountability by law.

4 SECTION 26. There is hereby appropriated to the Oklahoma
5 Educational Television Authority from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2018, the sum of Two Million Six
8 Hundred Ninety-nine Thousand Nine Hundred Twenty-seven Dollars
9 (\$2,699,927.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Oklahoma Educational Television
11 Authority by law.

12 SECTION 27. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Four Hundred
16 Thirty-two Million Six Hundred Eighty-two Thousand Three Hundred
17 Ninety-six Dollars (\$432,682,396.00) or so much thereof as may be
18 necessary for allocation by the Oklahoma State Regents for Higher
19 Education pursuant to the provisions of Article XIII-a of the
20 Oklahoma Constitution for the education and general operating
21 budgets of the institutions and for other programs, construction,
22 renovations or repairs administered by the Oklahoma State Regents
23 for Higher Education. Of those funds appropriated, the sum of Three
24 Million Thirteen Thousand One Hundred Thirty-nine Dollars

1 (\$3,013,139.00) shall be transferred to the Oklahoma Tuition
2 Equalization Grant Trust Fund to implement the provisions of the
3 Oklahoma Tuition Equalization Grant Act.

4 SECTION 28. The Oklahoma State Regents for Higher Education are
5 hereby authorized to expend during the fiscal year ending June 30,
6 2018, the sum of Forty-seven Million Three Hundred Seventy-two
7 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
8 Higher Education Capital Revolving Fund of the State Treasury for
9 allocation by the Oklahoma State Regents for Higher Education
10 pursuant to the provisions of Article XIII-a of the Oklahoma
11 Constitution for the education and general operating budgets of the
12 institutions and for other programs, construction, renovations or
13 repairs administered by the Oklahoma State Regents for Higher
14 Education.

15 SECTION 29. The Oklahoma State Regents for Higher Education are
16 hereby authorized to expend during the fiscal year ending June 30,
17 2018, the sum of Forty-seven Million Three Hundred Seventy-two
18 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
19 Oklahoma Student Aid Revolving Fund of the State Treasury for
20 allocation by the Oklahoma State Regents for Higher Education
21 pursuant to the provisions of Article XIII-a of the Oklahoma
22 Constitution for the education and general operating budgets of the
23 institutions and for other programs, construction, renovations or
24

1 repairs administered by the Oklahoma State Regents for Higher
2 Education.

3 SECTION 30. There is hereby appropriated to the Oklahoma State
4 Regents for Higher Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of Nine Hundred
7 Seventy Thousand Nine Hundred Forty Dollars (\$970,940.00) or so much
8 thereof as may be necessary for expenditures for concurrent
9 enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma
10 Statutes.

11 SECTION 31. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2018, the sum of
15 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
16 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
17 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
18 allocation by the Oklahoma State Regents for Higher Education
19 pursuant to the provisions of Article XIII-a of the Oklahoma
20 Constitution for construction, renovations or repairs administered
21 by the Oklahoma State Regents for Higher Education or for any other
22 purpose authorized by paragraph 2 of subsection C of Section 713 of
23 Title 3A of the Oklahoma Statutes.

24

1 SECTION 32. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2016, the sum of
5 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
6 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
7 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
8 by the Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-a of the Oklahoma Constitution for
10 construction, renovations or repairs administered by the Oklahoma
11 State Regents for Higher Education or for any other purpose
12 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
13 of the Oklahoma Statutes.

14 SECTION 33. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2018, the sum of Three Million Six
18 Hundred Sixty-four Thousand Fifty-two Dollars (\$3,664,052.00) or so
19 much thereof as may be necessary for the general operating budget of
20 the Administrative Offices of the Oklahoma State Regents for Higher
21 Education.

22 SECTION 34. There is hereby appropriated to the Commissioners
23 of the Land Office from any monies not otherwise appropriated from
24 the Commissioners of the Land Office Fund of the State Treasury for

1 the fiscal year ending June 30, 2018, the sum of Eight Million Five
2 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
3 so much thereof as may be necessary to perform the duties imposed
4 upon the Commissioners of the Land Office by law.

5 SECTION 35. There is hereby appropriated to the Oklahoma
6 Department of Libraries from any monies not otherwise appropriated
7 from the General Revenue Fund of the State Treasury for the fiscal
8 year ending June 30, 2018, the sum of Four Million Three Hundred
9 Eighty-six Thousand Seven Hundred Eighty Dollars (\$4,386,780.00) or
10 so much thereof as may be necessary to perform the duties imposed
11 upon the Oklahoma Department of Libraries by law.

12 SECTION 36. There is hereby appropriated to the Physician
13 Manpower Training Commission from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Two Million Nine
16 Hundred Fourteen Thousand Eight Hundred Forty Dollars
17 (\$2,914,840.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Physician Manpower Training Commission
19 by law.

20 SECTION 37. There is hereby appropriated to the Physician
21 Manpower Training Commission from any monies not otherwise
22 appropriated from the Special Cash Fund of the State Treasury the
23 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
24

1 thereof as may be necessary to perform the duties imposed upon the
2 Physician Manpower Training Commission by law.

3 SECTION 38. There is hereby appropriated to the Board of
4 Trustees of the Oklahoma School of Science and Mathematics from any
5 monies not otherwise appropriated from the General Revenue Fund of
6 the State Treasury for the fiscal year ending June 30, 2018, the sum
7 of Six Million One Hundred Twenty-one Thousand Seven Hundred Nine
8 Dollars (\$6,121,709.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the Board of Trustees of the
10 Oklahoma School of Science and Mathematics by law.

11 SECTION 39. There is hereby appropriated to the Oklahoma Center
12 for the Advancement of Science and Technology from any monies not
13 otherwise appropriated from the General Revenue Fund of the State
14 Treasury for the fiscal year ending June 30, 2018, the sum of
15 Thirteen Million Four Hundred Twenty-two Thousand Eight Hundred
16 Ninety-two Dollars (\$13,422,892.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Oklahoma Center for
18 the Advancement of Science and Technology by law. Of those funds
19 appropriated, the sum of Five Million Three Hundred Sixty-nine
20 Thousand One Hundred Fifty-seven Dollars (\$5,369,157.00) shall be
21 deposited in the Research Support Revolving Fund, created pursuant
22 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
23 funds appropriated, the sum of Two Million Nine Hundred Fifty-three
24 Thousand Thirty-six Dollars (\$2,953,036.00) shall be deposited in

1 the Seed-capital Revolving Fund, created pursuant to Section 5060.21
2 of Title 74 of the Oklahoma Statutes.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 40. There is hereby appropriated to the Office of the
5 Attorney General from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2018, the sum of Nine Million One Hundred Sixty-four
8 Thousand Four Hundred Fifty-nine Dollars (\$9,164,459.00) or so much
9 thereof as may be necessary to perform the duties imposed upon the
10 Office of the Attorney General by law.

11 SECTION 41. There is hereby appropriated to the Office of the
12 Attorney General from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2018, the sum of Nine Hundred Four Thousand Seven
15 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal
16 Services Revolving Fund, created pursuant to subsection G of Section
17 921.1 of Title 12 of the Oklahoma Statutes.

18 SECTION 42. REAPPROPRIATION AND REDESIGNATION The amount
19 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the
20 original appropriation of Five Million Dollars (\$5,000,000.00),
21 appropriated to the Office of the Attorney General by Section 154,
22 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated
23 from the Special Cash Fund of the State Treasury, for the
24 prosecution and defense of claims related to water and water rights

1 in Oklahoma, is hereby reappropriated and redesignated to perform
2 the duties imposed upon the Office of the Attorney General by law.
3 If, on the date this act is approved, any of the amount originally
4 appropriated, as adjusted by expenditures, encumbrances and
5 transfers, results in an unencumbered balance less than the
6 reappropriated and redesignated amount, that reappropriated and

5 perform the duties imposed upon the Department of Public Safety by
6 law.

7 SECTION 171. Each and every appropriation made by each section
8 of this act, regardless of amount or the source from which the
9 appropriation is made, shall be the total amount appropriated by
10 such section to the entity to which the appropriation is made for
11 the fiscal year ending June 30, 2018, less any amount either
12 allocated to or expended by such entity on or after July 1, 2017,
13 but prior to the effective date of this act, pursuant to any
14 applicable provisions of Enrolled Senate Bill No. 860 of the 1st
15 Regular Session of the 56th Oklahoma Legislature.
