15 of Investigation, the Council on Law Enforcement
16 Education and Training, the Board of Medicolegal
17 Investigations, the Oklahoma State Bureau of

21 Council, the Supreme Court, the Oklahoma Indigent
22 Defense System and the Pardon and Parole Board;
23 stating amounts of the appropriations; stating
24 purposes and restrictions; reappropriating and
redesignating certain funds; reappropriating certain
funds; authorizing transfers; repealing Sections 1
through 169, Chapter 371, O.S.L. 2017, which relate
to general appropriations for the expenses of various
agencies of the executive, legislative and judicial
departments of state; and repealing Sections 76, 82,
91, 146 and 169 of Enrolled House Bill No. 1019 of
the 1st Extraordinary Session of the 56th Oklahoma
Legislature, which relate to general appropriations
for the expenses of various agencies of the executive
departments of the state.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

EDUCATION

SECTION 1. There is hereby appropriated to the Oklahoma
Education Lottery Trust Fund from any monies not otherwise

1 appropriated from the Special Cash Fund of the State Treasury, the
2 sum of Ten Million One Hundred Forty-four Thousand One Hundred
3 Seventy-one Dollars (\$10,144,171.00) or so much thereof as may be
4 necessary pursuant to the provisions of subsection E of Section 713
5 of Title 3A of the Oklahoma Statutes.

6 SECTION 2. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2018, the sum of One Billion Twenty-one Million
10 Seventy-two Thousand Two Hundred Sixty-seven Dollars
11 (\$1,021,072,267.00) or so much thereof as may be necessary for the
12 financial support of public schools.

13 SECTION 3. There is hereby appropriated to the State Board of
14 Education from any monies not otherwise appropriated from the
15 Education Reform Revolving Fund created in Section 34.89 of Title 62
16 of the Oklahoma Statutes, the sum of Six Hundred Ninety-five Million
17 Four Hundred Seven Thousand One Hundred Thirty-eight Dollars
18 (\$695,407,138.00) or so much thereof as may be necessary for the
19 financial support of public schools.

20 SECTION 4. The State Board of Education is hereby authorized to
21 expend during the fiscal year ending June 30, 2018, from the Common
22 Education Technology Revolving Fund of the State Treasury, the sum
23 of Forty-seven Million Three Hundred Seventy-two Thousand Two
24

1 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
2 may be necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board of
4 Education from any monies not otherwise appropriated from the
5 Mineral Leasing Fund of the State Treasury for the fiscal year
6 ending June 30, 2018, the sum of Four Million Two Hundred Seventy-
7 five Thousand Dollars (\$4,275,000.00) or so much thereof as may be
8 necessary for the financial support of public schools.

9 SECTION 6. There is hereby appropriated to the State Board of
10 Education from any monies not otherwise appropriated from the
11 Mineral Leasing Fund of the State Treasury for the fiscal year
12 ending June 30, 2016, the sum of Two Million Six Hundred Twenty-four
13 Thousand Thirty-eight Dollars (\$2,624,038.00) or so much thereof as
14 may be necessary for the financial support of public schools.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2018, the sum of Twenty-five Million
19 Nine Hundred Thirty-nine Thousand Nine Hundred Ten Dollars
20 (\$25,939,910.00) or so much thereof as may be necessary for the
21 financial support of public schools.

22 SECTION 8. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2016, the sum of Five Million Four
2 Hundred Twenty-nine Thousand Eight Hundred Forty-four Dollars
3 (\$5,429,844.00) or so much thereof as may be necessary for the
4 financial support of public schools.

5 SECTION 9. Notwithstanding any other provision of law, the
6 State Board of Education is hereby authorized to expend during the
7 fiscal year ending June 30, 2018, from the School Consolidation
8 Assistance Fund (260 Fund), the sum of Two Million Five Hundred
9 Thousand Dollars (\$2,500,000.00) or so much thereof as may be
10 necessary for the financial support of public schools.

11 SECTION 10. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2018, the sum of Ninety-one Million Three Hundred
15 Nineteen Thousand Twenty-six Dollars (\$91,319,026.00) or so much
16 thereof as may be necessary for the support of public schools
17 activities.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 General Revenue Fund of the State Treasury for the fiscal year
21 ending June 30, 2018, the sum of Two Hundred Ninety-nine Million
22 Three Hundred Twenty Thousand Three Hundred Forty Dollars
23 (\$299,320,340.00) or so much thereof as may be necessary for the
24 Certified Employee Health Benefit Allowance.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2018, the sum of One Hundred Sixty-three Million
5 Three Hundred Seventy-five Thousand Six Hundred Twenty-seven Dollars
6 (\$163,375,627.00) so much thereof as may be necessary for the
7 Support Personnel Health Benefit Allowance.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2018, the sum of Fifteen Million Five Hundred Fifty-
12 two Thousand Five Hundred Twenty Dollars (\$15,552,520.00) or so much
13 thereof as may be necessary for administrative and support functions
14 of the State Department of Education.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2018, the sum of Two Million Eight
19 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
20 (\$2,882,213.00) or so much thereof as may be necessary for transfer
21 to the School Consolidation Assistance Fund.

22 SECTION 15. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2016, the sum of Six Hundred Three
2 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
3 thereof as may be necessary for transfer to the School Consolidation
4 Assistance Fund.

5 SECTION 16. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 Oklahoma Education Lottery Trust Fund of the State Treasury for the
8 fiscal year ending June 30, 2018, the sum of Two Million Eight
9 Hundred Eighty-two Thousand Two Hundred Thirteen Dollars
10 (\$2,882,213.00) or so much thereof as may be necessary for transfer
11 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

12 SECTION 17. There is hereby appropriated to the State Board of
13 Education from any monies not otherwise appropriated from the
14 Oklahoma Education Lottery Trust Fund of the State Treasury for the
15 fiscal year ending June 30, 2016, the sum of Six Hundred Three
16 Thousand Three Hundred Sixteen Dollars (\$603,316.00) or so much
17 thereof as may be necessary for transfer to the Teachers' Retirement
18 System Dedicated Revenue Revolving Fund.

19 SECTION 18. There is hereby appropriated to the Oklahoma Arts
20 Council from any monies not otherwise appropriated from the General
21 Revenue Fund of the State Treasury for the fiscal year ending June
22 30, 2018, the sum of Two Million Seven Hundred Seventy-six Thousand
23 Six Hundred Thirty-nine Dollars (\$2,776,639.00) or so much thereof

24

1 as may be necessary to perform the duties imposed upon the Oklahoma
2 Arts Council by law.

3 SECTION 19. There is hereby appropriated to the State Board of
4 Career and Technology Education from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2018, the sum of One Hundred Seven
7 Million Four Hundred Thirty-five Thousand One Hundred Thirty-seven
8 Dollars (\$107,435,137.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the State Board of Career and
10 Technology Education by law.

11 SECTION 20. There is hereby appropriated to the State Board of
12 Career and Technology Education from any monies not otherwise
13 appropriated from the Oklahoma Education Lottery Trust Fund of the
14 State Treasury for the fiscal year ending June 30, 2018, the sum of
15 Three Million One Hundred Seventy Thousand Four Hundred Thirty-three
16 Dollars (\$3,170,433.00) pursuant to paragraph 2 of subsection C of
17 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
18 the State Board of Career and Technology Education for the education
19 and general operating budgets of the institutions and for other
20 programs, construction, renovations or repairs administered by the
21 State Board of Career and Technology Education.

22 SECTION 21. There is hereby appropriated to the State Board of
23 Career and Technology Education from any monies not otherwise
24 appropriated from the Oklahoma Education Lottery Trust Fund of the

1 State Treasury for the fiscal year ending June 30, 2016, the sum of
2 Six Hundred Sixty-three Thousand Six Hundred Forty-eight Dollars
3 (\$663,648.00) pursuant to paragraph 2 of subsection C of Section 713
4 of Title 3A of the Oklahoma Statutes for allocation by the State
5 Board of Career and Technology Education for the education and
6 general operating budgets of the institutions and for other
7 programs, construction, renovations or repairs administered by the
8 State Board of Career and Technology Education.

9 SECTION 22. Notwithstanding any other provision of law, the
10 State Board of Career and Technology Education is hereby authorized
11 to expend during the fiscal year ending June 30, 2018, from the
12 State Board of Career and Technology Education Revolving Fund (200
13 Fund), the sum of Five Hundred Thousand Dollars (\$500,000.00) or so
14 much thereof as may be necessary to perform the duties imposed upon
15 the State Board of Career and Technology Education by law.

16 SECTION 23. There is hereby appropriated to the Office of
17 Educational Quality and Accountability from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2018, the sum of One Million One
20 Hundred Twelve Thousand Four Hundred Sixty-nine Dollars
21 (\$1,112,469.00) or so much thereof as may be necessary to perform
22 the duties imposed upon the Office of Educational Quality and
23 Accountability by law.

24

1 SECTION 24. There is hereby appropriated to the Office of
2 Educational Quality and Accountability from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury the
4 sum of Five Hundred Thousand Dollars (\$500,000.00) or so much
5 thereof as may be necessary to perform the duties imposed upon the
6 Office of Educational Quality and Accountability by law.

7 SECTION 25. There is hereby appropriated to the Oklahoma
8 Educational Television Authority from any monies not otherwise
9 appropriated from the General Revenue Fund of the State Treasury for
10 the fiscal year ending June 30, 2018, the sum of Two Million Six
11 Hundred Eighty-two Thousand Eighteen Dollars (\$2,682,018.00) or so
12 much thereof as may be necessary to perform the duties imposed upon
13 the Oklahoma Educational Television Authority by law.

14 SECTION 26. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2018, the sum of Six Hundred Forty-
18 one Million Nine Hundred Ninety-two Thousand Six Hundred Three
19 Dollars (\$641,992,603.00) or so much thereof as may be necessary for
20 allocation by the Oklahoma State Regents for Higher Education
21 pursuant to the provisions of Article XIII-A of the Oklahoma
22 Constitution for the education and general operating budgets of the
23 institutions and for other programs, construction, renovations or
24 repairs administered by the Oklahoma State Regents for Higher

1 Education. Of those funds appropriated, the sum of Two Million Nine
2 Hundred Ninety-four Thousand One Hundred Fifty-six Dollars
3 (\$2,994,156.00) shall be transferred to the Oklahoma Tuition
4 Equalization Grant Trust Fund to implement the provisions of the
5 Oklahoma Tuition Equalization Grant Act.

6 SECTION 27. The Oklahoma State Regents for Higher Education are
7 hereby authorized to expend during the fiscal year ending June 30,
8 2018, the sum of Forty-seven Million Three Hundred Seventy-two
9 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
10 Higher Education Capital Revolving Fund of the State Treasury for
11 allocation by the Oklahoma State Regents for Higher Education
12 pursuant to the provisions of Article XIII-A of the Oklahoma
13 Constitution for the education and general operating budgets of the
14 institutions and for other programs, construction, renovations or
15 repairs administered by the Oklahoma State Regents for Higher
16 Education.

17 SECTION 28. The Oklahoma State Regents for Higher Education are
18 hereby authorized to expend during the fiscal year ending June 30,
19 2018, the sum of Forty-seven Million Three Hundred Seventy-two
20 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
21 Oklahoma Student Aid Revolving Fund of the State Treasury for
22 allocation by the Oklahoma State Regents for Higher Education
23 pursuant to the provisions of Article XIII-A of the Oklahoma
24 Constitution for the education and general operating budgets of the

1 institutions and for other programs, construction, renovations or
2 repairs administered by the Oklahoma State Regents for Higher
3 Education.

4 SECTION 29. There is hereby appropriated to the Oklahoma State
5 Regents for Higher Education from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2018, the sum of Nine Hundred Sixty-
8 four Thousand Eight Hundred Twenty-three Dollars (\$964,823.00) or so
9 much thereof as may be necessary for expenditures for concurrent
10 enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma
11 Statutes.

12 SECTION 30. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the Oklahoma Education Lottery Trust Fund of the
15 State Treasury for the fiscal year ending June 30, 2018, the sum of
16 Twenty-two Million Seven Hundred Sixty-nine Thousand Four Hundred
17 Seventy-seven Dollars (\$22,769,477.00) pursuant to paragraph 2 of
18 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for
19 allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for construction, renovations or repairs administered
22 by the Oklahoma State Regents for Higher Education or for any other
23 purpose authorized by paragraph 2 of subsection C of Section 713 of
24 Title 3A of the Oklahoma Statutes.

1 SECTION 31. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Oklahoma Education Lottery Trust Fund of the
4 State Treasury for the fiscal year ending June 30, 2016, the sum of
5 Four Million Seven Hundred Sixty-six Thousand One Hundred Ninety-
6 seven Dollars (\$4,766,197.00) pursuant to paragraph 2 of subsection
7 C of Section 713 of Title 3A of the Oklahoma Statutes for allocation
8 by the Oklahoma State Regents for Higher Education pursuant to the
9 provisions of Article XIII-A of the Oklahoma Constitution for
10 construction, renovations or repairs administered by the Oklahoma
11 State Regents for Higher Education or for any other purpose
12 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
13 of the Oklahoma Statutes.

14 SECTION 32. There is hereby appropriated to the Oklahoma State
15 Regents for Higher Education from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2018, the sum of Three Million Six
18 Hundred Forty Thousand Nine Hundred Sixty-nine Dollars
19 (\$3,640,969.00) or so much thereof as may be necessary for the
20 general operating budget of the Administrative Offices of the
21 Oklahoma State Regents for Higher Education.

22 SECTION 33. There is hereby appropriated to the Commissioners
23 of the Land Office from any monies not otherwise appropriated from
24 the Commissioners of the Land Office Fund of the State Treasury for

1 the fiscal year ending June 30, 2018, the sum of Eight Million Five
2 Hundred Thirty-eight Thousand Six Hundred Dollars (\$8,538,600.00) or
3 so much thereof as may be necessary to perform the duties imposed
4 upon the Commissioners of the Land Office by law.

5 SECTION 34. There is hereby appropriated to the Oklahoma
6 Department of Libraries from any monies not otherwise appropriated
7 from the General Revenue Fund of the State Treasury for the fiscal
8 year ending June 30, 2018, the sum of Four Million Three Hundred
9 Fifty-seven Thousand Six Hundred Eighty-two Dollars (\$4,357,682.00)
10 or so much thereof as may be necessary to perform the duties imposed
11 upon the Oklahoma Department of Libraries by law.

12 SECTION 35. There is hereby appropriated to the Physician
13 Manpower Training Commission from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2018, the sum of Two Million Eight
16 Hundred Ninety-two Thousand Eight Hundred Fifty-two Dollars
17 (\$2,892,852.00) or so much thereof as may be necessary to perform
18 the duties imposed upon the Physician Manpower Training Commission
19 by law.

20 SECTION 36. There is hereby appropriated to the Physician
21 Manpower Training Commission from any monies not otherwise
22 appropriated from the Special Cash Fund of the State Treasury the
23 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
24

1 thereof as may be necessary to perform the duties imposed upon the
2 Physician Manpower Training Commission by law.

3 SECTION 37. There is hereby appropriated to the Board of
4 Trustees of the Oklahoma School of Science and Mathematics from any
5 monies not otherwise appropriated from the General Revenue Fund of
6 the State Treasury for the fiscal year ending June 30, 2018, the sum
7 of Six Million Eighty-two Thousand Three Hundred Ninety-seven
8 Dollars (\$6,082,397.00) or so much thereof as may be necessary to
9 perform the duties imposed upon the Board of Trustees of the
10 Oklahoma School of Science and Mathematics by law.

11 SECTION 38. There is hereby appropriated to the Oklahoma Center
12 for the Advancement of Science and Technology from any monies not
13 otherwise appropriated from the General Revenue Fund of the State
14 Treasury for the fiscal year ending June 30, 2018, the sum of
15 Thirteen Million Three Hundred Thirty-three Thousand Eight Hundred
16 Fifty-five Dollars (\$13,333,855.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Oklahoma Center for
18 the Advancement of Science and Technology by law. Of those funds
19 appropriated, the sum of Five Million Three Hundred Thirty-three
20 Thousand Five Hundred Forty-two Dollars (\$5,333,542.00) shall be
21 deposited in the Research Support Revolving Fund, created pursuant
22 to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
23 funds appropriated, the sum of Two Million Nine Hundred Thirty-three
24 Thousand Four Hundred Forty-eight Dollars (\$2,933,448.00) shall be

1 deposited in the Seed-Capital Revolving Fund, created pursuant to
2 Section 5060.21 of Title 74 of the Oklahoma Statutes.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 39. There is hereby appropriated to the Office of the
5 Attorney General from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2018, the sum of Nine Million One Hundred Ten
8 Thousand Twenty-one Dollars (\$9,110,021.00) or so much thereof as
9 may be necessary to perform the duties imposed upon the Office of
10 the Attorney General by law.

11 SECTION 40. There is hereby appropriated to the Office of the
12 Attorney General from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2018, the sum of Eight Hundred Ninety-nine Thousand
15 Three Hundred Fifty-two Dollars (\$899,352.00) to transfer to the
16 Legal Services Revolving Fund, created pursuant to subsection G of
17 Section 921.1 of Title 12 of the Oklahoma Statutes.

18 SECTION 41. REAPPROPRIATION AND REDESIGNATION The amount
19 of One Million Nine Hundred Thousand Dollars (\$1,900,000.00) of the
20 original appropriation of Five Million Dollars (\$5,000,000.00),
21 appropriated to the Office of the Attorney General by Section 154,
22 Chapter 311, O.S.L. 2012, from any monies not otherwise appropriated
23 from the Special Cash Fund of the State Treasury, for the
24 prosecution and defense of claims related to water and water rights

1 in Oklahoma, is hereby reappropriated and redesignated to perform
2 the duties imposed upon the Office of the Attorney General by law.
3 If, on the date this act is approved, any of the amount originally

5 transfers, results in an unencumbered balance less than the
6 reappropriated and redesignated amount, that reappropriated and
7 redesignated amount is reduced to the unencumbered amount.
