Supp. 2020, Section 1002), which relates to Commissioners of the Land Office 10 Modernization Act; modifying powers and duties of the Commissioners of the Land Office; requiring notice to 11 certain landowners when state school lands are recategorized; and providing an effective date. 12 1.3 14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA: 15 SECTION 1. AMENDATORY 64 O.S. 2011, Section 1002, as 16 amended by Section 1, Chapter 70, O.S.L. 2013 (64 O.S. Supp. 2020, 17 Section 1002), is amended to read as follows: 18 Section 1002. A. In order that the state school lands may be 19 administered in a manner to assure their preservation as well as the 20 appreciation of the trust estate and the maximum return from the use 21 of state school lands for the support and maintenance of the common 22 schools of the state, the Commissioners of the Land Office, as 23 trustees of the state school lands, are hereby authorized and 24 empowered to:

- 1. Categorize the state school lands as agricultural or commercial according to the use which the Commissioners of the Land Office determine from time to time to be most beneficial to the interest of the present and future beneficiaries of the state, subject to the provisions of subsection B of this section;
- 2. Sell, at public auction after appraisement, the surface interest in any state school land categorized by the Commissioners of the Land Office to be excess or when determined to be in the best interest of the trust;
- 3. Institute projects to develop and improve those state school lands which are categorized as commercial lands;
- 4. Acquire by exchange, purchase, gift or grant all real property and to acquire by exchange, purchase, gift or grant all personal property necessary for the purpose of utilizing trust lands for the development of commercial and agricultural leases to maximize trust income for present and future beneficiaries; and
- 5. Exchange any real property of the trust for other real property of equal or greater value to maximize income for present and future beneficiaries, in accordance with and under the safeguard of trust requirements.
- B. If the Commissioners of the Land Office determine it is beneficial to recategorize state school land in accordance with paragraph 1 of subsection A of this section, and the state school land is located outside of the corporate limits of a town or

1	municipality, the Commissioners of the Land Office shall send a
2	notice of the recategorization by certified mail to each person who
3	owns land within the same section as the state school land that is
4	being recategorized.
5	SECTION 2. This act shall become effective November 1, 2021.
